## CHAPTER 285.

[Published March 23, 1875.]

AN ACT relating to division fences, and amendatory of chapter 17, of the revised statutes, entitled, "Of fences and fence viewers; of pounds and impounding of cattle, and of the acts amendatory thereof."

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Chapter seventeen (17), of the Revised Statutes, entitled, "Of fences and fence-owners [viewers]; of pounds and the impounding of cattle, and the acts amendatory thereto," is hereby amended so as to read as follows: Section twenty-five (25). The provisions of this chapter and of the acts amendatory chapter extended to out-lots thereto, shall extend to and include all out-lots occupied and used for agricultural purposes, and embraced poses. in the plat of any incorporated city or village within this state, and the aldermen of the respective wards of such city, and the trustees of any such village, are hereby exportered, and it is hereby made their duty, Duties of trusto discharge the duties imposed upon fence-viewers tees of villages. of the several towns, as provided by this chapter, in their respective wards and villages.

Section 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 286.

## CHAPTER 287.

AN ACT to authorize county boards of supervisors to alter the boundary lines of villages heretofore incorporated by special acts.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:
