The board of regents may advertise for proposals to erect, repair or enlarge any May adver-normal school building, reserving the right to reject sals. any and all proposals made in the pursuance of such advertisements, and the expense of such advertising, and procuring plans and specifications for buildings, or for the repair, or alteration of or additions to any buildings to be used for normal schools, shall be paid in the same manner from the normal school income fund as hereinbefore provided for the expenses incurred in the erection of normal school buildings.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.
