## CHAPTER 354.

[Published March 23, 1876.]

AN ACT to appropriate to Taylor S. Hayhurst a sum of money.

*The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. There is hereby appropriated to Taylor S. Hayhurst from the general fund, out of any money not heretofore appropriated, the sum of two hundred and sixty dollars for his expenses and attorney fees in the contested election case of T. S. Hayhurst vs. P. Griffin, as follows: Appropriation.

Sheriff's, justice and witnesses . . . . .	\$85 00
Expenses . . . . .	25 00
Attorney fees . . . . .	150 00
	\$260 00

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 355.

[Published March 23, 1876.]

AN ACT to appropriate to Joseph Bennett a sum of money therein named.

*The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. There is hereby appropriated to Joseph Bennett the sum of four hundred dollars, out of any money not otherwise appropriated, to reimburse him for expenses and attorney fees in the contested election case of Bennett vs. Gray. Appropriation.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 356.

[Published May 5, 1876.]

AN ACT to repeal section 2, of chapter two hundred and sixty-one, of the general laws for the year 1875, entitled, "An act to provide for the depositing of funds of the counties, the taxable property of which shall exceed in valuation, as fixed by the state board of equalization, the amount of thirty million dollars (\$30,000,000)," approved March 4, 1875.

*The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:*

Repealed.

SECTION 1. Section two, of chapter two hundred and sixty-one, of the general laws of the year 1875, is hereby repealed.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 357.

[Published April 4, 1876.]

AN ACT to repeal part of section one (1), of chapter one hundred and seventy-seven (177), of the general laws for the year 1875, entitled "An act to authorize the county board of supervisors of the county of Milwaukee to appropriate a certain sum to the county treasurer of said county for the purposes of clerk-hire," approved March 4, 1875.

*The people of the State of Wisconsin, represented in senate and assembly, do enact as follows:*

Repealed.

SECTION 1. Section one, of chapter one hundred and seventy-seven, of the general laws for 1875, is hereby amended by striking out of said section the words, "and no treasurer of said county shall be elected to the said office the succeeding term," and the clause in said section one, above recited, is hereby repealed.
