CHAPTER 212.

AN ACT to amend chapter ninety-two of the general laws of 1871, entitled "An act to provide for the furnishing by hotel and inn keepers of a means of escaping in case of fire."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section one of chapter ninety-two of the general laws of 1871, entitled An act to provide for the furnishing by hotel and inn keepers of a means of escaping in case of fire, is hereby amended by adding at the end thereof the following: "It shall be and is hereby made the duty of all hotel or inn keepers, or owners of manufactories of three or more stories in height, to provide and furnish every such hotel, inn or manufactory, with one or more good and substantial

Fire escapes.
