CHAPTER 66.

AN ACT to appropriate to the Institution for the Education of the Blind a sum of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Appropriation.

SECTION 1. There is hereby appropriated to the institution for the education of the blind, out of any money in the general fund not otherwise appropriated, the sum of eighteen thousand five hundred dollars, for the following purposes, to wit: fifteen thousand seven hundred and seventy-five dollars for the payment of current expenses for the year ending March 1, 1879; two thousand two hundred and twenty-five dollars for house furnishing; five hundred dollars for improvement of grounds.

When to be drawn.

SECTION 2. All sums of money appropriated by this act for current expenses shall be drawn not oftener than quarterly in advance.

SECTION 3. This act shall take effect and be inforce from and after its passage and publication.

CHAPTER 67.

AN ACT for the preservation of fish in the waters of La Crosse county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Prohibition.

SECTION 1. No person or persons shall place, set, draw or use any seine-net, scoop-net, pound or gill-net,

wire-basket, grapple or trap, or any other contrivance or device other than hook and line or spear, in Black or La Crosse rivers, or any of their tributaries, or in any waters or lakes in the county of La Crosse, excepting the Mississippi river, for the purpose of taking or catching fish; and any person or persons who shall Penalty. violate any of the provisions of this section shall, on conviction thereof, be subject to a fine of not less than one dollar nor more than ten dollars for the first offense, and not less than five dollars nor more than twenty-five dollars for each and every subsequent conviction, pursuant to the provisions of this act.

SECTION 2. Justices of the peace shall have juris- Justices to have diction to hear, try, and determine all cases arising Jurisdiction. under this act: provided, that the defendant shall have the right of appeal and a trial by jury, as in other CAREA.

SECTION 3. This act shall take effect and be in force from and after its passage.

CHAPTER 68.

AN ACT relating to warehouse receipts, and amendatory of section one, chapter two hundred and twenty, of the laws of Wisconsin for 1877.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section one of chapter two hundred Amendment. and twenty of the laws of Wisconsin for 1877, entitled "An act to declare warehouse receipts negotiable," is hereby amended so as to read as follows: "Section 1. All warehouse receipts on which the words 'not negotiable are not written or stamped upon the face thereof shall be deemed negotiable, the same as bills of exchange and promissory notes.".

SECTION 2. This act shall take effect from and after its passage and publication.
