school district number two, in said town, and embracing within the limits of said district all of township number twenty, north of range two west, in said town, including sections numbered from one to twelve, inclusive, in said township, on the seventh day of August, 1874, together with the subsequent acts and proceedings of said town board, on the twenty-sixth day of June, 1876, and the seventh day of May, 1877, in changing the boundaries of said district, are hereby legalized and declared valid and binding upon all parties interested in said school district, and of full force and effect.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 73.

AN ACT to authorize certain exchanges between the State Historical Society and the University of Wisconsin.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Geological specimens and prehistoric relics may be exchanged.

SECTION 1. The State Historical Society is hereby authorized to transfer any or all geological specimens it now has or may hereafter receive, to the cabinet of natural history of the University of Wisconsin, and said university is also authorized to transfer any pre-historic relics it may have or receive, to said historical society.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 74.

AN ACT to authorize the town of Waupaca, in the county of Waupaca, to keep an office and hold elections within the limits of the city of Waupaca.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Powers of supervisors. SECTION 1. The board of supervisors of the town of Waupaca, in the county of Waupaca, are hereby auth-

orized and empowered to keep an office and transact any and all business of said town, at such place or places within the limits of the city of Waupaca, in said county, as said board of supervisors, by an order entered in their minutes, determine.

SECTION 2. Any general or special election, and any Elections may annual or special town meeting of said town of Wau- of Waupson. paca, hereafter ordered or held, may be held at such places within the limits of the city of Waupaca as the board of supervisors of said town may determine: provided, the notice of said election or town meeting shall specify the place where the same will be held; and any such election or town meeting of the said town of Waupaca, so held within the limits of the said city of Waupaca, shall be as legal and binding in all respects as the same would be if held within the limits of the said town, anything in the laws of this state to the contrary notwithstanding.

SECTION 3. This act shall take effect and be in force

from and after its passage.

CHAPTER 75.

AN ACT to repeal chapter three hundred and thirty-eight of the private and local laws of one thousand eight hundred and sixty-nine, relating to the town of La Prairie, in the county of Rock, doing work in the town of Harmony, in said county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Chapter three hundred and thirty-eight Repealed. of the private and local laws of one thousand eight hundred and sixty-nine, entitled "An act to authorize the town of La Prairie, in the county of Rock, to do work upon a certain highway, located in the town of Harmony in said county," is hereby repealed.
