across Wolf river, in Shawano county, at a point on the northeast quarter of section twenty-five, in township twenty-seven north, of range fitteen east; and to erect and maintain mills, machinery and necessary appendages to enable them to use the water of said river for hydraulic and boomage purposes.

Slides and sluiceways. Section 2. The aforesaid persons, their associates and assigns, shall build suitable slides or sluiceways in said dam for running logs and timber over the same, and shall keep the same in repair. The same shall be kept open at all times when said river is at a driving stage and there are logs and timber to run over said dam. The said Charles D. Wescott, Mathias Miller and H. M. Loomer, and their associates and assigns, may erect and maintain booms for the sorting of logs passing into the mill-pond hereby authorized to be created: provided, that said booms shall be constructed so as to allow free passage of logs or lumber.

Authority of owners.

SECTION 8. The control of said dam, slides or sluiceways shall belong to the said Charles H. Wescott, Mathias Miller and H. M. Loomer, their associates and assigns, but subject always to the provisions of this act.

Subject to provision of revised statutes.

SECTION 4. The dam so erected shall be subject to all the provisions of the revised statutes of 1878, so far as the said revised statutes may apply to dams, in like manner as if such provisions were incorporated in this act.

Repealed.

SECTION 5. Any and all charters granted by the legislature heretofore, to build and maintain a dam across Wolf river at the same place as heretofore mentioned, are hereby repealed.

SECTION 6. This act shall take effect and be in force

from and after its passage and publication.

CHAPTER 214.

AN ACT authorizing justices of the peace, elected in the several wards of the city of Madison to keep an office and to perform their duties in any part of said city.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Office in any part of city.

SECTION 1. The justices of the peace elected in the several wards of the city of Madison, may keep

an office and perform all the duties pertaining to their said office of the justice of the peace in any part of said city, as fully as they may now do in the wards in which they were respectively elected to such office.

SECTION 2. This act shall be in force from and after its passage and publication.

AN ACT to appropriate to the county of Green Lake a certain sum of money therein named.

There is hereby appropriated to the Appropriation, county of Green Lake, out of any money in the general fund not otherwise appropriated, the sum of two hundred and three and ten one hundredths dollars, to reimburse the said county for moneys paid for the support and funeral expenses of John Switzer, an insane pauper, now deceased.

CHAPTER 216.

AN ACT to remedy the evils consequent upon the destruction of public records of Dodge county by fire.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

It shall be lawful for any person or Re-recording of Section 1. persons claiming title to any lands in the county of Dodge, by virtue of any original deed, conveyance, contract, mortgage, deed of trust or other instrument in writing, affecting real estate, which has heretofore been recorded, or certified copies of the same, to have the said deeds, conveyance, contract, mortgage, deeds of trust or other instrument in writing, or certified copies thereof, recorded again within two years' time from
