

neglect or refuse, he or they shall be punished by a fine not exceeding one hundred dollars, with costs, or by imprisonment in the county jail not exceeding ninety days, or by both such fine and imprisonment, in the discretion of the court.

SECTION 2. It shall not be lawful for any person or persons to place a weir dam, fish weir or weir net across any race, drain, or stream or river in the counties of Iowa and La Fayette, in this state, in such manner as to obstruct the free passage of fish up and down the same; and any persons violating the provisions of this act shall be liable to a penalty of not less than five nor more than fifty dollars for each such violation, and also for the payment of two dollars additional penalty for every day he shall continue to keep up such fish weir or weir net, in violation of this act, after having been duly notified by any elector of the township wherein such fish weir or weir net may be, feeling himself aggrieved thereby, to remove the same; said penalty or penalties to be recovered before any court of competent jurisdiction in the township or county where such offense shall have been committed, with costs. Municipal courts, police justices, and justices of the peace, shall have power to hear, try and determine all offenses under this act.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 249.

AN ACT to amend chapter three hundred and eighteen of the private and local laws of 1855, as amended by chapter one hundred and eighty-nine of the general laws of 1865, relating to the house of correction, Milwaukee county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section six of said chapter three hundred and eighteen of the private and local laws of 1855, as amended by section one of said chapter one hundred and eighty-nine of the general laws of 1865, is hereby amended so as to read as follows: Section 6. The expenses of maintaining said house of correction over and above all receipts for the labor of persons confined therein, and for the support of prisoners therein, whose support is not chargeable to said county of Milwaukee, shall be audited and paid by the said

board of supervisors yearly, at its annual meeting, and shall be raised, levied and collected as part of the ordinary expenses of said county of Milwaukee; and the city of Milwaukee shall, on the first Monday of January in each and every year, pay to the county of Milwaukee the sum of one dollar and fifty cents per week per capita, for each and every person confined in the house of correction for the violation of any of the ordinances of the said city of Milwaukee during the preceding year.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 250.

AN ACT to legalize the action therein set forth of the village board of the village of Wonewoc, in the county of Juneau.
