AN ACT to legalize the acts of C. W. Haskins, as a notary public, within and for the county of Polk.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Legalized.

SECTION 1. The official acts of C. W. Haskins, notary public, in Polk county, are hereby legalized and declared to be lawful.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 107.

AN ACT to amend section 2433, chapter 113, of the revised statutes, entitled "of court commissioners," as amended by chapter 151 of the laws of 1881.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Amended.

SECTION 1. Section 2433 of the revised statutes, as amended by chapter 151 of the laws of 1881, is hereby amended by adding to said section the words, "five such court commissioners may be appointed in the county of Winnebago."

SECTION 2. All acts and parts of acts contravening this act are hereby repealed.

SECTION 3. This act shall be in force and effect from and after its passage and publication.

## CHAPTER 108.

An act relating to the payment of clerk's fees upon appeal from courts of justices of the peace in Milwaukee county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Payment of fees.

SECTION 1. Upon appeal from courts of justices of the peace in the county of Milwaukee,

the appellant shall, at the time of perfecting such appeal, pay to the justice of the peace, the clerk's fees required to be paid by chapter 451, of the private and local laws of 1871. Such justice of the peace, shall, at the time of making a return to the appellate court of the testimony, proceedings and judgment, and filling the same therein, pay to said clerk, such clerk's fees in addition to the state tax.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 109.

AN ACT to appropriate to the Wisconsin State Agricultural Society certain sums of money therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. There is hereby appropriated to the Wisconsin State Agricultural Society, out of any money in the general fund not otherwise appropriated, the sum of two thousand dollars (\$2,000), for the year 1883, and the further sum of two thousand dollars (\$2,000) for the year 1884. Appropriation.

SECTION 2. This act shall take effect and be in force from and after the passage and publication thereof.

CHAPTER 110.

AN ACT to appropriate to the Northern Wisconsin Agricultural and Mechanical Association a sum of money therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. There is hereby appropriated out of the general fund to the Northern Wisconsin Agricultural and Mechanical Association, the sum of two thousand dollars (\$2,000) for the year 1883 and the sum of one thousand dollars (\$1,000) for the year 1884. Appropriation.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
