## CHAPTER 10.

AN ACT granting to Walter L. Peck, his heirs and assigns, the right to maintain a bridge across Lake La Belle, in the town of Oconomowoc, Waukesha county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Walter L. Peck, his heirs and assigns, shall have the right to maintain a bridge across the waters of Lake La Belle, in the town of Oconomowoc, Waukesha county, Wisconsin, from the south shore of Long Island, in said lake, to the lands now held and owned by him on the south shore of said lake, in the same manner as now maintained by him; provided, always, that said bridge shall not affect the height of the waters in said lake, and shall not encroach on the riparian rights of any adjacent proprietor. May maintain a bridge.

SECTION 2. The right is hereby reserved to the state to alter, amend or repeal any or all provisions of this act.

SECTION 3. This act shall take effect and be in force from and after its passage and publication. Approved February 27, 1883.

## CHAPTER 11.

AN ACT to authorize Anthony J. Hayward, his heirs or assigns, to construct and maintain a dam across the Nama Kogan river, in Ashland county, Wisconsin, and to construct and maintain booms and piers in connection therewith.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Anthony J. Hayward, his heirs or assigns, are hereby authorized to construct and maintain a dam across the Nama Kogan river in Ashland county, Wisconsin, for manufacturing and other purposes, and to erect and maintain such piers and booms in connection therewith, as may be necessary or convenient for holding and handling logs to be manufactured at the village of Hayward, in said county. Said dam shall be maintained on section twenty-seven (27) town May construct and maintain a dam.

forty-one (41), range nine (9) west, in said county. Logs destined for points below on said river, shall not be detained longer than may be necessary to separate from the general drives of logs such as may be intended for manufacture at said village of Hayward.

SECTION 2. Said dam and works shall be so maintained that logs destined for points below, can be passed over said dam without unreasonable delay, and no charges shall be made for benefits that may accrue to the owners of said logs, and no toll charges shall be made on any logs put into said river above said dam intended for manufacture at said village of Hayward. The right to appeal or amend this act is hereby reserved. All acts as far as they conflict with this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication. Approved February 27, 1883.

## CHAPTER 12.

AN ACT relative to the taking inquests of the dead.

*The people of the state of Wisconsin, represented in senate and asssembly, do enact as follows:*

SECTION 1. In all cases where an inquest of the dead is or ought to be taken, the same may be taken by the coroner of the county, who, for the purpose, may perform all the duties, has all the jurisdiction and powers and is entitled to the same fees as a justice of the peace of said county.
