SECTION 2. The said Eliza Conan and the said Mary Safford, their heirs and assigns, are hereby authorized and empowered to build and maintain, at any place or places on or along the said piers, docks or wharves, such sheds, warehouses, stores, elevators or mills as to the said Eliza Conan and the said Mary Safford, their heirs and assigns may seem requisite or necessary, and may charge, receive and collect rents and tolls for the use of the said piers, docks and wharves and other structures, hereinbefore authorized. The legislature reserves the right to alter, amend or repeal this act at any future session.

SECTION 3. This act shall take effect and be in force from and after its passage.

#### CHAPTER 207.

AN ACT to repeal chapter 170 of the laws of 1880, and to re-enact section 4565 of the revised statutes relating to exportation of game.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Chapter 170 of the general laws of 1880 is hereby repealed.

SECTION 2. Section 4565 of the revised statutes is hereby re-enacted.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

#### CHAPTER 208.

AN ACT for the preservation of fish in the waters of Dell creek, Sauk county, Wisconsin.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

How to catch  
fish.

SECTION 1. It shall hereafter be unlawful for any person to take or kill any fish in the waters of Dell creek, in the county of Sauk, above the

lower dam thereon, in any manner except by hook and line, in the usual manner of fishing. The use of grapple hook or hooks, or other device for hooking up fish, is prohibited.

SECTION 2. Any person violating the provisions of section 1, shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine of not less than twenty dollars (\$20) nor more than one hundred dollars (\$100) and costs of prosecution, and upon failure to pay such fine and costs, shall be committed to the county jail not less than ten days nor more than six months, unless said fine and costs are sooner paid. Penalty.

SECTION 3. Any person giving information which shall cause the conviction of any one violating the provisions of section 1, shall be entitled to receive one-half of any fine collected in such case, and it shall be the duty of any public officer in the towns of Delton, Dellona and Excelsior, in the county of Sauk, who may know or have information of the violation of the provisions of section 1, to prosecute, and any such officer who shall refuse or neglect to so prosecute, shall be liable to a fine of not less than ten dollars (\$10) nor more than fifty dollars (\$50) and costs, to be sued for in the name of the state of Wisconsin by the town treasurer of the town in which such officer holds office, or any other person may sue. All officers of a town elected or appointed, shall be deemed public officers under the provisions of this act. Nothing herein contained shall be construed to prevent any person from prosecuting violaters of the provisions of section 1. Reward to informant.

SECTION 4. The presence of any person or persons on the waters herein mentioned with boat, spear and torchlight in the night, or boat and spear in daytime, shall be evidence of an intention to violate the provisions of section 1, and said boat, spear and torch may be seized and forfeited to the state. Presence of persons to be evidence.

SECTION 5. No black bass shall be taken or killed in any manner in the waters herein described, between the first day of November and the succeeding first day of May in each year, under the same penalty as prescribed in this act for the violation of section 1. Close time for black bass.

SECTION 6. Fish may be taken in any manner

and at any time in the waters of Dell creek below the lower dam.

SECTION 7. All previous laws for the protection of fish in Dell Creek, Sauk county, are hereby repealed.

SECTION 8. This act shall take effect and be in force from and after the date of its passage and publication.

CHAPTER 209.

AN ACT to authorize the erection of a dam across Black river, in the county of Clark, Wisconsin, and to grant certain powers and privileges to certain persons therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

May maintain  
a dam.

SECTION 1. James Hewett, his heirs and assigns, are hereby authorized and empowered to erect, keep up and maintain a dam, not exceeding ten feet in height, across the Black river, in Clark county, Wisconsin, at a point on said river not more than six hundred feet distant from where O'Neill's creek empties into the said Black river. Said dam to be erected and constructed for manufacturing and boomage purposes; provided, that said dam shall be provided and furnished with a suitable slide or chute, so as to allow the free and unobstructed passage of saw logs.

SECTION 2. In connection with said dam, the said James Hewett, his heirs and assigns, are further authorized and empowered to erect, build, keep up and maintain a system of piers and booms in and along and across said river, not distant from said dam, however, more than two thousand feet; and provided, further, that no charge for tolls upon logs passing through said dam, or said booms, shall ever be collected or received by said James Hewett, or his heirs or assigns.

SECTION 3. The said James Hewett, his heirs or assigns, shall conform to the conditions and provisions of chapters 70 and 146 of the revised statutes, and the legislature may at any time alter, modify, amend or repeal this act.

SECTION 4. This act shall take effect and be in force from and after its passage and publication
