# JOINT RESOLUTIONS.

#### [No. 5, S.]

#### JOINT RESOLUTION No. 1.

To provide for printing report of state librarian.

Resolved by the senate, the assembly concurring, That one thousand (1,000) copies of the report of the state librarian for 1882 be printed; that eight hundred (800) copies be bound in paper and two hundred (200) in cloth; said report to be distributed as follows: six hundred (600) copies to the legislature and four hundred (400) copies to the state library.

#### [No. 4, A.]

#### JOINT RESOLUTION NO. 2.

In relation to increase of pensions to one-armed and one-legged soldiers.

Whereas, The house of representatives at its last session, passed house bill No. 1410, increasing the pension to one-armed and one-legged soldiers to forty dollars (\$40) per month; and,

WHEREAS, Said bill is now pending in the senate of the

United States; therefore,

Resolved, by the assembly the senate concurring, That our senators are hereby requested to use their utmost influence in aiding the passage of said bill. Further, Resolved, That his excellency, the governor, be and is

each of our senators in congress.

#### [No. 8, S.]

#### JOINT RESOLUTION NO. 3.

Whereas, Contagious pleuro-pneumonia in cattle is prevalent in the states of New York, New Jersey, Pennsylvania, Virginia, Delaware, Maryland and the District of Columbia; and,

WHEREAS, All efforts for its suppression by the states where it exists, have been unsuccessful in arresting the spread and progress of said disease, and which has become

so prevalent as to threaten and endanger the entire cattle

interests of the country; and,

Whereas, Our export trade in live cattle has been damaged to the extent of many millions annually, by the embargo laid by European governments on account of said disease.

Therefore, be it resolved by the senate, the assembly concurring, That the question has assumed national importance,

demanding the immediate attention of congress.

We would therefore respectfully call the earnest attention of our senators and representatives to the fact, and ask them to take such measures as will bring the subject up for action before the close of the present session.

## [No. 11, A.] JOINT RESOLUTION NO. 4.

Resolved. To suspend sales of all public lands until the present legislature shall have affixed anew the price thereof. Resolved, the senate concurring. That all sales of the state public lands shall be, and are hereby suspended, until all bills now before the legislature, and all bills that may yet come up shall have been disposed of.

## [No. 14, A.] JOINT RESOLUTION NO. 5.

Requesting our senators and representatives in congress to use their influence to have the tax on matches abolished.

Resolved by the assembly, the senate concurring, That our senators and representatives in congress are hereby requested to use their utmost influence to repeal that part of the internal revenue law requiring stamps on matches.
