trial shall proceed in the same manner and be governed by the same rules as in the trial of cases in justice's court under the general laws of this state.

SECTION 97. This act is hereby declared to be a General law. general law, and shall be favorably construed in

all courts and places.

SECTION 98. This act shall take effect and be in force from and after the date of its passage and publication.

CHAPTER 163.

AN ACT to amend chapter 4, of the laws of Wisconsin for the year 1883, entitled, "An act to incorporate the city of Black River Falls."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Act amended.

SECTION 1. That the act entitled, "An act to incorporate the city of Black River Falls, approved February 20, 1883, is hereby amended so as to read as follows: Section 1. That all that district of coun- Corporate try in the county of Jackson, and state of Wiscon-name. sin, hereinafter described, shall be and remain a city by the name of Black River Falls, and they who now or may hereafter inhabit said district, shall be a municipal corporation by the name of the city of Black River Falls, and shall have the general powers possessed by municipal corporations at common law, and under the revised statutes of this state, and the laws amendatory thereof, and in addition thereto, shall have and possess the powers hereinafter granted, and the authorities thereof shall be capable of contracting and being contracted with; suing or being sued; pleading or being impleaded in all courts of law and equity; and shall have a common seal, and may change and alter the same at pleasure.

CHAPTER II.

BOUNDARIES AND WARDS.

City boundaries. SECTION 1. All of section fifteen, the east half of the east half of section sixteen, the east half of the northeast quarter of section twenty-one, all that part of section twenty-two lying and being north and west of the east and south bank of Black river; the west half of section fourteen (14). and all of section eleven (11) except the east half of the east half thereof, and all in township number twenty-one north, of range number four west, in Jackson county, Wisconsin, shall be included within and constitute the territory comprising the city of Black River Falls.

Ward bound-

SECTION 2. The said city shall be divided into four wards, viz.: The east half of the northeast quarter, and the northeast quarter of southeast quarter of section sixteen, and all that portion of section fifteen lying north of what is now known as Jefferson and Main streets in Black River Falls and west of a straight line passing through the centre of what is now known as Bluff street in Black River Falls, north and south, and from thence to the north line of section fifteen shall constitute and be the first ward. The southeast quarter of the southeast quarter of section sixteen, the northeast quarter of the northeast quarter of section twenty-one, and all that portion of section fifteen south of Jefferson street aforesaid and west of the centre of what is known as J street. in Black River Falls, and continued south to the section line shall constitute the second ward. The southeast quarter of the northeast quarter of section twenty-one, and all that portion of section twenty-two lying north and west of the south and east banks of Black River, and all that portion of section fifteen lying west of Black River and south of Main street aforesaid, and the east of the centre of J street continued south to the section line shall constitute the third ward. All the rest of the territory in said city of Black River Falls shall constitute the fourth ward.

Corporate authority in whom vested. SECTION 3. The corporate authority of said city shall be vested in one municipal officer, styled the mayor, and in one board of aldermen, consisting

of one alderman from each ward, who with the mayor, shall be denominated the common council. together with such other officers as are hereaf-ter mentioned or may be created under this act.

CHAPTER III.

ELECTIONS.

SECTION 1. The annual election for city and Annual election ward officers shall be held on the first Tuesday when held. after the first Monday of March in each year, at such place as the common council shall designate and provide, and the poll shall be kept open from nine o'clock A. M., until twelve o'clock noon, and from one o'clock P. M. until five o'clock P. M. The city clerk shall give at least ten days' notice of such election, stating time and place of holding the same, the officers elected thereat, and also of any special action to be taken or asked at such meeting, by causing the same to be printed in one or more newspapers published in said city of Black River Falls, and by posting the same in one or more public places in each ward of said city, and the city clerk shall file copies of the newspapers containing such notice, together with his affidavit of the publishing and posting of the same, but a failure to give the notice as above specified shall not invalidate the election.

SECTION 2. The elective officers of said city Elective shall be a mayor, clerk, treasurer, an assessor, two omcers. justices of the peace and two constables, elected by and for the city at large, and an alderman from each ward; three supervisors at large, to be elected in the year 1885, at the April judicial election without further notice and to enter upon their duties immediately after their election and qualification, and hold their offices until their successors are elected and qualified; said supervisors shall thereafter be elected annually at the regular charter election and who shall represent the city on the county board of Jackson county. All other officers of said city shall be elected or appointed

SECTION 3. The mayor, treasurer, assessor, clerk Elective offiand aldermen shall be freeholders in said city, and freeholders. all city and ward officers shall be qualified voters

by the common council.

and residents of the city, and in the ward for which they were elected or appointed. All elective officers shall, unless otherwise provided, hold their respective offices for one year, and until their successors are elected and qualified, except justices of the peace, who shall hold their respective offices for two years, and until their successors are elected and qualified; provided, however, the common council shall have the power, for cause, to expel any of their own number, and to remove from office any officer or agent under the city government, notice being first given to the officer complained of. The mayor shall have power to suspend any officer of said city who has been appointed or elected by the council when complained of, until the council shall take up his case and dispose of it. He shall also have power to fill any vacancy thus created for the time being.

In case of a vacancy.

SECTION 4. Whenever a vacancy shall occur in the office of mayor, such vacancy shall be filled by a new election, which shall be ordered by the common council, within twenty days after such vacancy shall occur; any vacancy happening in any other office shall be filled by the common council; the person elected or appointed to fill any vacancy shall hold his office and discharge the duties thereof for the unexpired term except in case of justice of the peace, whose appointment shall continue only until the next charter election, when the vacancy shall be filled for the remainder of the term by an election.

Elections to be

SECTION 5. All elections by the people shall be by ballot, and a plurality of votes shall constitute an election. When two or more candidates for an elective office shall receive an equal number of votes for the same office, the election shall be determined by the casting of lots in presence of the common council, at such time and in such manner as they shall direct.

Qualified

SECTION 6. All persons entitled to vote for county and state officers, and who shall be actual residents and inhabitants of the city for thirty days next preceding the election, and actual residents and inhabitants for ten days in the ward for which he offers his vote, next preceding said election, shall be entitled to vote for any city officer to be

elected, or other question that may be submitted

to the people for their vote.

SECTION 7. The inspectors for city elections Inspectors of shall be as follows: The four aldermen and four clerks, one of which shall be the city clerk, and he shall be the clerk for the ward in which he lives: the other three clerks shall be one from each ward, to be appointed by the mayor at the first annual meeting or as soon thereafter as may be, and which shall be confirmed by the common council, each of said clerks so appointed and confirmed to be the clerk of city elections for the ward in which he resides, and each of said aldermen shall be the inspector of city elections for the ward in which he lives.

SECTION 8. All city elections for city officers City elections, shall be held at one p'ace as shall be designated where held. by the common council, and there shall be four ballot boxes, one for each ward, and on each box shall be printed in red the number of the ward for which said ballot box is to be used; each of said ballot boxes shall be divided into two separate divisions, in one of which divisions shall be deposited the votes for city officers for that ward and in the other division to be deposited the votes on the license question; each division shall be distinctly lettered.

SECTION 9. All general elections shall be held Place where at such place in said city as the common council general elections shall be may direct, and the city shall constitute but one held. election precinct, and the board of inspectors of all elections except city elections shall consist of three inspectors and two clerks, two of which shall be the mayor as one inspector, and the city clerk as one of the clerks, and the other two inspectors and one clerk shall be chosen by the common council from the electors of said city, at the annual meeting, one of which inspectors to be chosen shall not belong to the same political party as the mayor, and the clerk so chosen shall not belong to the same political party as the clerk of the city, and in case any inspector or clerk shall for any cause, fail to appear at the time for opening the polls, such vacancy shall be filled by the remaining board of inspectors so present.

SECTION 10. If any vote be challenged, or if Fraudulen the inspectors or any of them, of any election, shall have reason to believe when any person

presents himself to give his vote, that he does not possess the qualifications of an elector, the same oath as it required by law at general elections shall be administered to the person offering to vote, with the further statement in city elections that the deponent has, for thirty days next preceding the election at which he offers his vote, resided in the city, and has for ten days next preceding said election resided in the ward for which he offers his vote. All persons illegally voting, and all fraud, deceit or corruption at any election held under this act, shall be punished according to the laws of this state, made and provided for the punishment of illegal voting, fraud, deceit or corruption of any election.

Resident elector.

SECTION 11. No person shall be eligible to any office under this act unless he is at the time a resident elector of the city.

Canvass of votes.

Section 12. When the election shall be closed the inspectors shall proceed to count the votes cast for each and every candidate voted for, and shall make a return of the votes cast in their election precinct for each and every officer, and the number of votes cast for each and every person. for each and every office, which shall be subscribed by the inspectors, and shall be forthwith delivered to the city clerk, and within one week after such election the council shall meet and canvass said returns and declare the result as it shall appear from the same. The clerk shall thereupon immediately give notice to the persons elected of their election; as soon as the votes are counted and canvassed by the inspectors they shall be destroyed, except as otherwise provided for in section 45, of the revised statutes.

Special elections.

SECTION 13. Special elections to fill vacancies shall be held and conducted in the same manner, and the same returns thereof shall be made in the same form and manner as general or annual elections, and within such times as shall be prescribed by the common council.

What is deemed a vacation in office. SECTION 14. Any officer removing from the city, or any alderman removing from the ward for which he was elected, or any officer who shall neglect or refuse one week after notice of his election or appointment to qualify, and shall neglect or refuse to enter upon the duties of his office at the commencement of his term of office, shall

be deemed to have vacated his office; and when any officer from sickness or any other cause shall be unable to attend to the duties of his office, except such as shall by the constitution be required to be elected, said office may be filled by appointment during the time of such disability, but no longer; and the common council shall proceed to fill any such vacancy as herein provided.

SECTION 15. The votes for mayor, and all elect-votes to be on one hallot and shall be one ballot. ive officers shall be on one ballot, and shall be deposited in one box, and all other questions submitted to the people at the city election shall be on separate ballots and deposited in sep-

arate ballot-boxes.

SECTION 16. The term of every officer elected when term of under this act, except to fill a vacancy, shall commence on the first Monday of April of the year for which and in which he was elected, and shall, except justices of the peace, continue for one vear and until his successor is elected or appointed and qualified; and justices of the peace shall hold their offices for two years and until their successers are elected and qualified.

CHAPTER IV.

DUTIES OF OFFICERS.

SECTION 1. Every person elected or appointed Qualification to any office under this act, except justices of the officers. peace, shall, before he enters upon the duties of his office, take and subscribe the constitutional oath of office, and file the same, duly certified by the officer taking the same, with the clerk of the city, and the clerk, marshal, constable and such other officers as the common council may direct, shall severally, before they enter upon the duties of their respective offices execute to the city of Black River Falls, a bond, with at least two sureties, who shall each justify in the amount mentioned in said bond, and the conditions of said bond shall be that the party who is elected or appointed to such office, will faithfully discharge his duties as such officer, and will obey all rules, regulations and ordinances of said city, and will pay over to the city all moneys that shall come to his hands by virtue of said office, belonging to said city, and that at the expiration of his office

he will turn over to the city all property in his hands belonging to said city. The treasurer shall. before entering on the duties of his office, execute to the city of Black River Falls a bond with at least two and not more than ten sureties, in the penal sum of not less than the amount of the last annual city and school tax, and each surety shall swear that he is worth a certain amount over and above his debts, liabilities and exemptions in property in this state and the aggregate of such amounts shall exceed the penal sum specified in the bond. The council may, from time to time. require new or additional bonds from the treasurer or other officers of the city, and the council may remove from office any officer refusing or neglecting to give the same. Justices of the peace shall qualify in the same manner as in towns, except their bonds shall be approved by the common council of the city. All other bonds shall be approved by the common council, and when approved, filed with the city clerk.

Duties of mayer.

SECTION 2. The mayor shall, when present. preside over the meetings of the common council. He shall take care that the laws of the state and the ordinances of the city are duly observed and enforced, and that all other executive officers of the city discharge their respective duties. shall from time to time, give the common council such information and recommend such measures as he may deem advantageous to the city, and in case of a riot or other disturbance, or whenever he may deem it expedient, he may appoint as many special or temporary police and constables as he may deem necessary. The mayor shall be the chief executive officer and head of the police of the city. The mayor shall have a vote only in case of a tie, or when the council shall be engaged in the election or removal of an officer, or the levying of taxes.

President of council.

SECTION 3. At the first meeting of the common council after their election in each year, they shall proceed to elect by ballot one of their number as president, and in the absence of the mayor the said president shall preside over the meetings of the common council, and during the absence or inability of the mayor, for any cause whatever, to discharge the duties of his office, the said president shall exercise all the powers and discharge

all the duties of his office as mayor, and in case both the mayor and president shall be absent from any meeting of the common council, they shall elect a temporary presiding officer, who, for the time being, shall discharge all the duties of mayor. and while acting he shall be styled acting mayor, and his acts while so acting shall have the same force as if performed by the mayor.

Scetion 4. The common council may, at their appointed officers. first annual meeting or as soon thereafter as may be, appoint the following officers: City marshal, city attorney, street commissioner and such other officers or agents of the city as they may deem for the best interests of the city, all of said officers to hold their offices for the term for which the council were elected unless they be sooner discharged for cause by the council. The said council shall, at the time of appointing any officer or agent of the city, fix the compensation or salary and may prescribe the duties of said office and which duties may be increased or modified from time to time by the council as they may deem expedient.

SECTION 5. The clerk shall keep the corporate Duties of seal and all the papers and records of the city, and keep a record of the proceedings of the common council, at whose meetings it shall be his duty to attend, and copies of all papers filed in his office, and transcripts from the records of the common council certified to have been compared by him by the original, and to be a correct transcript therefrom, under the corporate seal, shall be evidence in all courts in like manner as if the originals were produced. He shall draw and countersign all orders on the treasury in pursuance of any order or resolution of the common council, and keep full and accurate account thereof in books provided for that purpose; he shall file in his office all chattel mortgages presented to him for that purpose, and the renewals thereof, and safely keep the same, receiving therefor the same compensation as clerks of towns; and chattel mortgages so filed and the renewals thereof, shall be as valid and legal as if the same had been filed in the town clerk's office of any town. The clerk shall have power and authority to administer oaths or affirmations.

The justices of the peace elected un- justices. SECTION 6.

der this act shall have the same jurisdiction in civil and criminal cases, and perform all duties of justices of the peace as provided by the general laws of the state, and in addition thereto shall have exclusive jurisdiction of all cases arising under the ordinances heretofore or hereafter passed by said city, unless therein otherwise expressly provided, and said justices may hold their offices anywhere in said city not otherwise prohibited by the laws of this state; that changes of venue shall be granted in the same manner as provided by the general laws of the state, and either party shall have the right to appeal as hereinafter provided.

Jurisdiction of

SECTION 7. The constables elected under this act shall have the same jurisdiction as other constables, and shall qualify in the same manner as constables elected in organized towns, except the official bond of such constables shall be approved by the mayor and filed with his oath of office, in the office of the city clerk.

Duties of treasurer.

SECTION 8. The treasurer of said city shall receive all moneys which may or shall be collected for the use of the corporation, by virtue of this act, or by virtue of any by-law or ordinance of the corporation, and giving the person paying the same his receipt therefor. All moneys shall be drawn from the treasury by warrant, signed by the mayor, by order of the common council, and countersigned by the clerk, who shall keep a record thereof, and any such warrant shall set forth for what purpose the amount specified therein is to be paid; and the said treasurer shall pay out of the funds of the corporation in no other way whatever. He shall keep a just and accurate account of all moneys and other things coming into his hands as treasurer, in a book to be provided by the corporation for that purpose, which shall be and remain the property of the corporation, and in said book he shall note the time when the persons from whom the amount of the several sums was received, and the source whence the said sums arose respectively, and in the same book he shall duly enter an account of all sums paid out; and said book shall at all reasonable times be opened to the inspection of the voters of said city; and the said treasurer shall annually, and as often as they shall require, render to the

common council a minute account of all his receipts and disbursements; said annual report shall be made and filed with the city clerk at least ten days before his term expires. The said treasurer shall be collector of taxes within the corporation. and in addition to the powers and duties already specified, shall have the same powers and duties, and be subject to the same liabilities as treasurers in towns. He shall, in the same manner. before receiving the tax roll of the city, execute his bond to the treasurer of the county of Jackson, which bond shall be approved by the county treasurer, and upon filing the same the treasurer of said county shall give him a receipt therefor, and upon filing the receipt with the clerk of said city, the said clerk shall deliver the tax roll of the city to him; and he shall proceed to collect the taxes as hereinafter provided. No person having been city treasurer for two years in succession shall be eligible to a re-election until one year shall have elapsed, nor shall any person who has been city treasurer be appointed deputy treasurer for the term immediately succeeding his term of office. The salary of the treasurer shall not exceed four hundred dollars per annum, and shall be payable quarterly.

SECTION 9. The assessor shall assess all the tax- Duties of able property of the city of Black River Falls as assessor. required by law, and shall complete and return his assessment roll to the common council on the day fixed by the general laws of this state. assessor shall receive for his services such compensation as the common council shall determine, not exceeding two hundred dollars, for the term for which he was elected, and which shall be pay-

able when the assessment roll is completed.

SECTION 10. The marshal shall possess all the Duties of mar. powers of constables in towns, and be subject to the same liabilities. It shall be his duty to execute and return all writs and processes to him directed by the mayor, and when necessary, in criminal cases, or for the violation of any ordinance of said city, or laws of this state, may pursue and serve the same in any part of the state of Wisconsin. It shall be his duty to suppress all riots, disturbances and breaches of the peace, and with or without a warrant to apprehend any person in the act of committing any offense against

any ordinance of said city or laws of this state and forthwith bring such person before competent authority for examination; and for such service he shall receive such fees as are allowed to constables for like service. He shall do and perform all such duties as may lawfully be enjoined on him by the ordinances of said city. He shall have the power to appoint one or more deputies, to be approved by the council, but for whose official acts he shall be responsible, and of whom he may require a bond for the faithful discharge of their duties.

City attorney.

SECTION 11. The city attorney shall be a person duly admitted to practice in the courts of record, conformably to the laws of this state.

Duties of street commissioners.

SECTION 12. It shall be the duty of the street commissioner, within five days after his appointment and qualification, to inspect all the streets in the city, all sidewalks, cross walks, ditches, gutters, culverts, and all bridges and approaches thereto, and all matters and things appertaining to the streets, and report to the common council recommending what in his opinion, is necessary and ought to be done thereto. On the receipt thereof the common council shall consider the same and may adopt the whole or any part thereof, add to, strike out, amend or change any part thereof, and as soon as they have passed upon said report and recommendations, the street commissioner shall be informed of the action had thereon, whereupon said street commissioner shall cause such work to be done in accordance with the common council's amendments to his report and according to the orders and directions of said common council. Any party or parties may petition the common council for any work or improvement that they may particularly desire to be done, and said council may act thereupon as they may deem fitting and proper, and said street commissioner may, at other times, make such other reports as the necessities of the case may require.

Further duties.

SECTION 13. It shall be the further duty of the street commissioner to employ men and procure utensils, implements, teams, materials and whatever may be needful in performing such street and city work, and all this he shall do under the direction and advice of the common council; and

he shall superintend all such work when directed by the council so to do, and shall keep an accurate account of all materials procured, and of all teams and utensils, and men employed by him, and be able to certify to the account therefor, and shall do and perform, or cause to be done, any and all other duties pertaining to his office that may be prescribed from time to time by the common council.

SECTION 14. All accounts against the city for Accounts to be either work, hire or materials for street purposes, general fund. including street commissioner's services, shall be paid out of the general fund, by orders drawn and issued by the common council. All such accounts for street purposes, except for work and hire, shall be duly verified, and when they arose or were created under the direction of said street commissioner, shall be certified by him to be true and correct in all particulars. The common council may, at its option, let all or any of such street work, by contract, to the lowest bidder. street commissioner shall be paid for his services, and for every day's service actually rendered, shall receive such compensation as the common council and said commissioner shall agree upon, at the beginning of the official year, or he shall be paid such sum per annum, in lieu thereof, for the services required to be performed by him, as he and the common council can agree upon at the beginning of his official year.

SECTION 15. The common council shall have other duties power, from time to time, to require other and may be performed. further duties to be performed by any officer whose duties are herein prescribed, and to appoint such other officers as may be necessary to carry into effect the provisions of this act, and to prescribe their duties, and fix the compensation of all officers elected or appointed by them; such compensation shall be fixed by resolution at the time the office is created, or at the commencement of the year, and shall not be increased or dimininished during the term such officer shall remain

in office, or for which he is elected or appointed.

SECTION 16. The common council, at its first Printing to be meeting in each year, or as soon thereafter as bidder. may be, shall designate one or more newspapers printed in said city, in which shall be published all ordinances and other proceedings and matters

required by this act, or by the by-laws or ordinances of the common council, to be published in a public newspaper; which printing or publishing shall be let by contract to the lowest bidder or bidders.

City printer to

SECTION 17. The city printer or printers, immediately after the publication of any notice or ordinance, or resolution or by-law, which by this act is required to be published, shall file with the clerk of the city a copy of such publication, with his or their affidavit, or the affidavit of his or their foreman, of the length of time the same has been published, and such affidavit shall be prima facie evidence of the publication of such notice, ordinance, by-law or resolution, and the clerk shall file the same in his office.

Penalty for failure to deliver to successor. SECTION 18. If any person, having been an officer of said city, shall not, within ten days after notification and request by the city clerk or mayor, deliver to his successor in office, all property, books, papers and effects belonging to said city or pertaining to the office he may have held, he shall forfeit and pay to the use of said city, one hundred dollars, besides all damages caused by his neglect or refusal so to deliver; and such successor may recover possession of such books, papers and effects in the manner prescribed by the laws in this state.

Shall not be party to any job.

SECTION 19. No alderman shall be a party to, or interested in any job or contract with the city or any of the wards; and any contract in which any alderman may be so interested, shall be null and void; and in case any money shall have been paid on any such contract, the common council may sue for and recover back the amount so paid, from the parties to such contract, and alderman interested in the same.

Officers of the peace defined.

SECTION 20. The mayor or acting mayor, sheriff of Jackson county, and each and every alderman, justice of the peace, marshal, under sheriff and deputy sheriff of Jackson county, and policeman. watchman and constable of said city, shall be officers of the peace, and may command the peace and suppress, in a summary manner, all rioting and disorderly behavoir within the limits of the city, and for such purposes may command the assistance of all by-standers, and if need be, of all citizens; and if any person, by-stander, or citizen

shall refuse to aid in maintaining the peace when so required, every such person shall forfeit and pay a fine of not more than fifty dollars, and in case when the civil power may be required to suppress riots or disorderly behavior, the superior or senior officer present in the order mentioned in

this section shall direct the proceedings.

SECTION 21. There shall be elected by the com- city surveyor. mon council a city surveyor who shall be a practical surveyor and engineer. He shall keep his office at some convenient place within said city, and the common council shall prescribe his duties and fix the fees and compensation for any services performed by him. All surveys, profiles, plans or estimates made by him for the city or either of the wards shall be the property of said city, and shall be carefully preserved in the office of the surveyor, open to the inspection of parties interested; and the same, together with all books and papers appertaining to said office, shall be delivered over by the surveyor at the expiration of his term of office to his successor or the common council.

SECTION 22. The justices of the peace shall, as Report of jusoften as the common council may require, report peace, to the common council all the proceedings instituted before them in which the city is interested, and shall at the same time account for and pay over to the city treasurer all fines and penalties collected by them and belonging to said city; and said justices shall be entitled to receive from the county of Jackson such fees in similar cases as are allowed to other justices in the county for similar services.

CHAPTER V.

POWERS AND DUTIES OF COUNCIL.

SECTION 1. The mayor and aldermen shall con- No compense. stitute the common council, and shall receive no tion. compensation for their services, as such, except when acting as a board of equalization or as inspectors of election. The common council shall meet at such time and place as it by resolution shall direct. A majority of the council shall constitute a quorum. The style of all ordinances passed by the council shall be, "The mayor and

common council of the city of Black River Falls do ordain." etc.

First annual meeting when held.

SECTION 2. The common council shall hold its first annual meeting in each year on the first Monday in April, and thereafter stated meetings at such times as it shall appoint, and the mayor may call special meetings by notice to each of the members, to be served personally or left at their places of abode. The common council shall determine the rules of its own proceedings and be the judge of the election and qualifications of its own members, and have the power to compel the attendance of absent members.

Management and control of finances.

SECTION 3. The common council shall have the management and control of the finances, except school moneys, and of all the other public property in the city; and shall likewise, in addition to the power herein vested in it, have full power and authority to make, enact, ordain, establish, publish, enforce, alter, modify, amend and repeal all such ordinances, rules, resolutions and by-laws, for the government and good order of the city. for the suppression of vice, for the prevention of crime, and for the benefit of trade, commerce and health thereof; and so enforce as it shall deem expedient, declaring and imposing penalties, and so enforce the same against any person or persons who may violate any of the provisions of such ordinances, rules and by-laws, are hereby declared to be, and have the force of law: provided, that they be not repugnant to the constitution and laws of the United States or of this state. and for these purposes shall have authority by ordinance, resolution or by-laws.

Power to license. 1st. To license, regulate, suppress and prohibit the exhibition of common showmen, or shows of any kind, or the exhibition of caravans, circuses or theatrical performances, billiard tables, pool tables, bowling saloons, nine or ten pin alleys; to provide for the abatement and removal of all nuisances under the ordinances of said city, the laws of the state or at common law, and shall grant or refuse to grant, licenses to persons to sell, vend, deal or traffic in spirituous, vinous, malt or intoxicating liquors or drinks, within said city as shall be directed by the voters of said city at their annual election, and the question of granting or refusing to grant licenses in said city, to sell in-

toxicating liquors and drinks therein shall only be submitted to the voters of said city at its anual election, and at no other time, and in case the question is not submitted to the voters at the annual election, the common council shall have no power or authority to grant any license to sell intoxicating liquors and drinks in said city. The question when submitted to the voters shall be upon a separate ballot, and the ballots on the license question shall be in the following form: Those in favor, "For license;" those against, "No license," and they shall be deposited in a separate ballot box provided for that purpose, and whenever a majority of the voters shall declare by their votes as aforesaid in favor of license, then the common council shall grant licenses according to the provision of the laws of the state of Wisconsin on that subject; provided, they shall charge not less than three hundred dollars for retail license in said city; and in case the majority of the voters should declare for no license, or fail to submit the question as aforesaid, then, and every such case, the common council shall have no power or authority to grant licenses for the sale of intoxicating liquors and drinks in said city, except to druggists to sell for medicinal and mechanical purposes. and said council are hereby authorized in any case to grant licenses to druggists to sell intoxicating liquors and drinks for medicinal and mechanical purposes on such terms as the council may direct; and all such licenses granted shall run from the first Monday in April in each year to the first Monday in April following; provided, however, that when any such license shall be applied for after that date, the same may be granted to expire on the first Monday in April following, and provided further, that no license shall be granted to run or extend bevond the time for which the common council shall be elected.

2d. To restrain, prohibit and suppress all de-Gambling and graudulent de-graudulent de scriptions of gambling and fraudulent devices and vices. practices, and all playing of cards, dice or other games of chance, with or without betting, and to restrain, prohibit and suppress any person or persons from selling, vending or in any manner disposing for gain any spirituous, ardent, malt or intoxicating liquors or drinks, or from manufacturing or dealing in the same unless duly licensed

by the common council; and to license, regulate and suppress hawkers and peddlers; provided, that no greater or less rate of license or tax shall be charged to any such manufacturer than shall be charged to a retail dealer.

Riots and disturbances. 3d. To prevent any riots, noise, disturbances or disorderly assemblages, suppress and restrain disorderly houses or groceries and houses of ill-fame, and to authorize the destruction of all instruments used for the purpose of gaming.

Abatement of nuisances.

4th. To compel the owner or occupant of any grocery, cellar, tallow chandler's shop, soap factory, tannery, stable, barn, privy, sewer or other unwholesome or nauseous house or place, to clean, remove or abate the same from time to time, as often as it may be deemed necessary for the health, comfort and convenience of the inhabitants of said city.

Markets and gunpowder.

5th. To direct the location and management of slaughter-houses, and markets, and regulate the storage, keeping and conveying of gunpowder or other combustible materials.

Incumbering streets.

8th. To prevent the incumbering of the streets, sidewalks, lanes or alleys with railroad cars, locomotives, engines, carriages, carts, wagons, sleighs, boxes, lumber, pine, wood, or any other material or substances whatever.

Horse racing, bathing, etc. 7th. To prevent horse-racing, immoderate riding or driving in the streets, and to regulate the places of bathing and swimming in the waters within the limits of said city.

Restrain cattle.

8th. To restrain the running at large of cattle, mules, horses, swine, sheep, poultry and geese, and to authorize the distraining, impounding and sale of the same, for the penalty incurred and the cost of proceedings.

Dogs.

9th. To prevent the running at large of dogs in the said city, and to authorize the destruction of the same in a summary manner when at large contrary to the ordinances.

Muzzling dogs.

10th. To provide for the secure muzzling of dogs, and for the killing and destruction in a summary manner, all dogs not muzzled, found within the said city running at large.

Putrid carcasses.

11th. To prevent any person from bringing, depositing or having within said city any putrid carcasses or other unwholesome substances, and to require the removal of the same by any person

vho shall have upon his premises any such subtance, putrid or unsound beef, pork, fish, hides, kin. or substance of any kind, and in default, to in thorize the removal thereof by some competent officer, at the expense of such person or persons.

12th. To make and establish public pounds, Pounds. oumps, wells, cisterns and reservoirs, to erect amps and regulate and license omnibus drivers. nackmen, coachmen, cartmen, draymen, and the charges of hackmen, coachmen, omnibus drivers cabmen, cartmen, draymen and all others who may pursue like occupation in this city, and to provide for lighting the streets, public grounds and public buildings, with gas or otherwise.

13th. To establish and regulate boards of Boards of health, provide hospitals, pest-houses and the return of the bills of mortality, and to exempt burial grounds set apart for public use from taxation.

To regulate the size and weight of bread, Size and and to provide for the seizure and forfeiture of bread. bread baked contrary thereto.

15th. To prevent all persons riding or driving Riding and any ox, mule, cattle or other animal on the side-sidewalks. walks in said city, or in any way doing damage to said sidewalk.

16th. To prevent the shooting of fire-arms or Shooting firecrackers, and to prevent the exhibition of fireworks in any situation which may be considered by the council dangerous to the city or any property therein, or annoying to any citizen thereof.

To restrain drunkenness or obscenity in Drunkenness. the streets or public places and to provide for arresting, removing and punishing any person or persons who may be guilty of the same.

18th. To restrain and regulate runners and Rupners and solicitors for stages, public houses or other establishments, and to establish and regulate the police of the city.

19th. To compel the owners and occupants of Removal of buildings and grounds to remove snow, dirt or bish. rubbish from the sidewalks, streets or alleys opposite thereto, and to compel such owners or occupants to remove from the lot owned or occupied by him all such substances as the board of health shall direct; and in his default, to authorize the removal or destruction thereof by some

officers of the city, at the expense of such owners or occupant.

Weighing and selling hay.

20th. To regulate the place and manner of weighing and selling hay, and measuring and selling fuel and lime, and to appoint suitable persons to superintend and conduct the same.

Contagious dis**eases**.

To regulate, control and prevent the landing of persons from railroad cars or stages wherein are contagious or infectious diseases or disorders and to make such disposition of such persons as to preserve the health of said city.

Public actions.

22d. To regulate the time, place and manner of holding of public auctions or vendues.

Watchmen.

To appoint watchmen and prescribe their duties.

Weights and maasures.

24th. To provide by ordinance for a standard of weights and measures, and for the punishment of the use of false weights and measures.

Trees and monuments.

To protect trees and monuments in said

citv. Open and re-

To lay out, make, open, keep in repair. 26th. pair highways. alter or discontinue any highways, streets, lanes and alleys, and to keep them free from incumbrances, and to protect them from injury.

Alter name of city street.

To alter or change the name of any street 27th. in the city.

Ordain and repeat ordi-Dances.

To make, ordain, amend and repeal all such ordinances, by-laws and police regulations, not contrary to the constitution of this state. for the good order and government of the city, and which may be necessary or expedient to carry into effect the powers vested in the mayor and common council or any officer of said city by this act. or which may be vested in any officer of said city, by any ordinance thereof.

Regulate and license breweries. Jurisdiction

over stream 4.

To direct the location and regulate and license breweries, tanneries and packing-houses.

30th. The common council shall have jurisdiction over the streams within the limits of said city and may enact and enforce ordinances or by-laws for the preservation of fish in the waters thereof, so as to prohibit, regulate or license the taking or killing of fish in the waters thereof at any time; and may also by ordinance or resolution prevent any deterioration of said waters, or by nuisance being cast therein, by which the health of the inhabitants of the city or the purity of the water shall be impaired as it shall deem expedient.

SECTION 4. All laws, ordinances, regulations Regulation how and by-laws shall be passed by an affirmative vote passed. of a majority of the common council, and shall be signed by the mayor, and shall, within fifteen days after their passage, respectivley, be published in the official paper, or papers of said city once, before the same shall be in force, and within fifteen days thereafter they shall be recorded by the said clerk in books to be provided for that purpose; but before any of the said laws, ordinances. regulations or by-laws shall be recorded, the publication thereof, respectively, within the said time, shall be proved by the affidavit of the foreman or publisher of such newspaper, and said affidavit shall be recorded therewith, and at all times shall be deemed and taken as sufficient evidence of the time and manner of such publication; and such record of such law, ordinance, regulation or by-law and the proof of such record certified by the clerk under the seal of the city, or any printed book containing the same, purporting to have been published under the sanction of the mayor and council, shall be prima facie evidence of the due passage and publication of such law, ordinance, regulation or by-law. No appropriation shall be made without a vote of a majority of the members of the common council in its favor.

SECTION 5. The powers conferred upon the said Shall not bar or hinder suits. council, to provide for the abatement of nuisances shall not bar or hinder suits, prosecutions or proceedings in the courts according to law. Depots, houses or buildings of any kind wherein more than twenty-five pounds of gunpowder are deposited, stored or kept at any one time, gambling houses, houses of ill-fame, disorderly taverns and houses or places where spirituous, vinous or fermented liquors are sold without the license required therefor, within the limits of said city, are hereby declared and shall be deemed public or common nuisances.

SECTION 6. The common council shall examine, Examine, audit and adjust the accounts of the clerk, treas-just accounts urer, marshal and all other officers or agents of the city, at such time as they may deem proper, and also at the end of each year and before the time for which the officers of said city are elected or appointed, shall have expired. And the common council shall require each and every such

officer and agent to exhibit his books, funds and moneys, accounts and vouchers for such examination and settlement; and if any such officer or agent shall refuse to comply with the orders of said council in the discharge of his said duties, in pursuance of this section, or shall neglect or refuse to render his accounts or present his books funds, moneys and vouchers to said council, it shall be the duty of the common council to declare the office of such person vacant; and the common council shall order suits and proceedings at law against any officer or agent of said city, who may be found delinquent or defaulting in his accounts, or in the discharge of his official duties. and shall make a full record of all adjustments and settlements.

CHAPTER VI.

FINANCE AND TAXATION.

Funds under control of coun-

SECTION 1. All funds in the treasury, except school, state and county funds, shall be under the control of the common council, and shall be drawn out upon the order of the mayor and clerk, duly authorized by a vote of the common council; and all orders upon the treasury shall specify the purpose for which they were drawn, and shall be payable out of any funds in the treasury belonging to the city. City orders shall be receivable for all city taxes except school and special taxes for bridges and school purposes, and except taxes levied for the payment of the principal or interest of any outstanding indebtedness of said city, which shall be collected in money or in orders drawn upon such fund respectively, and all orders shall be payable to the persons or to the order of the person in whose favor they may be drawn.

Annual tax levy.

SECTION 2. The common council of said city shall annually levy upon the taxable property of said city, to defray the current expenses of said city, its schools, its streets and sidewalks, and for fair grounds within the city, a tax sufficient for said purposes.

Issue bonds.

SECTION 3. The common council of said city shall have power to issue bonds or other evidence of debt, payable at a day subsequent to the date of the issue thereof, for any purpose authorized by

law, in any case when the electors of said city shall, by a majority vote thereof, authorize the issuing of the same; provided, that said city shall not in any event, or for any purpose, ever be bonded to exceed five per cent, of the taxable property of said city, as equalized by the equaliz-

ing board of said city.

SECTION 4. The common council may, when Repair of ever it shall become necessary to build or repair any bridges. bridge in said city, or in case of floods or other causes, it shall become necessary to build or repair any public street or highway in said city, they may levy a tax for such purpose purposes, not exceeding two thousand dollars in any one year, and said taxes, when so levied, shall be collected at the same time as other city taxes are collected.

SECTION 5. Taxes may be levied by the common taxes for outcouncil at any regular meeting for the purpose of standing in debtedness. paying any outstanding indebtedness of the city of Black River Falls, and also for the payment of any bonds or any other evidence of debt hereafter issued or created in accordance with the provisions of this act, or by any authority of law. Said taxes when so levied shall be collected at the same time that other city taxes are collected.

SECTION 6. No account shall be allowed by the Verifying accommon council unless the same is verified by counts. the owner thereof or some person in his behalf.

SECTION 7. When the claim of any person Appeal how against the city shall be disallowed in whole or in taken. part by the common council, such person may appeal from the decision of such council to the circuit court for the county of Jackson by causing a written notice of such appeal to be served upon the clerk of said city within thirty days after the making of such decision.

SECTION 8. The city clerk, upon such appeal Duty of clerk being taken, shall immediately give notice thereof on appeal. to the mayor and common council or shall take such measures as by ordinance or resolution of said common council he may be required to do and shall make out a brief return of the proceedings in the case before said council with the decision thereon and file the same together with the bond and all papers in the case in his possession with the clerk of the circuit court for the county of Jackson and such appeal shall be en-

tered, tried and determined in the same manner as appeals from justices of the peace and costs shall thereupon be awarded in like manner; provided, however, that whenever an appeal is taken from the allowance made by the common council upon any claim and the recovery upon such appeal shall not exceed the amount allowed by said council exclusive of interest upon such allowance the appellant shall pay the cost of appeal which shall be deducted from the amount of the recovery, and when the amount of costs exceeds the sum recovered, judgment shall be rendered against the appellant for the amount of such excess.

Statement of claim to be

SECTION 9. No action upon any claim or cause of action for which a money judgment only is demandable, except upon city orders, bonds, coupons or written promises to pay any sum of money, shall be maintained against the city, unless a statement or bill of such claim shall have been filed with the city clerk, to be laid before the common council of said city, not until ten days after the next annual city election thereafter.

Determination of council to be final.

SECTION 10. The determination of the common council disallowing in whole or in part any claim of any person shall be final and conclusive and a perpetual bar to any action in any court, founded on such claim, unless an appeal shall be taken from the decision and determination of such common council, as hereinbefore provided; provided, however, that when the common council shall refuse or neglect to act upon any claim duly presented to them, this chapter shall not be construed as to prevent the institution and maintenance of any action by said claimant against said city.

CHAPTER VII.

OPENING OF STREETS, ALLEYS, ETC.

Opening streets. alleys, etc. SECTION 1. The common council shall have power to take, for the use of the city, in the manner hereinafter provided, any lots or any land for public squares, grounds, streets and alleys, and to widen or straighten the same, or for the purpose of erecting a public hall, market house, fire-engine house or any building in the construction of

water-works, or for flowing the same, for supplying the city with water, or any other lawful municipal purpose, or for erecting hospitals or pest-houses, for the prevention of contagious or infectious diseases within the city, for any needful or convenient purpose in connection with or to execute and accomplish any other power, right or privilege conferred on or granted to the city by its charter or any act amendatory thereof, or by any act of the legislature, and may take the same, and whether within or without the city, by conveyance from the owner upon a bargain or upon a donation thereof, or in manner as follows: Whenever it shall, in the option of the common council, be necessary, said council shall declare, by resolution, that it is necessary to take any such lots or lands for any of the purposes above set forth, giving description of the premises, defining separately each parcel thereof separately owned and the purposes for which they are to be The common council shall thereupon taken. cause a written notice, as prescribed in the next section, to be served upon the occupant or occupants of such lands, and the owners or owners of the same, if the place of residence of such owner or owners is known, or can be ascertained by reasonable diligence, when such residence is within the state, and in case such owner or owners are non-residents of the state, or their place of residence, after due diligence by the city attorney of said city, cannot be ascertained, which fact shall be made to appear by his affidavit, then the common council shall cause service of such notice to be made on such non-resident owner or owners, or the owner or owners, the residence of whom cannot be ascertained by causing the same to be published for six weeks in the official paper of the city, at least once each week, and by causing such notice to be mailed, postpaid, to the address of such owners, within five days from the time of the first publication of such notice, when the postoffice address of such owner is known.

SECTION 2. Such notice shall be signed by the what the nocity clerk or city attorney, and shall state the adoption of the resolution, and embrace a copy thereof, and further that at a time and place therein named, not less than ten days after the service of such notice, or the expiration of such

publication, as the case may be, application will be made to the county judge of the said county of Jackson, for a jury to inquire and determine whether it is necessary to take the land or any part thereof, described in such resolution, for the purposes therein specified. Such notice shall further state the time and place at which such jury will be applied for to meet to discharge such duty; and the judge aforesaid shall fix the time and place so named in the precept hereinafter mentioned, and no other notice thereof shall be necessary.

Six competent persons to be appointed as jurors.

SECTION 3. At the time fixed in said notice for the appointment of such jurors, the judge named in said notice, upon proof of the service of the same on the owner or owners of the premises described in such notice, which proof shall be in the same manner as is now required to make proof of the service of a summons in civil actions in courts of records in this state, shall appoint six competent persons, having the qualification of jurors in and for the county of Jackson and not residents of the ward in which such premises are situated, not interested in such application, but residents of the city shall not be disqualified. The same rights of challenge peremptorily, or for favor or cause, may be exercised by the city attorney and by such land owner whose land is sought to be taken, or by his agent or attorney, as a party to a civil action in the circuit court is entitled to have: and the judge shall decide the same in like manner, and replace the name of any juror successfully challenged, by the name of some other competent person, until a jury of six be chosen. The said judge shall thereupon issue his precept. directed to such jurors, requiring them and each of them to appear before him, on the day named in the notice for such jurors to meet for the discharge of their duties under such appointment. The precept so issued may be served by the sheriff of said county, or by any public officer of said city. The jurors so chosen shall, before entering upon the performance of their duty, take an oath before such judge, faithfully and impartially to discharge their duty as such jurors, and a true verdict give, whether it is necessary to take such land, or any part thereof, mentioned in such resolution for the purpose therein specified.

SECTION 4. If any of the jurors so appointed In case any of shall be disqualfied from acting, or shall refuse to disqualified. act, the judge shall appoint others in their places, and a memorandum of such substitution shall be endorsed on the precept.

SECTION 5. The said jurors shall forthwith un- Jurors shall der direction of said judge, proceed in a body to body to view view the premises in question, and shall hear premises. such testimony as may be offered by any party interested, whose testimony shall be reduced to writing by said judge; and either of the jurors shall be authorized to administer the necessary

oath to witnesses.

SECTION 6. After having made such view and How verdict shall be reheard such testimony as shall have been produced, turned. the said jury shall, under direction of said judge, deliberate apart and return their unanimous verdict in writing, signed by them, in which they shall find and state whether it is necessary to take the whole of the lands described in such resolution for the purpose therein specified, or any part thereof, describing particularly the part to be taken, if they find only a part thereof so neces-Such verdict, with all the papers, proceedings and testimony had before him and said jury, shall then be forthwith filed by said judge with the clerk of the circuit court for Jackson county. together with a certificate by said judge that the same are the originals and the whole thereof. The clerk shall on application furnish a certified copy of the same, or any part thereof, which shall have the same force and effect as the originals. In case any jury called under the provisions of this charter shall disagree, another jury shall be forthwith selected in like manner, and all the like proceedings thereafter had as herein provided for the first jury, except that the said judge shall fix a reasonable time for the assembling of such jury in the precept therefor, but no other notice thereof shall be necessary to any party; and the like steps shall be taken in the case of any further disagreement, until a verdict shall be found.

SECTION 7. Should the necessity for the taking In case it is of the premises, or any part thereof, mentioned necessary to take the premin the resolution of the council, be so established ises. by the verdict of the jury, then the common council may enter an order directing the city attorney to proceed to procure to be assessed and ap-

praised the damages to the owner or owners of the premises so found necessary to be taken by reason of the taking of the same for the purpose specified. The city attorney shall thereupon make application to the judge of the circuit court or judge of the county court for Jackson county. briefly setting forth the fact that the necessity for taking such premises has been so established by the verdict of a jury, and praying the appointment of three commissioners to appraise the damages of each and all of the several owners of such lands, and showing the amount of land. giving the metes and bounds thereof, the purpose for which the same is to be taken, and the names of the several owners so far as the same are known to the city attorney. Five days' notice of the time and place when such application will be presented to such judge, accompanied with copy of such application, shall then be served on each owner in the cases when required, and in the manner provided in section 1, of this chapter. At the time and place designated, such judge shall hear all parties interested who appear, and shall appoint three disinterested and reputable freeholders of said county as such commissioners, by his order in writing to ascertain and appraise the compensation to be made to the owners of or persons interested in the land so found necessary to be taken, and fix the time and place for the first meeting of said commissioners.

In case there is a building on premises.

SECTION 8. If there should be any building standing in whole or in part upon the lands to be taken, the commissioners, before proceeding to make their assessments, shall first estimate and determine the whole value of such building to the owner, aside from the value of the land, and the injury to him in having such building taken from him; and, secondly, the value of such building removed.

Ten days personal notice. SECTION 9. At least ten days' personal notice of such determination, shall be given to the owner or his agent, if known, and a resident of the city, or left at his usual place of abode. If not known, or a non-resident, notice to all parties interested shall be given, by publication in the official paper three successive weeks; such notice shall specify the building and the award of the commissioners. It shall also require the parties

interested to appear by a day therein named, or give notice of their election, to the common council, either to accept the award of the commissioners and allow such building to be taken, with the lands appropriated, or their intention to remove such building at the rate set thereon by the commissioners to remove. If the owner shall agree to remove such building he shall have such time for this purpose as the common council shall allow.

SECTION 10. If the owner refuse to take the In case owner building at the value to remove, or fail to give building. notice of his election as aforesaid within the time prescribed, the council shall have power to direct the sale of such building at public auction, for cash, giving ten days' notice of such sale. proceeds shall be paid to the owner, or deposited

for him in the city treasury.

SECTION 11. The commissioners shall take and commissioner subscribe the oath prescribed by the twenty-eighth oath presection of the fourth article of the constitution be- scribed. fore entering on the discharge of their duties. majority of them may adjourn the proceedings before them from time to time, in their discretion. They shall cause notice to be given to each party interested of the time when and the place where they will neet to consider the amount of compensation to which he is entitled, which notice shall be personally served on such party or his authorized agent or attorney, or by leaving the same at his residence or place or place of business, with a person of suitable age and discretion, at least six days before the time of such meeting. If such party is a non-resident of this state, or his residence is unknown, and he has no authorized agent or attorney in this state, such notice shall be published in a newspaper as aforesaid for such length of time as the court or judge appointing said commissioners shall direct. The commissioners shall file a proof of such notices, or of the appearance of such parties before them, either personally or by attorney, with their report. But it shall not be necessary to serve or publish notice of any subsequent meeting held pursuant to adiournment.

SECTION 12. The commissioner shall view the commissioner premises described in the petition, and hear the shall view the allegations of the parties, and shall appraise, as-

certain and determine the value of each tract or parcel of land proposed to be taken, with the improvements thereon, and of each separate estate therein, and the damages sustained by the owner by reason of the taking thereof, and fix the amount of compensation to be made to each of such owners therefor; and in fixing the amount of such compensation, said commissioners shall not make any allowance or deduction from the value of the real estate taken on account of any real or supposed benefits which the parties in interest may derive from the construction of the proposed improvement, for which such real estate may be taken; but special benefits to the real estate adjoining the lands so taken shall be allowed in deduction of any damages sustained by owner to such adjoining real estate. In case of any building on the land, proceedings shall have been taken, as provided in sections 8, 9 and 10, the said commissioners shall not include the value of such building, as estimated by them, less the proceeds of the sale thereof, or if taken by the owner at the value to remove, in such case they shall only include the difference between such value and the whole estimated value of such building. jority of the commissioners, all being present, shall be competent to determine all matters before them. The commissioners shall, within twenty days after viewing any of the lands so taken, make and file in the office of the clerk of the circuit court of such county, a report of their proceedings concerning such lands, setting forth the award made for each tract or parcel thereof, or separate estate therein, to the owner or owners thereof. The commissioners shall be entitled to such compensation as the court may direct, which shall be paid by the city.

In case land or buildings belong to different parties.

SECTION 13. If the lands or buildings belong to different persons, or if the land be subject to lease, judgment or mortgage, or if there be any estate in it less than an estate in fee, the injury done to such persons or interests respectively, may be awarded to them by the commissioners, less the benefits resulting to them respectively from the proposed improvement.

Section 14. Whenever the commissioners shall have completed their duties and filed the report of

their proceedings and determination as before council may provided, the common council may if they shall ments to be deem it expedient, by resolution or ordinance, made. order such improvement to be made, and the land which has been so found necessary to be taken therefor, to be taken and used; and in case the city shall be absolutely liable to the owner or owners, or parties entitled thereto, for all compensation that may be established against said city therefor, and the council may also in that case make an assessment of the compensation to be paid therefor, with the costs of proceedings, or such part thereof as they shall determine to be just, upon the lands found by them to be directly benefited by such improvement in such proportion to the benefits enjoyed as they shall determine. If the council shall not deem it expedient to make such improvement, they may, by resolution, order all further proceedings to be discontinued.

SECTION 15. Any person being dissatisfied with May have the amount of compensation for property taken, from decision. or the amount assessed as benefits, shall have the right to appeal to the circuit court within twenty days from the time of awarding of compensation or assessment of benefits, by serving on the mayor or city clerk a notice of appeal therefrom, and giving a bond to the city in not less than one hundred dollars, to be approved by the mayor, acting mayor or city clerk, to pay all costs of appeal in case the appellant shall not, upon such appeal, increase the amount of compensation or decrease the amount assessed as benefits, as the case may be. The common council may appeal in behalf of the city by giving notice to the opposite party without giving bond. Upon filing such notice with the clerk of the circuit court, the appeals shall be considered an action pending in court for trial there, as other actions, and shall be entered by the clerk upon the records of the court by setting down the party appealing as plaintiff and the other party as defendant. Such appeal shall be tried by jury unless a trial by jury be waived by both parties; costs shall be allowed to the successful party, in accordance with the conditions of said bond.

SECTION 16. The report of the commissioners Repeal to be shall be recorded by the clerk of the court in

whose office the same is filed, in the judgment book of such court, and at any time after the making of such award the city may set apart in its treasury, to the order of the owner or owners of the land so taken, or pay the same to such owner or owners, or to the clerk of said court for the use of such owner or owners, the amounts awarded by the commissioners, and thereupon may enter upon, take and use the land for the purposes for which it was condemned, and may obtain from either of said judges, upon twenty-four hours' notice, a writ of assistance, to put its officers or agents into possession of the same. If such city be in possession or put in possession of such land. pending an appeal, the owners or parties entitled thereto shall be entitled to receive the money paid into court or set apart in the city treasury on account of the award appealed from, without prejudice to the appeal taken, but if the city shall have appealed, such money shall only be so withdrawn by leave of court, upon filing a bond in such sum and with such surety as shall be approved by the court or judge, to repay the amount by which such award shall be abated on such appeal, with costs. If any defect of title to or incumbrance upon any parcel of the premises shall be suggested in said petition, or if any party to said proceeding, or any person not a party, shall petition to the said court, setting up a claim adverse to the title set out in said petition to said premises, and to the money or any part of it to be paid as compensation for the property so taken, the court shall hear and determine the right of the parties to said money, and for that purpose may order a reference or an issue to be tried by a Either party may except to the decision of the court and may appeal to the supreme court in Either court may like manner as in actions. award costs to the prevailing party, and render judgment against the other party.

SECTION 17. When the whole of any lot or tract of land or other premises under lease or under contract shall be taken by virtue of this act, all the covenants, contracts or engagements between landlord and tenant, or any other contracting parties touching the same or any part thereof, shall, upon the confirmation of such report, respectively

cease and be absolutely discharged.

In case property is under lease.

SECTION 18. When only part of a lot or tract Regarding of land, or other premises so under lease or contract, shall be taken for any of the purposes aforesaid, all the covenants, contracts or agreements respectively, respecting the same, upon the confirmation of such report, shall be absolutely discharged as to the part thereof so taken, but shall remain valid, as to the residue thereof; and the rents. considerations, and payments reserved, payable and to be paid for and in respect to the same, shall be so proportioned that the part thereof justly and equitably payable for such residue thereof, and no more shall be paid or recoverable for in respect to the same.

SECTION 19. When any known owner of lands in case of legal or tenants affected by any proceedings under this charter, shall be an infant, or labor under any disability, the judge before whom the proceedings are pending may, upon the application of the council, or such party or his next friend, appoint a guardian for such party, in the same manner as in a civil action in a court of record, and all notices required by this charter shall be served

upon such guardian.

SECTION 20. The judge or court before whom May amend de proceedings are pending shall have power at any mality. time to amend any defect or informality in any of the special proceedings authorized by this act as may be necessary, or to cause new parties to be added, and to direct such further notices to be given to any party in interest as he deems proper. and also to appoint other commissioners in place of any who shall die, or refuse or neglect to serve, or be incapable of serving.

SECTION 21. Whenever any public grounds, Accurate survey to be made. streets or alleys shall be laid out, widened or enlarged, or other public improvements made under the provisions of this chapter or this act, the common council shall cause an accurate survey and profile thereof to be made and filed in the office of the city clerk.

SECTION 22. The council shall have power to Power to change the name of any street and to vacate any name of streets. plat or portion thereof that may be petitioned for by the proprietor of such plat, or any person interested therein; but no petition for such vacation shall be acted upon unless notice of such application to the common council shall have first been

published in the official city paper or papers for at least two weeks prior to the meeting of the council.

Unplatted

Section 23. Roads or streets may be laid out by the council through unplatted lands, in the same manner as roads are laid out by supervisors in towns.

Directions only directory.

Section 24. All the foregoing directions given in this chapter shall be deemed only directory, and no error, irregularity or informality of any of the proceedings under the provisions of this act, not affecting substantial justice, shall in any way affect the validity of the proceedings.

CHAPTER VIII.

CITY IMPROVEMENTS.

City improvements. SECTION 1. The council shall have power to order and contract for the making, grading, paving, macadamizing, repairing and cleaning of streets, alleys, public grounds, reservoirs, gutters, sewers, drains and sidewalks in the manner hereinafter mentioned, and direct and control the persons employed therein.

Cost and expense of surveying, etc. Section 2. The cost and expense of surveying or repairing streets, alleys, side walks, drains and sewers, and of estimating work thereon, in the execution of any public improvement, shall be charged to and payable by the city. The cost and expense of opening, grading, graveling, paving, macadamizing, or planking streets and alleys, and constructing or repairing sidewalks, shall be payable out of the general funds of the city. Sewers, cross walks and drains may be ordered by the council, and all costs and expenses, as well as the damages which shall be sustained by owners of lands through which the same shall pass, shall be charged to and payable by the city.

Regarding the repaying of streets.

SECTION 3. Whenever the council shall require any street to be repaved or macadamized, it shall determine the manner in which the work shall be done, and of what material; and the street commissioner, or such other person or officer as the council may designate to have charge of the work, shall let a contract for doing the whole of such work. Public notice of the letting of such con-

tract shall be given by advertisement in the official paper of the city for at least twenty days, and the contract shall be awarded to some responsible bidder, whose bid it shall deem most reasonable and proper; the cost of such paving or macadamizing shall be paid by the city out of the general funds of the city.

SECTION 4. In case no bids shall be received for In case there the performance of any work required to be done are no bids. by this act, the council may cause such work to be done under the supervision of the street commissioner, or a committee of the council, and the expense for doing the same shall be paid for by the city out of the general funds of the city.

SECTION 5. The cometery grounds now owned control of by the city of Black River Falls, shall be con-grounds. trolled by the mayor and common council of said city of Black River Falls, and they shall be empowered to purchase, in the name of said city, additional grounds for cemetery purposes, and all other property belonging to said city shall be under the control of the mayor and common council.

SECTION 6. The county bridge across Black County bridge. river, in the city of Black River Falls, shall be and remain a county bridge, and shall be kept up and maintained at the county expense, and in no event shall said county bridge be kept in repair or maintained at the city expense, and said city shall not in any event be liable for injuries caused by any defect in said bridge.

CHAPTER IX.

ASSESSING, LEVYING AND COLLECTING OF TAXES.

SECTION 1. All property, real or personal, Assessing and within the city, except such as may be exempt by taxes. the laws of the state, shall be subject to taxation for the support of city government, its schools and the payment of its debts and liabilities, and the same shall be assessed in the manner hereinafter provided; and the assessor elected under this act shall have and possess the same powers, and be subject to the same duties and liabilities, as township assessors, except so far as they may be altered by this act; provided, however, that the common council may prescribe the forms of as-

sessment rolls, and more fully define the duties of assessors, and make such rules and regulations in relation to revising, altering or adding to such rolls as they may from time to time deem advisble.

Return of as-

Section 2. The assessor shall return the said assessment roll to the board of equalization of the city on or before the first Monday in July in each and every year. The board of equalization may supply omissions in said roll, and for the purpose of equalizing the same may alter and and to take from and otherwise revise and correct the same.

In case of omission.

If it shall appear to the assessor that SECTION 3. any lot or parcel of land was omitted in the assessment roll of either or both of the preceding years, and that the same was then liable to taxation, he shall, in addition to the assessment of that year, assess upon the lot or tract so omitted for such year or years that it shall have been omitted, the just value thereof, noting the year when such omission occurred, and such assessment shall have the same force and effect as it would have had if made the year when the same was omitted. and the common council shall direct, in addition to the tax for the current year, such tax to be levied upon such lot or tract as the same would have been chargeable with had not the same been so omitted; and such tax shall be collected as other taxes or assessments for the current year. All lands shall be subject to taxes that may have been omitted, in whosesoever hands the same may have come. Should the tax or assessment upon any parcel of land be set aside or declared void be reason of any defect or informality in the assessing, levying, selling or conveying of the same, but not affecting the equity and justice of the tax itself, the common council shall cause the tax or assessment so set aside or declared void, to be relevied in such manner as they shall by ordinance direct; provided, that if the defect was in the assessment, the same shall be again assessed at such time as the common council shall direct, and the said tax or assessment so assessed shall be levied and continue a lien upon such lot or tract, and shall be collected as other taxes and assessments are collected under this act.

Board of equalization.

SECTION 4. The mayor, the city clerk, the asses-

sor and one alderman from each ward shall constitute the board of equalization. Such board of equalization shall meet on the first Monday of July each and every year at nine o'clock in the forenoon, and shall proceed in all respects, as town boards are by law required to proceed, as far as the same is applicable, reviewing, correcting and equalizing the assessment roll of the city. The mayor shall be president of the board of equalization and the city clerk, the clerk thereof, and all changes made in said roll by said board shall be recorded by the clerk, and when finally completed the said assessment roll shall be filed with the city clerk.

SECTION 5. On the first Monday of October in City taxes to be each year, or within ten days' thereafter, the determined. common council shall determine the amount of taxes authorized by law and by this act to be levied for general city purposes, for school pur-poses, and for paying the city's indebtedness, due or to become due for the ensuing year; and shall by resolution, levy the same; but no such resolution shall be adopted except by a vote of two-thirds of the members elect, which shall appear in the proceedings of the common council.

SECTION 6. All taxes and assessments, general Taxes to remain a lien en or special, levied under this act, shall be and re-property. main a lien upon the lands and tenements upon which they may be assessed and upon all personal property of any person or body politic, assessed for personal taxes, from the date of the warrant, for the collection thereof, until such taxes shall be paid; and no sales or transfers of such real or personal property shall affect such lien. personal property belonging to the person taxed may be sold for the payment of taxes upon personal property or real property.

SECTION 7. Before the annual meeting of the City clerk to board of supervisors of the county of Jackson, stract of assessand by the time required by the laws of this ment roll. state for the return of assessments from the several towns, the city clerk shall transmit an abstract of the assessment roll to the county clerk of said county, who shall lay the same before the board of supervisors at their annual meeting.

SECTION 8. The board of supervisors shall re- Chy to be regard the city of Black River Falls as a town, in gardeda town

equalizing the assessment of the several towns in said county, as provided by law; but in such equalization shall consider the assessment roll of the city as an entire roll.

Supervisors may levy a tax.

ŠECTION 9. The said board of supervisors may levy a tax or taxes upon such city, as now is or may be provided by law hereinafter in relation to towns, and shall cause the amount of taxes so levied to be certified to the city clerk in the manner provided by law in relation to towns and town clerks, and in all transactions of the board of supervisors of said county, said city shall be regarded as a town, except as herein otherwise provided.

City clerk shall add tax to assessment roll.

SECTION 10. Upon receiving the statement of the amount of taxes so levied, the city clerk shall make out upon the assessment roll, in columns left for that purpose, or upon a copy thereof, a complete statement of the several taxes levied for state, county, city or other purposes, and all delinquent taxes of any previous years, and all special taxes levied by the common council since the making out of the annual tax list in such separate columns as may be necessary, with the total footings carried out opposite each tract or lot of land, or persons named therein, which statement shall be called the tax list of the city of Black River Falls, and shall be preserved by said clerk as a record in his office, and shall have the same legal force and effect as the records of the common council.

Tax list to be prima facie evidence. SECTION 11. The tax list made out and preserved as aforesaid shall be prima facie evidence in every court of record in the state that every act or thing required by law to be done relating to the assessing or levying of taxes, from the election of officers to the completion of the tax list, inclusive has been done regularly and correctly as required by law.

Duplicate copies to be made out. Section 12. Immediately after making out the tax list as aforesaid, the clerk shall make out a duplicate copy thereof, to which shall be appended a warrant, signed by the mayor and clerk and sealed with the corporate seal of said city, directed to the treasurer, requiring and commanding him to collect the taxes specified in said duplicate copy of the tax list, in the manner provided by law, and said clerk shall on or before the tenth

day of December of the same year deliver the same to the city treasurer for collection, and make a record of such delivery on the tax list preserved in his office.

SECTION 13. Upon the receipt of any tax roll Public notice and warrant by the treasurer, he shall give public shall be given. notice of four days in a newspaper published in said city, and by posting the same in three or more public places in said city, that such tax list has been committed to him for collection, and that he will receive payment for taxes at his office therein, on and after the day in such notice to be specified.

SECTION 14. The city treasurer, upon the re-city treasurer ceipt of such duplicate copy of the tax list, shall to collect. proceed to collect the same in like manner, and shall have like powers, and be subject to like requirements, liabilities and restrictions as town treasurers, except as otherwise provided in this act. The city treasurer shall receive two percent. fees upon all taxes paid to him before the tenth day of January, and five per cent. fees upon all taxes paid or collected after that time, which fees when collected shall be paid into the treasury of the city for the benefit of the general fund.

SECTION 15. The treasurer shall on or before when taxahall the last Monday in January in each year, pay to be paid. the county treasurer the state tax apportioned to said city of Black River Falls by the board of supervisors of said Jackson county.

SECTION 16. On or before the last Monday in Delinquent tax January in each year, unless the time be extended list to be made out. as provided by law, the said treasurer shall make out a return to the treasurer of the county in which said lands may be, a list of all lands and lots upon which the taxes have not been paid, and shall also settle with and pay over all moneys properly payable to said county treasurer, in like manner as now or may hereafter be required of town treasurers. The said treasurer shall also, at the said time, make out and deliver to the city clerk a list of all delinquent personal property taxes for the same year. The county treasurer shall add the same interest, penalty or fees to such delinquent returns as are allowed, or are required by law upon delinquent returns from the several towns.

Section 17. The county treasurer shall sell all

County treasurer shall sell delinquent . lands. delinquent lands and lots returned from the city of Black River Falls, at the same time and in the same manner as other delinquent lands are sold in said county.

Directions only directory.

Section 18. All the directions hereby given, for the assessing of land and assessing and levying, collections and returns of taxes and assessments, shall be deemed only directory, and no error or informality in the proceedings of any of the officers entrusted with the same, not affecting the substantial justice of the tax itself, shall vitiate or in anywise affect the validity of the tax or assessment.

Power of council.

SECTION 19. The common council shall have power to levy a tax or taxes to pay any and all judgments against the city.

In case treasurer refuses to do his duty. SECTION 20. In case the city treasurer shall at any time refuse or neglect to perform his duties in enforcing the payment of taxes, as provided by this act, and as authorized and required by the laws of this state, the common council shall forthwith remove such treasurer from office, and appoint a suitable person to fill the vacancy.

Forced collection of taxes. SECTION 21. At the expiration of the time now or hereafter designated by the general laws of this state for the collection of personal taxes, the treasurer shall proceed to enforce the collection thereof, in the same manner as now is or may hereafter be prescribed by such law.

Poll tax.

SECTION 22. Every male inhabitant of the city of Black River Falls over twenty-one years of age and under fifty, except active members of the fire department, shall pay into the city treasury annually, the sum of one dollar and fifty cents each as a poll tax. It shall be the duty of the assessor in the city of Black River Falls to make out duplicate lists of all persons liable to said tax in the city, and said assessor shall, on or before the first Monday of July in each year, deliver one of said lists to the city clerk and one to the treasurer of the city of Black River Falls. The said treasurer shall thereupon immediately proceed to collect the same; and all persons liable to pay such tax who shall not have paid the same within twenty days after demand, either personal or by written notice left at their usual place of abode. shall be liable to and shall pay a penalty of two dollars, together with the costs of prosecution, to

be prosecuted for by said treasurer in the name of the city of Black River Falls. The process in such case shall be by warrant, and in case judgment shall be rendered against the defendant in such action, and he shall refuse or neglect to pay such judgment, he shall be imprisoned in the county jail not to exceed ten days. The moneys collected as above shall go to the general fund of the city. The mayor, city clerk and treasurer shall constitute a board to determine the liabilities of persons to pay such tax; and all persons claiming to be exempt from such tax must apply to said board within twenty days after the demand or notice mentioned in this section.

CHAPTER X.

FIRE DEPARTMENT.

SECTION 1. The common council, for the pur- Fire departpose of guarding against the calamities of fire, ment. shall have the power to prescribe the limits within which wooden buildings or buildings of other material that shall not be considered fire-proof, shall not be erected or repaired, and to direct that all and every building within the limits prescribed shall be made and constructed of fire-proof materials, and to prohibit the repairing or rebuilding of wooden buildings within the fire limits, where the same shall have been damaged to the extent of fifty per cent. of the value thereof, and to prescribe the manner of ascertaining such damage, and to prescribe the penalties for the violation of any resolution or ordinance passed under this section.

SECTION 2. The common council shall have the Dangerous conpower to prevent the dangerous construction and buildings, condition of chimneys, fire-places, hearths, stoves, chimneys, etc. stove-pipes, ovens, boilers and apparatus used in and about any building, and to cause the same to be removed or placed in a safe condition when considered dangerous; to prevent the deposit of ashes in unsafe places; to require the inhabitants to provide as many fire-buckets, and in such manner and time as they shall prescribe, and to regulate the use of them in time of fire; to regulate and prevent the carrying on of manufactures dangerous in causing or promoting fires; to regulate

and prevent the use of fire-works and fire-arms; to compel the owners and occupants of buildings to have scuttles in the roof and stairs or ladders leading to the same; to authorize the mayor, aldermen, firewardens and other officers of the city to keep away from the vicinity of a fire all idle and suspected persons, and to compel all by-standers to aid in the extinguishment of fires and in the preservation of property exposed to danger thereat, and generally to establish such regulations for the prevention and extinguishment of fires as the common council may deem expedient, and to provide penalties for the violation of any resolution or ordinance passed under this section.

Power to purchase fireengines.

SECTION 3 The common council shall have full power to purchase fire-engines and other fire apparatus, and to authorize the formation of fireengine, hook and ladder and hose companies, and to provide for the due and proper support and regulation of the same, and to order such companies to be disbanded and their meetings to be prohibited and their apparatus to be delivered up. Each company shall not exceed seventy able bodied men between the ages of eighteen and fifty years and may elect its own officers except chief eugineer and assistant engineer, who shall be appointed by the council, and form its own by-laws. not inconsistent with the laws of the state or the ordinances and regulations of said city, and shall be formed only by voluntary enlistments. Every member of said company hereby authorized to be formed shall be exempt from highway work and poll tax and from serving on juries and military duty, except in case of war, insurrection or invasion during the continuance of such membership; and any person having served for the term of ten years in either of such companies shall be forever thereafter exempt from poll tax and military and jury duty, except as in cases before mentioned.

Firewardens.

Section 4. The mayor shall appoint two firewardens for each ward subject to confirmation by the common council, who shall perform such duties as the common council may prescribe, and they may at any time enter into any building, house, store, barn or enclosure for the purpose of inspecting the same.

Section 5. When any person shall refuse to

obey the lawful order of any engineer, firewarden Penalty for reor alderman of the city, the mayor or city mar-flawful order of shal at any fire, it shall be lawful for the officer proper officers. giving such order to arrest or direct orally the marshal, constable or watchman, or any citizen to arrest such person, and to confine him temporarily in any safe place until such fire shall be extinguished, and in the same manner such officers or any of them, may arrest or direct the arrest and confinement of any person at such fire who shall be intoxicated or disorderly; any person who shall refuse to arrest or aid in arresting any person so refusing shall be liable to such penalty as the common council may prescribe, not exceeding twenty dollars.

SECTION 6. The common council shall have Sack compower to organize a (sack) company, or to coun-panies may be organized. tenance any such company now organized, which shall be known by such names as they may select and shall consist of not more than thirty mem-Such company shall continue a part of the fire department, and at fires shall be subject to the control of the engineer; the members of the said company, either collectively or individually, are hereby authorized and empowered to act as special police in and for the city of Black River Falls, and are hereby vested with all the power and authority which now is and may thereafter be vested in any other police officer of said city, and shall be entitled to all the rights and immunities of the fire department, except exemption from jury duty. At fires they shall take charge of all property which may be exposed or endangered, and shall, as far as may be in their power, preserve the same from injury or destruction; such company may from time to time, adopt such by-laws as they may deem necessary, not inconsistent with the laws of this state, or the ordinances of said city. The members thereof shall not be entitled to any compensation for any services rendered in their official capacity. They shall, in case of riot or other disturbances of the peace, have access to all licensed places of amusement in the city, and shall perform such services as may be necessary for the peace and good order of the same.

Section 7. There shall be elected by the mem- officers of sack bers of each company aforesaid, annually at their company.

annual meetings, a clerk or secretary, and a treasurer, who shall on or before the first Monday of May in each year, return to the city clerk a list containing the names of each member of their respective companies; and when any member of either of said companies shall cease to be a member thereof by resignation, expulsion or otherwise, notice thereof shall be given to the city clerk.

Duties of treasurer.

SECTION 8. The treasurer of the fire department shall receive and pay out all moneys belonging to said department, and shall secure the faithful performance of his duty by his bond to said city, in such penal sum as may be required, and with sureties to be approved by the common council; such moneys shall only be paid out on orders signed by the chief engineer or acting chief engineer and countersigned by the clerk of said department.

Duties of clerk.

Section 9. The city clerk is hereby required to keep a record of the members of the several companies organized under this chapter, and such record shall consist of the returns made by the several clerks or secretaries as above provided; and no person shall be exempt from jury duty unless his name is entered on such list. In case any person shall for any cause cease to be a member of either of said companies the clerk shall note that fact on the list thereof, and shall return to the clerk of the board of supervisors of the county of Jackson, a list of all members who are members of either or all of said companies exempt from jury duty, on or before the day now appointed or which may hereafter be appointed for the annual meeting of said board, and said board shall not place the names of such persons on the jury list for the ensuing year.

May levy tax for fire purposes. SECTION 10. The council shall have power to raise a tax each year, not exceeding five mills on the dollar of the taxable property within said city for fire purposes, the same to be assessed and collected in the same manner as the general tax of said city; and the moneys arising therefrom shall be expended under the direction of the council of said city for fire purposes.

Two per cent to be paid by corporations, etc.; SECTION 11. All corporations, companies and associations not incorporated under the laws of this state, engaged in said city effecting fire insurance shall pay to the city treasurer at the rate of

two per cent. upon the amount of all premiums which shall have been received or shall have been agreed to be paid for any insurance effected or agreed to be effected on any property in said city, by or with such corporation or associations respectively, in manner and at the times as prescribed by the general laws of the state in relation thereto. The money so received shall go to the general fund of the city, to be used and paid out for the purposes of said fire department.

CHAPTER XI.

ACTIONS TO RECOVER PENALTIES.

SECTION 2. It shall be sufficient to give the Number of sec-number of the section and chapter of this act, or ter to be given. the section of the ordinance, by-law or regulation violated in the foregoing form of complaint, and said complaint may be sworn to before any officer authorized to administer oaths: Upon the filing of such complaint with the justice of the peace, he shall issue a warrant substantially in the following form:

State of Wisconsin, City of Black River Falls, \ ss. County of Jackson,

To the sheriff or any constable of said county, Form of or the marshal of the city of Black River Falls, greeting:

Whereas — — has this day complained to me in writing, on oath, that — did, on the — day of —, 18—, violate the sections of an ordinance, by-law, regulation or law (describing it by its title), which said — is now in force and effect, as said complainant verily believes. Therefore, in the name of the state of Wisconsin, you are hereby commanded to arrest the body of the said — and bring him before the justice of the peace of said city to answer to the said city of Black River Falls on the complaint aforesaid.

Justice of the Peace

How the court shall proceed in the case. SECTION 3. Upon the return of the warrant, the court may proceed summarily with the case, unless it be continued by consent, or for cause. If the case he adjourned, the defendant, if required by the court so to do, shall recognize with surety for his or her appearance, in such sum as the court may direct, or in default thereof may be put in the charge of the officer who made the arrest, or be committed to the common jail of Jackson county. The complaint made aforesaid shall stand in lieu of a declaration, and the plea of "not guilty" shall put at issue all subject matter which pertains to the defense of the action.

Prima facie evidence. SECTION 4. A printed copy of any ordinance, by-law or resolution purporting to have been passed by the common council, and published in a newspaper, or in pamphlet or book form, shall be *prima facie* evidence of its due passage and publication, and shall be received in evidence after issue joined and upon trial in any court in this state.

Witnesses and jurors to attend without fees in advance.

SECTION 5. Witnesses and jurors shall attend before the justice court in all city or criminal prosecutions, without payment of fees in advance, or a tender thereof, upon the process of the court duly served, and in default thereof their attendance may be enforced by attachment. In case the jury, after being kept a reasonable time, should disagree, they shall be discharged without the payment of fees, and thereupon the court shall adjourn the cause to a day certain, and issue a new venire as aforesaid.

Findings of court.

Section 6. In city prosecutions the finding of the court shall be "guilty" or "not guilty." If guilty the court shall render judgment thereon against the defendant for the fine, penalty or forfeiture prescribed in this act or in the ordinance,

by-law or regulation for which the violation of which the person or persons shall have been adjudged guilty, and for costs of suit; but if not guilty, the costs of suit shall be taxed against the city; and in all cases of conviction in actions brought or prosecuted to recover a penalty, a fine or forfeiture under any of the provisions of this act, or for the violation of any ordinance of said city, the court shall enter judgment against the defendant for the fine and costs of prosecution, and if the defendant shall neglect or refuse to pay such fine and costs the court shall enter a judgment that the defendant be imprisoned in the county jail of Jackson county for such term as may be prescribed by this act or the ordinance violated not exceeding three months, and shall forth with commit the defendant for the term fixed by said judgment, or the court may, in its discretion, in case of the non-payment of such fine and costs as aforesaid, enter judgment that said defendant be imprisoned as aforesaid and kept at hard labor for the benefit of the city of Black River Falls, in the said jail or upon the public streets or elsewhere within said city, under the supervision of the city marshal, or such member of the police force as may be detailed by the mayor for that purpose, for the period of time for which such person or persons shall have been so committed, unless the judgment and expenses of imprisonment are sooner paid; and all persons so committed and kept at labor shall be allowed one dollar per day for each day's labor rendered exclusive of board, and the amount so earned shall be applied in liquidation of the judgment, until the same shall be fully paid by such labor, at which time the judgment shall be satisfied and the defendant discharged from custody. execution may be in the following form:

The form of the commitment shall be substantially the same as that of the execution, omitting all that relates to the levy and sale and return of writs.

Appeal of defendant, how taken. SECTION 7. In all cases where judgment is rendered against a defendant for the recovery of fines or penalties mentioned in this act, or the ordinances now in force or hereafter to be ordained, the defendant may appeal from such judgment to the circuit court of the county of Jackson in the same manner as is now provided by law from judgment of justices of the peace in criminal cases.

In case judgment be affirmed. SECTION 8. If the judgment of the justice of the peace shall be affirmed, or if, upon the trial the defendant shall be convicted, the court shall inflict the penalty provided by this act, or the ordinance, resolution, by-law or regulation under which he or they are prosecuted, and enter judgment against him or them, and their sureties for such penalty, together with the costs in both courts, and enforce the same by execution, as in action of tort.

City may appeal.

SECTION 9. In all cases where judgment is rendered against the city of Black River Falls for the costs, when said action shall have been brought

under any of the provisions of this charter, or for the violation of any ordinance, resolution or bylaw of said city, the said city may appeal from such judgment to the circuit court of said county. within the same time and in the same manner as provided by law for appeals from justice court. Judgments in civil actions and if judgment be rendered against the defendant in circuit court, it shall be enforced by the circuit court as provided by section 6, of this chapter.

SECTION 10. Said appeal shall stand for trial by Appeal to jury, unless a jury be waived in the manner provided by law; in said circuit court, at the next term thereof after the day the judgment of the justice of the peace shall be rendered, and no notice of trial shall be required to be given to or

by either party.

SECTION 11. No person shall be an incompetent shall not work judge, justice, juror or witness by reason of his incompetency being an inhabitant of said city in any proceeding or action in which the city shall be a party in interest.

SECTION 12. When any suit or action shall be How action commenced against said city, the service thereof shall be commenced. may be made by leaving a copy of the process of summons with the mayor or clerk of said city, and it shall be the duty of the said mayor or clerk so served forthwith to inform the common council thereof, or to take such demand or proceedings as by ordinance or resolution of said council may be in such case provided.

SECTION 13. All penalties and forfeitures recov- Penalties to be ered and collected under and by virtue of this act paid into treasury. shall be paid into the city treasury for the use and

benefit of said city.

SECTION 14. All fire-engines, hose carts, hooks city fire propand ladders, and wagons therefor, and all other empt from atapparatus and implements used to extinguish fire, tacoment or and all houses or buildings owned or occupied by said city for such engines, hose carts, hooks and ladders and other apparatus and implements, shall be exempt from attachment or execution issued in any action or any judgment wherein the said city shall be a party.

SECTION 15. No real or personal property of city any inhabitant of said city, or of any individual property exempt for city or corporation, shall be levied on or sold by virtue debts. of any attachment or execution issued to collect

or satisfy any contract, debt or obligation of said

city, or any judgment against said city.

Power of pardon, etc.

SECTION 16. The mayor shall have power to grant pardons or commutations, after convictions, for all offenses against the ordinances of the city, upon such conditions as he may deem proper. He shall communicate any such actions to the council at its next meeting, with the reason therefor.

In case judgment against city.

Section 17. When a judgment shall be recovered against the city of Black River Falls or against any city or ward officer in an action prosecuted by or against such officer in his name of office, where the same should be paid by the city, no execution shall be awarded or issued upon such judgment, except as herein provided; but the same, unless reversed, shall be levied and collected as other city taxes, and when so collected shall be paid by the city treasurer to the person to whom the same shall be adjudged, upon the delivery of a proper voucher therefor; but if any payment thereof be not made within sixty days after the city treasurer is required to make his return of taxes next after the rendition of such judgment, execution may be issued thereon upon the order of the court authorized to issue such execution on special application therefor.

CHAPTER XII.

MISCELLANEOUS PROVISIONS.

May purchase stone crusher.

SECTION 1. The common council shall have power to purchase a stone crusher and to purchase stone and cause the same to be broken and prepared for use in improving the streets of the city. The council may with the consent of the sheriff, or of the board of supervisors of Jackson county, deposit stone when brought upon the grounds connected with the jail of said Jackson county, and may use in breaking said stone such labor of prisoners under sentence in said jail as the sheriff will furnish, or may use said labor in breaking stone or in doing any other work in any part of the city, on such terms as may be agreed between the city and the county of Jackson.

Set out ornamental trees. SECTION 2. The council shall have power to require the owner of any lot or grounds in said city to set out ornamental or shade trees in the street in

front of the same, and to protect and preserve them, and in default, thereof, to cause the same to be done, and to levy a special tax upon such lot or grounds to pay the expense of the same. It shall also have power to determine the lines on which the trees shall be set, the places where they are to be set, and the kind and size of the trees to be set, and the manner of protecting them, and for replanting them when they have died or been so injured as to fail to answer the purpose for which they were set out, and to prohibit the setting out of any trees that may be regarded as nuisances, and to order their removal when they have hitherto been set out. It shall also have power to provide for and direct the trimming of shade trees to such proper proportions, and to do all other needful acts as to them shall seem just and proper to give this section proper effect.

The common council may expend Amount that for the improvement of any highway or highways pended. leading into said city not to exceed two thousand dollars in any one year, to be expended under and

by the direction of the common council.

SECTION 4. The common council may expend Donation for for the improvement of the Jackson County Agri- fair purposes. cultural Society fair grounds in said city of Black River Falls, not to exceed one thousand dollars in any one year, to be expended under and by direction of the common council of said city.

SECTION 5. All work for the city exceeding one to be let by hundred dollars in amount shall be let by contract contract. to the lowest responsible bidder, and due notice shall be given of the time and place of letting

such contract.

Section 6. No extra compensation shall be no extra comallowed to any officer, agent, servant or contractor any officer. after the service shall have been rendered, or the contract entered into, nor shall any compensation be paid to the mayor or any alderman, for their services.

SECTION 7. The council shall settle all just Settlement of claims and demands against said city, and settle with the treasurer annually, and publish accounts of the receipts and expenditures of the city for the information of the citizens.

SECTION 8. This act is hereby declared a pub-public act. lic act, and shall be liberally construed in all courts of this state.

In case city cierk is incapacitated.

Section 9. Whenever the city clerk may be absent or incapacitated from performing the duties of his office, the common council may appoint some suitable person to perform for the time being the duties of the office, and the acts of the person so appointed shall be of full effect and legality.

Penalty for collusion.

Section 10. Every member of the common council of the city of Black River Falls who shall. directly or indirectly vote for himself, or knowingly to any other person, any sum of money for any other purpose whatever, in violation of the city charter, or any amendment thereof, or shall ask or receive any compensation for doing any official act, except as inspector of elections, member of the board of registry, and as a member of the board of equalization, or for extra work on committee; any member of the common council or any other city officer who shall be directly or indirectly interested in any contract with or in behalf of said city, and any member of said council. or other city officer, who shall directly or indirectly purchase or be interested in the purchase of any city order or city indebtedness for less than the full amount thereof, shall be deemed guilty of a misdemeanor in office, and may be prosecuted either by indictment or complaint, before any justice of the peace having jurisdiction, and upon conviction thereof, shall be punished by fine not exceeding one hundred dollars nor less than twenty dollars, or by imprisonment in the county iail for not more than thirty days nor less than ten days, or both, at the discretion of the court, and shall forfeit his office; and any contract made in violation of the provisions of this section shall be

Licenses by whom signed.

Section 11. Every license issued by the authority of this act, or the ordinances of the city, shall be signed by the city clerk and sealed with the corporate seal of the city; but no such license shall be issued by said clerk until the person applying for the same shall have deposited with the clerk the receipt of the city treasurer for the amount required to be paid therefor. Nor shall any license be issued for dealing in, selling or vending spirituous or malt liquors, until the same shall have been directed by the common council, and the applicant shall have filed a receipt as afore-

said, together with the bonds as required by the laws of this state, which bond shall be approved either by the mayor or common council; every such license shall contain a clause prohibiting the selling, vending or giving away of any spirituous. vinous or malt liquors on general or special election days.

SECTION 12. No assignee of any license shall be Assessment of licenses. permitted to pursue the occupation or business licensed, except by a vote of two-thirds of the

common council.

SECTION 13. Any person who shall be guilty of Drunkenness, drunkenness, or immoderate drinking, improper cunished. reveling, obscenity or noisy, boisterous or disor-derly conduct in the streets or public places of the city of Black River Falls, shall be deemed guilty of a misdemeanor, and on conviction thereof before a justice of the peace of said city, shall be punished by a fine of not less than one nor more than one hundred dollars, or by imprison. ment in the county jail of Jackson county not less than two days nor more than three months.

Section 14. No moneys shall be appropriated Appropriafor any purpose whatever except such as are ex-

pressly authorized by this act.

SECTION 15. No penalty or judgment recovered Remission of in favor of the city shall be remitted or discharged except by a two-thirds vote of the aldermen elect.

SECTION 16. The common council may at any Lines and time cause a new and accurate survey to be made may be re-adon the lines and boundaries of all the streets, justed. alleys, sidewalks, public grounds, wharves and blocks, and may cause to be established such permanent land marks as they deem necessary, and cause an accurate plat or plats thereof to be made and certified to by the surveyor, which shall be filed in the office of the city clerk, and recorded in the office of the register of deeds of Jackson county.

SECTION 17. The surveys and landmarks so shall be prima made and established shall be prima facie evidence of correctness. dence of the lines and boundaries of all streets, alleys, public grounds, wharves and blocks in all cases in which they shall be drawn into controversy in all courts in this state.

SECTION 18. The common council may, at such grades of all time as they may deem proper, establish the streets shall be established.

grades of all streets, alleys and sidewalks of said city, or any or either of them, and shall cause accurate profiles thereof to be made, and should the grade so established be at any time thereafter altered, all damages, costs and charges therefor shall be paid by the city to the owner of any lot or parcel of land or tenement which may be effected or injured in consequence of the alteration of such grade; provided, however, that nothing in this section contained shall be so construed as to prevent the street committee of the several wards of said city from ordering or causing to be done, the grading of any street within their ward to a temporary grade to be established by such committee.

May have and purchase real estate.

SECTION 19. The city may have, purchase and hold real and personal estate sufficient for the convenience of the inhabitants thereof, and may sell and convey the same; and the same while owned, occupied or held by said city, shall be exempt from taxation.

Not subject to special taxation. SECTION 20. No real or personal property shall be subject to special taxation for street or sidewalk purposes; but all streets and sidewalks are to be maintained out of the general funds of the city.

Deeding property.

SECTION 21. When the city of Black River Falls deeds or leases any real estate or any interest therein, owned by said city, the party of the first part shall be the city of Black River Falls, and the person or persons authorized to execute such deed or lease, need not be named in the body thereof.

Mayor to execute a deed. SECTION 22. The mayor of said city is hereby authorized, when the common council shall by ordinance or resolution for that purpose describe the real estate and interest to be conveyed, order and direct him so to do, to execute a deed or lease of such real estate or interest therein belonging to the said city. The said deed or lease shall be signed by the mayor of the city and countersigned by the city clerk and sealed with the corporate seal of said city, and duly witnessed and acknowledged as is provided for the execution of deeds and conveyances.

Ordinance to be attached to deed. Section 23. When any such deed or lease is so executed the city clerk shall attach to such deed or lease a true copy, by him duly certified, of the

ordinance or resolution aforesaid, and the same shall be recorded by the register of deeds, which said deed or lease, and such copy so attached and record thereof shall be in all courts of this state prima facie evidence of the authority of the mayor to make and execute such deed or lease.

SECTION 24. If any election by the people for in case elec-common council shall, for any cause, not be held at proper time. at the time or in the manner herein prescribed, or if the council shall fail to organize as herein prescribed, it shall not be considered reason for arresting, suspending or absolving said corporation, but such election or organization may be held at any subsequent day, by order of the common council, and if any of the duties enjoined by this or the ordinances or by-laws or regulations of said city, to be done by any officer at any specified time and the same are not then done or performed, the common council may appoint another time at which said act may be done or per-

SECTION 25. All moneys paid to the city on ac. License money count of any or all licenses whatever, granted or to be part of issued by the common council of said city shall general fund. issued by the common council of said city, shall be paid into the city treasury and become a part

of the general fund of said city.

SECTION 26. The use of the jail of Jackson use of country county, until otherwise provided, shall be granted jail. to said city, on such terms as may be agreed upon between the mayor and chairman of the county board of supervisors, for the confinement of offenders; provided, that in all cases of final commitments on sentence for the violation of any law or ordinance of said city, the expense of maintaining said prisoners shall be borne in the same way as now provided by section 917, revised statutes of 1878, for prisoners committed from villages for violation of village ordinances, and every such offender shall be delivered to the sheriff of said county, for whose custody, safe keeping and delivery the sheriff shall be responsible as in other cases.

SECTION 27. The city of Black River Falls shall How city shall be represented in the board of supervisors of in county Jackson county by three supervisors from the city board. at large.

SECTION 28. The regular committees of the com- Regular common council shall be as follows: On finance, erated.

streets, ordinances, fire department and licenses, and shall be appointed by the mayor at the first meeting after the annual election, or as soon thereafter as convenient.

Remission of tax, etc.

SECTION 29. The common council may by unanimous vote thereof, remit any tax or special assessment, or any part thereof whenever the same shall be manifestly illegal or unjust.

Town meetings may be held in city.

SECTION 30. The citizens of the town of Albion shall have the privilege to hold all town meetings and the general and special elections at such place in the city of Black River Falls as they may determine, and the officers of said town of Albion may transact all town business in said city and with the like effect as if held or done in the town of Albion.

City paupers, how disposed. SECTION 31. The paupers of said city shall be removed to the poor-house of the county of Jackson by the mayor or aldermen, in like manner as they are removed from the several towns in said county.

No officer to go as surety on bond.

SECTION 32. No alderman or other city officer shall be accepted as surety upon any bond, note or obligation made by or to the city, nor shall any officer required to give bonds as aforesaid enter upon the discharge of the duties of his office until such bond shall have been filed and approved as by this act provided.

Resignations.

SECTION 33. Any officer may resign his office by filing his written resignation with the clerk; and such resignation shall take effect and his office shall be deemed vacant from the time such resignation shall be accepted by the council.

Removal of member of council. SECTION 34. The common council may by a two-thirds vote thereof upon ten days' written notice and a hearing expel any member thereof for cause.

Removal of officers or agents.

SECTION 35. The common council may remove any officer or agent of the city, except a member of the common council by a majority vote thereof, for incompetency, misconduct or neglect in the discharge of official duties.

Shall constitute ne part of road district. SECTION 36. The city of Black River Falls shall constitute no part of a road district.

Does not repeal.

SECTION 37. No general law of this state contravening the provisions of this act, shall be construed as repealing, annulling, or modifying the same, unless such purposes be expressly set forth

in such law, as an amendment to this chapter or this act.

SECTION 38. No personal property tax shall be Personal property tax not returned by the city treasurer to the county treas-returnable. urer, but the city treasurer shall have the same powers to collect said personal property tax as is now conferred by law upon county treasurers for the collection of all personal property taxes.

SECTION 39. In all matters arising under the General provisprovisions of this act, not particularly provided govern. for by the provisions of this act, the same shall be governed by the general provisions of law on that

subject.

SECTION 40. All acts and parts of acts conflicting Repealing with the provisions of this act, together with sections. the act of which this is amendatory, are hereby repealed.

Section 41. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 164.

AN ACT to revise the charter of the city of Chippewa Falls.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

CHAPTER I.

SECTION 1. All that district of country in the corporate county of Chippewa, hereinafter described, shall be and remain a city by the name of Chippewa Falls, and the people who now, or who may hereafter inhabit said district, shall be a municipal corporation by the name of the city of Chippewa Falls, and shall have the general powers possessed by municipal corporations at common law, and also the powers hereinafter specially granted, and the authorities thereof shall have perpetual succession, and shall be capable of contracting and being contracted with, suing and being sued, pleading
