CHAPTER 139.

AN ACT to authorize Frank Entner, his associates, heirs and assigns, to keep and maintain a ferry across the St. Croix river.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Frank Entner, his associates, heirs Frank Entner and assigns, shall have the exclusive right and authorized to operate a ferry privilege, for the term of ten years, of keeping on St. Croix river. and maintaining a ferry across the St. Croix river, on lot number five, section number eleven, township thirty-three, range nineteen west, in Polk county, Wisconsin, and no ferry shall be authorized within one mile above the place where said ferry shall be established, or one mile below said ferry.

SECTION 2. The said ferry shall be subject to subject to reg-such regulations as ferries are, or may be by law, charge tolls. be subject, and the proprietor thereof, shall be entitled to receive for crossing any vehicle drawn by two horses or mules, or one yoke of oxen, forty cents; for each additional horse, mule or ox, ten cents; for one horse and wagon, thirty five cents; for horses, mules or cattle in droves, ten cents each; for sheep or hogs in droves, five cents each; for foot passengers, ten cents each; provided, that

the driver and passengers properly seated in any vehicle shall be included in the charge for the vehicle itself.

Right to alter repeal or amend act reserved. SECTION 3. The legislature hereby reserves the right to alter, amend or repeal this act at any future time.

SECTION 4. All acts or parts of acts conflicting with the provisions of this act are hereby repealed.

CHAPTER 140.

AN ACT to amend section 1095, of the revised statutes, relating to the collection of taxes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Amending section 1095, revised statutes.

SECTION 1. Section 1095, of the revised statutes is hereby amended, by adding after the word, "property" in the eighth line in said section, the words, "the valuation," so that said section when so amended shall read as follows: Section 1095. The county clerk of each county shall prepare and cause to be printed and furnished to each town, city and village treasurer of his county, a book of tax receipts for each current year, with stubs to be a duplicate of the receipts; and every town, city and village treasurer shall use only the receipts so furnished, and shall enter in each receipt given by him for the payment of taxes, the name of the person, firm, company or corporation paying the same, the date thereof, the description of the property, the valuation, and the aggregate amount of taxes paid; and when it appears from the tax roll that the taxes for the previous year remain unpaid upon any tract of land, he shall enter in such receipt, under the head of "taxes unpaid for previous year," opposite such tract, the year for
