CHAPTER 15.

AN ACT to appropriate money to pay for the sup-

*The people of the state of Wisconsin, represented
in senate and assembly, do enact as follows:*

SECTION 1. There is hereby appropriated out of
any money in the state treasury not otherwise

appropriated a sum sufficient to pay for the one hundred and fifty copies of Sanborn & Berryman's supplement to the revised statutes, purchased by the superintendent of public property for the use of this legislature, pursuant to joint resolution No. 3, senate; provided, that the cost of said supplements shall not exceed seven hundred and fifty dollars.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 16.

AN ACT to amend section 875, of the revised statutes, relating to officers of villages.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Amending
section 875 R. S.

SECTION 1. Section 875, of the revised statutes, is hereby amended to read as follows: Section 875. At the annual charter election in each village, there shall be chosen the following officers, viz.: A president, six trustees, a clerk, a treasurer, a supervisor, a marshal and a constable, also two justices of the peace and a police justice, if required to be elected in such year, unless any such office shall have been discontinued as hereinafter provided. All other officers shall be appointed by the village board and at their first meeting, unless they shall otherwise provide, after the annual election; and such officers shall be removable by the village board on a vote of a majority of all the trustees. No person not a resident elector in such village shall be eligible to any office therein.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
