## CHAPTER 327.

AN ACT to amend chapter 37, of the laws of Wisconsin of the year 1882, entitled, "an act to incorporate the city of Port Washington."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Amend section 5, of said chapter 37, by striking out the words, "a city marshal," and the word, "marshal," whenever occurring in said section. Amend ch. 37, laws of 1882. c

SECTION 2. Amend section 6, of said chapter 37, by striking out all after the words, "section 6," and in lieu thereof, insert the following: Whenever a vacancy shall occur in any office, except mayor, such vacancy shall be filled by the common council. The person appointed to fill any vacancy shall hold his office and discharge the duties thereof for the unexpired term, and with the same rights and subject to the same liabilities as the person whose office he shall be appointed to fill, except in case of justice of the peace, whose appointment shall continue only until the next charter election, when the vacancy shall be filled for the remainder of the term by an election. In case of vacancy.

SECTION 3. Amend section 19, of said chapter 37, by striking out all after the word, "clerks," in the eighteenth line of said section, and insert in lieu thereof, the following: And the said clerk shall possess authority to administer oaths and affirmations, and take acknowledgments of deeds, mortgages and other instruments in writing; he shall receive such compensation as the common council shall provide by ordinance or resolution, and he may appoint a deputy city clerk, to be approved by the common council, who shall in the absence or inability of the clerk, perform all the duties that would necessarily be required of the city clerk if present. Clerk may administer oaths.

SECTION 4. Amend section 57, of said chapter 37, by inserting in the first line of said section, between the words, "mayor," "clerk," "one alderman, the latter to be appointed by the common Further amend ch. 37.

council annually at a regular meeting to be held in the month of June.”

SECTION 5. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 332.

AN ACT to incorporate the city of New Lisbon.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

### CHAPTER I.

#### CORPORATE NAME.

SECTION 1. All that district of country in the county of Juneau hereinafter described, including the present village of New Lisbon, and the people who now or may hereafter inhabit said district, shall be a municipal corporation by the name of the city of New Lisbon, and shall have the general powers possessed by municipal corporations at common and statute laws, and also the powers hereinafter specially granted, and the authorities thereof shall have perpetual succession, and shall be capable of contracting and being contracted with, suing and being sued, pleading and being impleaded with, in all courts of law and equity, and shall have a common seal and may change and alter the same at pleasure.
