## CHAPTER 211.

AN ACT to provide for the distribution of the Blue Book.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

25,000 copies of blue book to be printed biennially

blue book to legislators, state officers. other officers.

The secretary of state shall, until SECTION 1. otherwise provided by law, cause to be printed twenty-five thousand copies of the Blue Book at each regular session of the Wisconsin legisla-Distribution or ture, to be distributed as follows: To each member of the senate and assembly one hundred and public and and twenty-five copies. To the chief clerks and the sergeants-at-arms of the two houses, fifty And to the assistant chief clerks copies each. and the assistant sergeants-at-arms, ten copies each. The journal clerk, the book-keeper and assistant book-keeper of the two houses, five copies each; and to each of the other clerks and employes, one copy each, whose names appear To the governor, one hunin the Blue Book. dred and twenty-five copies. To the secretary of state, one hundred and twenty-five copies. To the rest of the elective state officers in the capitol one hundred and twenty-five copies each. To the state agricultural society, the state horticultural society, the state board of charities and reform, the academy of arts and sciences, the home office of the Wisconsin humane society, one copy each. To the state historical To each regent of the state society, fifty copies. university and normal schools, one copy. each college, academy, free high school, normal school and free public library of the state, and to the state penal and charitable institutions, one copy each. To the county clerks and superintendents of schools of the several counties in this state, one copy each, which shall be delivered to their successors in office.

clerk of the supreme court of the state of Wisconsin, to the clerks of the United States courts in Wisconsin, one copy each. To each judge of a court of record in the state, one copy. To the reporters in regular attendance on the legislature, one copy each. To the justices of the supreme court of the state of Wisconsin and to the judges of the United States courts sitting within this state, one copy each. To each member of the state board of health, one copy. the senators and representatives in congress and to the members of congress elect, one copy To each member of the board of commissioners of fisheries, one copy. To the adjutant general for the use of the Wisconsin National Guard, fifty copies. To the superintendent of public property, who shall distribute the same to the county and city superintendents of the state, a sufficient number to supply each school district in his or her superintendent district with one copy, which copy shall become the property of the district thus supplied, and shall be kept in the schoolhouse to be used as a reference book, as dictionaries and other reference books are kept for the use of pupils in the public schools. The remainder shall be kept by the secretary of state, who shall deliver to the superintendent of public property at the commencement of each regular session of the legislature, one hundred and thirty-seven copies, to be by him distributed to the members of the legislature and to the chief clerks and sergeants-at-arms of each house at the opening of the session; the remainder to be kept for sale and exchange. One copy of such Blue Book for each justice of the supreme court, state officer and each member of the senate and assembly and the chief clerks thereof, and each senator and member of congress, newspaper reporter in regular attendance upon the legislature, assistant clerks. and assistant sergeants-at-arms, shall be bound in half morocco and be lettered with the name of the person entitled to receive The Blue Book delivered to the public li17,000 additional for 1895,

Expenses of preparing and publishing to be fixed by the secretary of

braries, to the county clerks and county superintendents of schools shall be for the use of all persons desiring to use the same; provided, that in the year 1895, only seventeen thousand copies shall be printed under the provisions of this act and that the distribution of Blue Books of 1895 already made under the law of 1893, shall constitute a part of the allotment as provided by this act. The expense for preparing and publishing such Blue Book, other than such as is covered by the contract with the state printer, shall be fixed by the secretary of state and paid out from the state treasury.

SECTION 2. All acts or parts of acts in any manner conflicting with any of the provisions

of this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 212.

AN ACT to amend section 3069, revised statutes, relating to appealable orders.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

What orders may be appealed to the supreme court.

SECTION 1. Section 3069, of the revised statutes, is hereby amended so that it shall read as follows, to-wit: Section 3069. The following orders, when made by the court, may be carried by appeal to the supreme court.

Affecting a substantial right.

1. An order affecting a substantial right, made in any action, when such order, in effect, determines the action and prevents a judgment, from which an appeal might be taken.
