CHAPTER 112.

AN ACT to amend section 8, of chapter 33, of the laws of 1893, entitled, An act to create and establish a superior court in and for Douglas county, Wisconsin, providing for terms of court and jurors.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Terms of holding court changed.

Section 8, of chapter 33, of the SECTION 1. laws of 1893, is hereby amended by striking out the words, "first Monday of January, the first Monday of May, the first Monday of August and the first Morday of November," where they occur in the second, third and fourth lines thereof, and inserting in lieu thereof the words, "first Tuesday in January, first Tuesday in April and the first Tuesday in September," and by striking out all the words in said section after the word "provided" in the fourteenth line thereof, and inserting in lieu thereof, the words, "It shall be the duty of the county board of supervisors of said Douglas county to select in the manner now provided by law, two hundred persons to serve as jurors in said court, and said county board of supervisors shall, in the same manner, select sixty persons to serve as petit jurors in said court for the year 1897, at their first meeting after the passage and publication of this act," so that said section when so amended, shall read as follows: Section 8. The terms of said superior court shall be held on the first Tuesday in January, first Tuesday in April, and the first Tuesday in September in each year. jury shall be summoned for the first day of each of said terms unless otherwise ordered by said Jurors shall be chosen before each term court. of said superior court, by the same persons, in the same manner, as jurors in the circuit court

Terms — when to be held. are now chosen, and all the provisions of law and rules of practice relating to the selection, qualifications, duties and compensation of jurors in the circuit court, shall be applicable in said superior court; provided, it shall be the duty of the county board of supervisors of said Douglas county to select in the manner now provided by law, two hundred persons to serve as jurors in said court, and said county board of supervisors shall, in the same manner, select sixty persons to serve as petit jurors in said court for the year 1897, at their first meeting after the passage and publication of this act.

SECTION 2. All acts or parts of acts in conflict with the provisions of this act, are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after July 1, 1897.
