upon the same belonging to said corporation, or shall unlawfully and maliciously place any obstruction or thing in the channel or way of such improvement or canal, such person or persons so offending shall, each of them, for every offense, forfeit and pay to such corporation the sum of twenty-five dollars, and in addition to such forfeit, such person or persons shall, each of them, for each and every such offense, forfeit and pay to such corporation, the amount of damages caused by such offense, which may be recovered in any court of competent jurisdiction.

Life imprisonment, when. SECTION 6. Any person who shall unlawfully and maliciously place any obstruction in the channel of any stream or canal, improved or constructed for navigation purposes, whereby the death of any person shall be caused, shall be punished by imprisonment in the state prison during life.

SECTION 7. This act shall take effect and be in force, from and after its passage and publication.

## CHAPTER 289.

AN ACT to amend section 1409g, of the Wisconsin statutes of 1898, relating to the sale of drugs etc. by unlicensed persons.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

"Usual domestic remedies" construed. SECTION 1. Section 1409g, of the Wisconsin statutes of 1898, is hereby amended by adding at the end of said section the following: "The term 'usual domestic remedies,' referred to in said sec-

tion, is hereby construed to include alum, ammonia, borax, bay rum, castor oil, camphor spirits, camphor gum, copperas, glycerine, epsom salts, glauber salts, rochelle salts, fennel seed, indigo, magnesia, potash, senna leaves, sulphur, vaseline, insect powder, resin, turpentine, and blue vitrol. Poisonous drugs or medicines, such as rough on rats, carbolic acid, aconite, laudanum, paregoric and spirits of nitre may be sold by general stores in sealed packages only; said package to be properly labeled by a registered pharmacist of Wisconsin. The label shall have the name of a registered pharmacist thereon, and the words 'Registered Pharmacist of Wisconsin, Certificate No. ——.' with the proper directions for the use thereof. The sale of these articles put up by wholesale druggists or manufacturers, not registered pharmacists of Wisconsin, is not legal under this act."

SECTION 2. This act shall take effect and be in force, from and after its passage and publication.

AN ACT to amend section 169b, of the Wisconsin statutes of 1898 relating to employment of additional help and workmen for the several departments.
