CHAPTER 202.

AN ACT to detach certain territory from the county of Forest and to attach the same to the county of Vilas and to create the town of Hackley.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Territory detached. SECTION 1. Townships No. 41 north of range 12 east and No. 42 north of range 12 east are hereby detached from the county of Forest and attached to and made a part of the county of Vilas.

Territory embraced in town of Hackley. SECTION 2. Township No. 41 north of ranges 11 and 12 east and township No. 42 north of ranges 11 and 12 cast are hereby created and constituted a separate town to be known and designated as the town of Hackley.

Apportionment of credits and indebtedness between town of Hiles and town of Hackley. SECTION 3. The credits and indebtedness shall be apportioned between the town of Hiles and the town of Hackley, taking into consideration only the territory hereby detached from said town of Hiles, according to the provisions of section 672 of the statutes of Wisconsin.

Apportionment of credits and indebtedness between town of Eagle River and town of Hackley. SECTION 4. The credits and assets and indebtedness shall be apportioned between the town of Eagle River and the town of Hackley so far as it applies to the territory hereby detached from said town of Eagle River according to the provisions of section 672 of the statutes of Wisconsin.

First town meeting. SECTION 5. Qualified electors of said town of Hackley shall meet at the school house in the village of Hackley on the third Tuesday of May, 1905, and at such town meeting in the manner provided by law, elect town officers for the said town of Hackley and transact such other business as electors of a town are authorized to transact at an annual meeting.

When town deemed duly organized. SECTION 6. Upon the election of such officers, the town of Hackley shall possess all the rights and privileges of towns under the statutes.

Assessment of property; schools. SECTION 7. All the property in said town of Hackley shall be assessed by the officers of said town and the personal property as of May first. The schools in said town shall be, until otherwise provided, under the township system and the first school officer shall be elected on said third Tuesday in May, 1905.

SECTION 8. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 203.

AN ACT relating to the payment of the cost and expense of street improvements in cities of the first class.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Improvements, how paid for when city unable to collect special assessment. SECTION 1. In cities of the first class as defined by section 926, subdivision 1 of the statutes of 1898, when a contract shall be entered into by said city for any street improvement, and the contractor shall agree to be paid by special assessments, and the improvement so contracted for shall be completed and accepted by the city, and said city shall, for any reason, be unable to collect said special assessment or any part of any said special assessment at the time when it would regularly collect the same, and be thereby unable to pay the cost of said improvement in the manner agreed, then said city shall pay the cost of said improvement to the said contractor or to the person entitled to receive the same out of the same fund and at the same time that it would be by law required to pay the ex-
