## CHAPTER 411.

AN ACT to amend section 1786e, statutes of 1898, relating to the organization of mutual co-operative corporations.

The people of the state of Wisconsin, represented in schate and assembly, do enact as follows:

SECTION 1. Section 1786e, statutes of 1898, is amended to read:

4. Such money shall be paid to the treasurer of the society, association, or board, upon his receipt, countersigned by the secretary.

5. • • • The amounts to be paid to any such organized agricultural society, association or board, during any year, shall not exceed the following amounts, to-wit:—to the state board of agricultural the sum of ten thousand dollars, to the northern Wisconsin state fair or the La Crosse inter-state fair association, the sum of five thousand dollars each, and to any county agricultural society or other association or board above mentioned, the sum of one thousand and seven hundred dollars each.

**Tobacco association: appropriation.** SECTION 1465. There is annually for two years appropriated to the Wisconsin Tobacco Growers' and Dealers' Association out of any money in the treasury not otherwise appropriated, the sum of three hundred dollars.

**Canada thistle extermination:** SECTION 1480t—1. The noxious weed known as Canada thistle (circium arvense) is hereby declared a public nuisance.

State thistle board created. SECTION 1480t—2. There is created the Wisconsin Canada thistle board to be composed of the hereinafter named officers. The said board shall provide blank forms for all reports herein required. The director of the agricultural experiment station shall be the head of said board and shall be the final authority in all matters brought before said board, and his decision shall be in all such matters final.

**County thistle commissioner.** SECTION 1480t—3. The county supervisor of assessments of each county shall, by virtue of his office, be county Canada thistle commissioner and his per diem, while so engaged shall be the same as received by him in his capacity as superintendent of assessments.
