

given in such nomination paper, and he shall post a copy of each sample ballot in a conspicuous place in his office.

* * * 5. On the tenth day before such primary the county clerk shall correct any errors or omissions in the ballot, cause the same to be printed and distributed as required by law in the case of ballots for the general election, except that the number of ballots to be furnished to each precinct shall be twice the number of votes cast thereat in the last preceding general election.

Section 11—12. 4. At all primaries there shall be an Australian ballot made up of the several party tickets herein provided for, all of which shall be securely fastened together at the top and folded, provided that there shall be as many separate tickets as there are parties entitled to participate in said primary election. The names of all candidates * * * *at the September primary shall be arranged as provided in sections 11—7 and 11—10 of the statutes as herein amended. The names of candidates at city primaries shall be arranged alphabetically according to surnames.*

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 465.

AN ACT to repeal sections 1, 4 and 5 of chapter 472, laws of 1907; to renumber sections 2, 3, and 6 of said chapter to be sections 1, 2, and 3, respectively, to amend subsection 5 of section 170, and section 579a of the statutes; relating to the salaries of the state superintendent of public instruction and his subordinates, and making an appropriation therefor.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Sections 1, 4 and 5 of chapter 472, laws of 1907, are hereby repealed, and sections 2, 3 and 6 of said chapter are renumbered to be sections 1, 2, and 3, respectively.

SECTION 2. Subsection 5 of section 170 of the statutes is amended to read: 5. The state superintendent, five thousand dollars.

The state superintendent shall be reimbursed the sum actually paid by him for his traveling expenses in making the official visits required by law.

The assistant state superintendent * * * *twenty-five* hundred dollars.

* * * The inspector of free high schools * * * *twenty-five* hundred dollars; the chief clerk * * * *twenty-two hundred fifty* dollars; the library clerk, * * * *eighteen* hundred dollars; * * * *three clerks and stenographers*, seven hundred * * * *twenty* dollars each; an index, * * * filing, *diploma, and certificate* clerk, * * * *twelve* hundred dollars; the mailing clerk, one thousand dollars. The inspector of free high schools shall be reimbursed his actual and necessary expenses incurred in the performance of his duty; and his salary and expenses shall be paid upon the certificate of the state superintendent, from the appropriation made for free high schools.

The assistant state superintendent, chief clerk, and library clerk shall be reimbursed the expenses actually incurred by them in the performance of their duties, when the accounts for such expenses are approved by the state superintendent.

The inspector of rural schools shall receive as an annual salary * * * *twenty-two hundred and fifty* dollars and shall be reimbursed for all actual and necessary traveling expenses when duly certified by the state superintendent. Such salary and expenses shall be paid out of the appropriation to the common school fund provided for in chapter 313 of the laws of 1903.

* * *

SECTION 2. Section 579a of the statutes is amended to read: Section 579a. 1. The state superintendent of public instruction may appoint a competent person who shall act under his direction as inspector of public schools for the deaf. When not engaged in the inspection of the schools for the deaf, said inspector may be assigned to such other duties as the state superintendent may determine and designate.

2. The inspector of *day schools for the deaf* shall receive an annual salary of * * * *eighteen* hundred dollars and reimbursements for all actual and necessary traveling expenses incurred, when duly certified by the state superintendent; provided that no more than five hundred dollars shall be allowed for expenses. The salary and expenses shall be paid in the same manner as the state officers are paid.

3. It shall be the duty of the treasurer of the school district board or of the board of education receiving the aid provided for in section 578 of the statutes * * * to render annually to the superintendent of public instruction an itemized statement of all expenditures of said school or schools. Any surplus

at the end of the year shall be reserved as a special fund for the deaf school and can be used for no other purpose.

4. It shall be the duty of the inspector to report annually to the superintendent of public instruction as to the condition and progress of the day schools and make such recommendations as he may deem proper for the improvement of the same.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 466.

AN ACT to amend that paragraph designated c of subsection 10 of section 170 of the statutes; to create two new paragraphs to be designated paragraphs f and g of subsection 10 of section 170 of the statutes, relating to employees in new heating plant and elsewhere.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. That paragraph designated paragraph c of subsection 10 of section 170 of the statutes, is amended to read: (Section 170, subsection 10) c. The other persons employed in the office of the superintendent of public property the sums following: The chief clerk, * * * *sixteen* hundred dollars; * * * the state carpenter, twelve hundred dollar;; two assistant state carpenters, nine hundred dollars each; * * * the painter, nine hundred dollars; the assistant painter, eight hundred and forty dollars; a receiving and shipping clerk, nine hundred dollars; eight policemen at eight hundred and forty dollars each, two night watchmen at eight hundred and forty dollars each; * * * *four* elevator operators, eight hundred and forty dollars each; * * * *seventeen* janitors at eight hundred and forty dollars each; the carpet man, eight hundred and forty dollars; the cuspidor cleaner, seven hundred and twenty dollars, fourteen regular laborers at seven hundred and twenty dollars each; five scrub women at one dollar and fifty cents per day for the time during which they are employed; * * *

SECTION 2. There are added to subsection 10 of section 170 of the statutes, two new paragraphs to read: (Section 170, subsection 10) f. For the maintenance and operation of the heat, light, power, and other mechanical equipment at the capitol, the following persons are to be employed by the state,
