## **CHAPTER 437.**

AN ACT to amend subsection 4, of section 36, of the statutes, relating to the publication of election notices.

The people of the State of Wisconsin, represented in Senale and Assembly, do enact as follows:

SECTION 1. Subsection 4, of section 36, of the statutes, is amended to read: (Section 36) 4. Such publication shall be made twice in daily or weekly newspapers in counties or cities having such, one of which publications in daily papers shall be on the day preceding the election and the other publication one week previously, and when published in a weekly paper the dates shall be designated by the county clerk; but if there be no daily or weekly newspaper published within the county or city, \* \* \* publication \* \* \* may be made in any daily or weekly newspaper having a general circulation in such county or eity.

## CHAPTER 438.

AN ACT to create section 288b of the statutes, relating to the cleansing and disinfecting of cuspidors and other materials and appliances used in the capitol building, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 288b. For the purpose of better safeguarding the health of the state employes and the general public who frequent the capitol building, the superintendent of public property shall provide and equip a room or rooms in the capitol building as a sterilizing chamber or chambers to be used for thoroughly cleansing and disinfecting cuspidors, substantially according to the Manning system as now established and used in the government printing office at Washington, District of Columbia, and for cleansing and disinfecting such other materia's and appliances used in the capitol building as may be required from time to time. There is appropriated out of any money in the state treasury, not otherwise appropriated, a sum sufficient to defray the expenses thereof, not exceeding the sum of one thousand dollars. All expenses under this section shall be audited upon proper vouchers duly certified by the superintendent of public property and paid out of the money herein appropriated.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 439.

- AN ACT to amend sections 1728p to 1728za, inclusive, of the statutes, relating to the work of children under sixteen years of age, in the sale or delivery of newspapers, magazines or periodicals, in the distribution of hand bills and circulars, and in street trades in cities of the first class.
- The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Sections 1728p to 1728za, inclusive, of the statutes, are amended to read: Section 1728p. The term "street trade," as used in this act, shall mean any business or occupation in which any street, alley, court, square or other public place is used for the sale, display or offering for sale of any articles, goods or merchandise. No boy under the age of \* \* twelve years, and no girl under the age of \* \* eighteen years, shall in any city of the first class distribute, sell or expose or offer for sale newspapers, magazines or periodicals in any street or public place.

Section 1728q. No boy under \* \* \* fourtcen years of age, shall, in any city of the first class, work at any time, or be employed or permitted to work at any time, as a bootblack or in any other street trade, or shall sell or offer any goods or merchandise for sale or distribute hand bills or circulars or any other articles, except newspapers, magazines or periodicals as hereinafter provided.

Section 1728r. No girl under **\* \*** *cighteen* years of age shall, in any city of the first class, work at any time, or be employed or permitted to work at any time, as a bootblack or at any other street trades or in the *sale* or distribution of hand bills or circulars or any other articles upon the street or from house to house.
