of the state at the next general primary the question of nomination of candidates unless it has been determined at a special primary called by the governor as herein provided.

## CHAPTER 614.

AN ACT to renumber and amend section 4959d of the statutes, relating to works of necessity or charity.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 4959d of the statutes is renumbered and amended to read: Section \* \* 4595d. The keeping open of a store or shop for the sale of dry goods, wearing apparel, hats, caps, boots, shoes, hardware, furniture, crockery, glassware, jewelry, \* \* coffees, teas or spices, \* \* on the first day of the week, shall not be deemed a work of necessity or charity.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 615.

AN ACT to amend section 1, of chapter 309, laws of 1895, as amended by chapter 436, laws of 1901, relating to the redistricting, readjusting and changing of the boundaries of wards in cities of the first class having special charters.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Section 1, of chapter 309, laws of 1895, is amended to read: Section 1. The common council of all cities of the first class, organized under special charter, may by a \* \* \* three-fifths vote of all its members within two years after each state or United States census is taken and the result thereof as to its population is made known, redistrict, readjust and change the boundaries of wards so that they shall be as nearly equal in population as may be, and to that end such council may create new wards and consolidate old ones, but no ward shall be created having a population less than \* \* ten thousand nor exceeding \* \* \* twenty-five thousand. In redistricting such

cities the original numbers of the wards and their geographical outlines shall as far as possible be retained, and the wards so created and those the boundaries of which are changed shall be in as compact form as possible.

Section 2. This act shall take effect and be in force from ad after its passage and publication.

## CHAPTER 616.

AN ACT to create sections 553p—1 to 553p—13, inclusive, of the statutes, relating to education in industrial, commercial, continuation and evening schools and the maintenance of the Stout institute, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. There are added to the statutes thirteen new sections to read: Section 553p—1. 1. There is hereby created a state board of industrial education to be appointed by the governor. The board shall consist of six appointive members, three of whom shall be employers of labor and three of whom shall be skilled employes. The state superintendent of education and the dean of the extension department and the dean of the college of engineering of the university of Wisconsin shall be exofficio members of this board.

- 2. Each appointive member shall hold office for two years and shall receive traveling expenses and one hundred dollars per year. In the first appointments the governor shall designate three members to serve for one year and three members to serve for two years from the first day of July of the year in which the appointments are made. All appointments thereafter shall be for two years except appointments to fill vacancies, which shall be for the unexpired portion of the term.
- 3. Said board: (1) Shall have control over all state aid given under this act; (2) Shall meet quarterly and at such other times as may be found necessary; (3) Shall report biennially.

Section 553p—2. 1. The state superintendent of education shall appoint an assistant in the department of public instruction to be known as the assistant for industrial education. He shall with the advice, consent and direction of the state superintendent of education have general supervision over the public industrial schools and over all public evening schools, continuation schools and commercial schools created under this act.
