CHAPTER 122.

AN ACT to amend section 20.87 of the statutes, relating to inventories and receipts from distributees in counties.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 20.87 of the statutes is amended to read: Section 20.87. The superintendent of public property, and the county clerk and county superintendent of schools of each county, shall make and file annually with the printing board an inventory of all public printing undistributed in his office on the first day of July. Each county clerk shall transmit with his inventory a list of the officers in his county, and each county superintendent shall transmit with his inventory a list of the school districts, other schools and institutions in his county, entitled to distributions of public printing from his office. County clerks * * * shall take receipts from all such distributees and transmit the same with their said inventories. The printing board shall furnish suitable blanks for such inventories and lists, and may, in its discretion, order the return to the superintendent of public property of any public printing that has remained undistributed for more than six months in the office of any county clerk or superintendent of schools.

CHAPTER 123.

AN ACT to amend subsection 2 of section 435d of the statutes, relating to the use of schoolhouses by nonpartisan gatherings of citizens.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 2 section 435d of the statutes is amended to read: (Section 435d) 2. Where the citizens of any

community are organized into a nonpartisan, nonsectarian, non-exclusive association for the presentation and discussion of public questions or for the promotion of public health by giving instruction in any topic relating thereto or in physical culture and hygiene or by the practicing of physical exercises and the presentation and discussion of topics relating thereto, the school board or other body having charge of the schoolhouses or other public properties which are capable of being used as meeting places for such organization, when not being used for their prime purpose, shall provide, free of charge, light, heat and janitor service, where necessary, and shall make such other provisions as may be necessary for the free and convenient use of such building or grounds, by such organization for weekly, bi-weekly or monthly gatherings at such times as the citizens' organization shall request or designate. *All such gatherings shall be free to the public.*

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 124.

AN ACT to authorize the commissioners of public lands to sell certain lands in Oneida county belonging to the state of Wisconsin.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The commissioners of public lands are hereby authorized, instructed, and directed to sell and convey to Theodore Dion of Oneida county, Wisconsin, at the price of one hundred dollars the following described land situated in Oneida county, Wisconsin, to wit: the southeast quarter of the northeast quarter, and the northeast quarter of the southeast quarter of section eleven, township thirty-seven north of range eight east.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
