CHAPTER 257.

AN ACT to create section 169s of the statutes, providing for coöperation between state officers and departments.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 169s. 1. Whenever any two or more commissions, commissioners or officers of the state may so determine by order, such commissions, commissioners or officers may coöperate in performing any specific work assigned to any one or more of such commissions, commissioners or officers and make such assignments of employees to such work as shall be found for the best interests of the public service.

2. Every such order shall be filed with the secretary of state and a report of all work done through such coöperation shall be filed at the end of each calendar year with the secretary of state.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 258.

AN ACT to amend subdivision (a) of section 4560a—16 of the statutes, relating to shipments of deer.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subdivision (a) of section 4560a—16 of the statutes is amended to read: (Section 4560a—16) (a) Any carcass or part of carcass of any deer between the third day of December and the succeeding twelfth day of November, provided, that the shipments of green hides or green heads of deer are not to be had in possession after January third or between January third

and November eleventh of any year; and provided further, that any person, firm or corporation may ship, carry or convey to a taxidermist within or without this state the green head of a deer when severed from the body, without having the required coupon attached to the same, upon the issuance of a permit so to do to any such person, firm or corporation by the state fish and game warden, or any of his deputies, and when such permit so issued shall be attached to such green head.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 259.

AN ACT to amend section 411—4 of the statutes, relating to the number of county training schools for teachers that may be organized.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 411—4 of the statutes is amended to read: Section 411—4. The state superintendent shall give such information and assistance as may seem necessary in organizing and maintaining such training schools. He shall prescribe the course of study to be pursued; shall have the general supervision of all schools established under * * * *this section*; shall from time to time inspect the same, make such recommendations relating to their management as he may deem necessary, and make such reports thereon as shall give full information concerning their number, character and efficiency; provided, that he shall not place upon the said list more than thirty-three schools.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
