### CHAPTER 267.

AN ACT to amend section 13, chapter 241, laws 1893, as amended by chapter 12, laws 1901, and chapter 266, laws 1911, relating to the salaries of the judges and clerk of the municipal court for Ashland county.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 13, chapter 241, laws 1893, as amended by chapter 12, laws 1901, and chapter 266, laws 1911, is amended to read: Section 13. The judge for his services in criminal matters shall receive, in addition to the compensation hereinbefore provided, a salary of \* \* \* *sixteen* hundred dollars per year to be paid monthly, *and the clerk the sum of nine hundred dollars per year, to be paid monthly*, as follows: One-half thereof shall be paid out of the treasury of Ashland county, and one-half out of the treasury of the city of Ashland.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

### CHAPTER 268.

AN ACT to amend subdivision (31) of section 925—52 of the statutes, relating to the powers of the common council of cities.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subdivision (31) of section 925—52 of the statutes is amended to read: (Section 925—52) (31) To establish and alter the grade of streets and sidewalks; regulate the manner of using the streets and pavements; protect the same from injury by vehicles used thereon; require standard sidewalks *and curbs* to be laid upon such street or streets or part thereof as it may prescribe; declare any sidewalk *and curbs* or part thereof unsafe, defective or insufficient, and that the same be removed

and replaced with a new standard sidewalk *or curb* or one as good as standard, to be approved by the board of public works, at the expense of the owner or owners of the lots or parcels of land abutting upon that portion of the street or streets upon which said sidewalk *or curb* is ordered to be built or removed, and cause the expense thereof incurred by the city in front of each said abutting lot or parcel of land to be charged to such lot or parcel of land as a special tax and collected like other city taxes upon real estate; all proceedings as to the construction of sidewalks *and curbs* and the collection of the cost thereof to conform to the provisions of sections 925—201 to 925—207, inclusive; and to establish districts in cities of the first, second and third classes and in all cities of the fourth class having a population, according to the last state or federal census, of five thousand inhabitants or over, within which all electric light or power, telephone, telegraph or other wires may in the same ordinance establishing such districts be ordered to be placed under ground and all poles now or hereafter used to support such wires shall be removed from the streets in such districts, and to provide a penalty for the violation of the provisions of such ordinance.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 269.

AN ACT to compensate Frank B. Dorohy for services performed for the state of Wisconsin in the year 1909, and making an appropriation.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. There is appropriated to Frank B. Dorohy of St. Croix Falls, Wisconsin, out of any funds in the state treasury not otherwise appropriated, the sum of seventy-five dollars in full for services rendered in the year 1909 to the state of Wisconsin, at the request of the state fish and game warden.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
