CHAPTER 48.

AN ACT to create section 579p, relating to the training of oral teachers of the deaf, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

- Section 1. There is added to the statutes a new section to read: Section 579p. 1. The board of regents of normal schools is hereby authorized and directed to establish and maintain a department in one of the normal schools of the state, located in a city maintaining a graded school for the deaf, to be known as a normal training department for oral teachers of the deaf.
- 2. Candidates for admission to this course shall have completed at least one year of the advanced course in a state normal school or its equivalent. Graduates from said course shall be granted a diploma by the board of regents that will serve as a basis for an unlimited state certificate, qualifying the holder to teach in any day school for the deaf in this state, or in any public hearing school of the state, below high school grade.
- 3. An annual appropriation of five thousand dollars, or such part of five thousand dollars as shall be necessary to carry on this work, shall be made from the general funds of the state for the purpose of maintaining this department; said appropriation to be disbursed under the direction of the board of regents of normal schools.

CHAPTER 49.

AN ACT to amend section 1, and to create section 3a of Chapter 474, laws of 1911, relating to a conveyance of state lands to John Henry Sykes.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Section 1. Chapter 474, laws of 1911, is amended to read: (Chapter 474, laws of 1911) Section 1. The commis-

sioners of fisheries are authorized and directed to enter into an agreement by which the state of Wisconsin may convey to John Henry Sykes the following described real estate located in Bayfield county, to wit: Commencing at the corner of sections 21 and 22, 27 and 28, township fifty north, range four west; thence running south on section line to the highway known as the "St. Paul Road;" thence southwesterly along the northerly side of the said St. Paul road to a point one hundred sixty-five feet west of the east line of section 28; thence north parallel with the east lines of sections 28 and 21 to a point six hundred sixty feet north of the corner of sections 21, 22, 27 and 28, township fifty north. range four west, and one hundred sixty-five feet west of the east line of section 21; thence running north 7° 2' east, a distance of two hundred forty-six and one-half feet to the corner of the state fish hatchery fence surrounding the birch run dam: thence running east one hundred thirty-four and one-half feet to the east line of said section 21; thence south along section line to the corner of sections 21, 22, 27 and 28, township fifty north, range four west, the place of beginning, excepting only a three rod strip for proposed pipe line. Such real estate may be conveyed in exchange for the conveyance by John Henry Sykes and any other parties who may be interested therein of the following described real estate in Bayfield county, to wit:

Commencing at a point evidenced by stake at time of survey, from thence running south 34° 30′ east 304 feet. from thence running south 50° 55′ east 367 feet. from thence running south 32° 30′ east 281 feet. from thence running south 9° 5′ east 167.7 feet. from thence running south 25° 16′ west 935 feet.

from thence running south 31° 52' west 107 feet.

to the flushing box in the hatch room of the Salmo state fish hatchery, the above being the actual distances and directions for the pipe and the limits of the three-rod strip, being ten feet west and thirty-nine and one-half feet east of the above described pipe line. The pipe to cross the section line between sections 21 and 22 at a point five hundred ninety-three feet north of the corner of sections 21, 22, 27 and 28, township fifty north, of range four west, and crossing the section line between sections 22 and 27, township fifty north, range four west, at a point two hundred fifty-three feet east of the said corner of sections 21, 22, 27 and 28, township fifty north, range four west. John Henry Sykes to reserve only the right for a road crossing three rods wide at a point where a line bearing north 20° east from the corner of sections 21, 22, 27 and 28 intersects said proposed pipe line. Magnetic variations in all cases being 4° east.

SECTION 2. There is added to Chapter 474, laws of 1911, a new section to read: (Chapter 474, laws of 1911) 3a. The contract and conveyances for the transfer and exchange of the land described in section 1, Chapter 474, laws of 1911, as amended by section 1 of this act, are hereby ratified and confirmed.

CHAPTER 50.

AN ACT to authorize the conveyance by the state to the town of Bayfield, of a right of way across the state hatchery land in Bayfield county.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. The commissioners of fisheries are authorized and directed to enter into an agreement by which the state of Wisconsin may convey to the town of Bayfield, Bayfield county, a right of way for the purposes of a road across state hatchery land in said Bayfield county, described as follows, to wit: From the corner of sections sixteen, seventeen, twenty and twenty-one, township fifty north, range four west of fourth principal meridian; thence south two degrees west twenty-seven and four-tenths feet to station 51+36; thence south twenty-five degrees nine minutes east one hundred and forty-one feet to station 49+95 at or near the western limits of property owned by the state of Wisconsin in the northwest quarter of the northwest quarter of section twenty-one, township fifty north, range four west as a point of beginning.

From this point of beginning (station 49+95) thence south seventy-three degrees and seventeen minutes east two hundred forty-six and six-tenths feet to station 47+48.4

Thence north sixty degrees east six hundred and sixty-three feet to station 40+86.4 in the southwest quarter of the southwest quarter of section sixteen, township fifty north, range four west.

Thence north thirty-one degrees and forty minutes east five hundred twenty-three and six-tenths feet to station 35 + 61.8.

Thence south sixty-five degrees and thirteen minutes east three hundred eighty-four and four-tenths feet to station 31+77.4 at or near the eastern limits of land owned by the state of Wiscon-
