CHAPTER 600.

AN ACT to amend subsections 1 and 3 and to repeal subsection 2 of section 172—10 of the statutes, reverting an unexpended balance and making and repealing appropriations for the secretary of state.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsections 1 and 3 of section 172—10 of the statutes are amended to read: (Section 172—10.) 1. There is * * * annually appropriated beginning July 1, * * * 1915 forty-six thousand six hundred dollars, payable from any moneys in the general fund not otherwise appropriated, for the secretary of state to carry into effect the powers, duties and functions provided by law for said secretary other than administering sections * * * 1636—47 to 1636—56, inclusive.

3. There is * * * appropriated * * * on July 1, * * * 1915, * * * forty thousand * * * dollars, and on July 1, 1916, sixty thousand dollars, payable from any moneys in the general fund not otherwise appropriated, for the secretary of state to cover the expense of administering sections 1636—47 to 1636—56, inclusive.

SECTION 2. Subsection 2 of section 172—10 of the statutes is repealed.

SECTION 3. The balance of the appropriation heretofore provided in subsection 1 of section 172—10 which remains unexpended on July 1, 1915, shall revert to the general fund.

SECTION 4. This act shall take effect as of July 1, 1915.

CHAPTER 601.

AN ACT to repeal subsections 1, 2 and 4 and to create subsections 1, 2 and 4 of section 172—65 and to create section 172—133 of the statutes, making appropriations for the Wisconsin industrial school for girls and relating to financial control of semi-public bodies.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsections 1, 2 and 4 of section 172—65 of the statutes are repealed.

SECTION 2. There are added to the statutes three new subsections and a new section to be numbered and to read: (Sec-

tion 172—65.) 1. There is annually appropriated beginning July 1, 1915, nine thousand and fifty dollars, payable from any moneys in the general fund not otherwise appropriated, for the operation of the Wisconsin industrial school for girls.

2. There is appropriated on July 1, 1915, five thousand three hundred fifty dollars and on July 1, 1916, five thousand three hundred fifty dollars, payable from any moneys in the general fund not otherwise appropriated, for property repairs and maintenance at the Wisconsin industrial school for girls.

4. There is appropriated on July 1, 1915, two thousand seven hundred dollars, payable from any moneys in the general fund not otherwise appropriated, for safety devices for fire protection and for other permanent improvements at the Wisconsin industrial school for girls.

Section 172—133. All appropriations made by law from state revenues for either the Wisconsin state horticultural society, the Wisconsin live stock breeders' association, or the industrial school for girls are made on the express conditions that such society, association or school, as the case may be, pays all moneys received by it into the state treasury within one week of receipt and conforms with the provisions of sections 145 and 172—130 of the statutes, both as to appropriations of its own receipts and as to appropriations made by the state from state revenues. Upon failure to comply with the above conditions, the secretary of state shall refuse to draw his warrant and the state treasurer shall refuse to pay any moneys appropriated to said society, association or school, as the case may be, from state revenues until compliance is made with said conditions and upon failure or refusal to so comply, after due notice received from the secretary of state, any appropriation made by law from state revenues to such society, association or school, as the case may be, shall permanently revert to the fund from which appropriated.

SECTION 3. The balance of the appropriation heretofore provided in subsection 1 of section 172—65 which remains unexpended at the close of business on June 30, 1915, is reappropriated for the operation of the Wisconsin industrial school for girls and this appropriation shall be available for payment of indebtedness incurred prior to June 30, 1915.

SECTION 4. This act shall take effect as of July 1, 1915.
