JOINT RESOLUTION NO. 6.

Relating to the introduction of bills "by request."

Resolved by the Assembly, the Senate concurring, That whenever a bill is introduced by any member "by request" that the name of the person, firm or corporation requesting the introduction of the bill shall appear on the envelope containing such bill, and shall be made a part of the record of such bill.

JOINT RESOLUTION NO. 7.

To create a joint committee of the legislature to investigate and examine into the purchases and sales of lands for or by the University of Wisconsin.

Resolved by the Assembly, the Senate concurring, That a joint committee of the legislature be and is hereby created to investigate and examine into the purchases and sales or options or contracts for the purchase or sale of lands for or by the University of Wisconsin. Such committee shall consist of five members, two from the senate and three from the assembly, to be appointed in the manner that standing committees are appointed; be it further

Resolved, That the said committee, by a majority vote of the members thereof, is hereby invested with plenary power to perform and discharge the duties by this resolution enjoined. Any member of the said committee shall have power to administer oaths to persons appearing before such committee and the committee may have the services of any of the legislative stenographic force for taking down and transcribing testimony; be it further

Resolved, That said committee and each member thereof shall have full power to examine all books, records, papers, files and documents on file at the University of Wisconsin or elsewhere pertinent or pertaining to the purchase and sales or options or contracts for the purchase or sale of lands for or by the University, and the committee, by a majority vote, shall have power to compel the production thereof and to subpoena and examine witnesses regarding any matters included in this resolution; be it further

Resolved, That said committee may require the services of any competent civil engineer or engineers, now in the employ of the state, either of any department or of any institution, to assist said committee in its investigation and upon the request of such committee, such state department or institution shall assign to this work such civil engineer or engineers as the committee may request; be it further

Resolved, That said committee report to the legislature the result of its investigation and examination, together with such testimony as may be taken by the committee, and make such recommendations as the members of the committee deem advisable and proper in the premises.

JOINT RESOLUTION NO. 8.

Relating to the death of Captain Alexander A. Arnold.

WHEREAS, Captain Alexander A. Arnold, a former member of the legislature and a pioneer citizen of this state, died at Galesville, Wisconsin, Monday morning, March 1st, and

WHEREAS, Captain Arnold gave freely of his time and energy to public life and service; he enlisted in company C of the Thirtieth Wisconsin Volunteer Infantry, in August, 1862, of which company he was chosen captain and was so commissioned by Governor Lewis and served his state until the close of the Civil war; he was elected to the assembly in 1870 and again in 1880 when he was chosen speaker of that house, and he served his district in the state senate from 1878 to 1880, and

WHEREAS, Captain Arnold served the state of Wisconsin honorably and efficiently and was a prominent and leading factor in the upbuilding of his community and state, now therefore be it

Resolved, by the Senate, the Assembly concurring, That as evidence of respect and in recognition of the important public services of Captain Arnold this memorial be entered in the journals of both houses and that a suitably engrossed copy of the same, properly attested by the presiding officers, be forwarded to the members of Captain Arnold's family.
