this state for the insurance of property against loss or damage may also insure the same classes of property, by fire • • subject to the limitations prescribed by the law under which it was organized or is governed as to the amount of any single risk, against loss or damage by lightning, hail, windstorms, tornadoes, cyclones, hurricanes, earthquake, bombardment, invasion, insurrection, riot, civil war, military or usurped power. leakage of sprinklers and sprinkler systems, installed or maintained for the purpose of protection against fire and by explosions, whether fire ensues or not, including insurance upon automobiles and vehicles and the accessories and other property transported upon and used in connection therewith against loss by collision and against loss by legal liability for damage to property resulting from the maintenance and use of such automobiles or vehicles and against loss by burglary or theft or both and against any risk mentioned in subsections 1, 2, 5 or 10 of section 1897 which said company may assume under its license; provided the same shall be clearly expressed in the policy, but nothing herein shall be construed to empower such companies to insure against loss or damage to persons or property resulting from explosions of steam boilers.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 445

AN ACT to appropriate a sum of money named therein to Chris Dyrud of Baraboo, Wisconsin, due him on tax certificates issued on certain state lands.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to Chris Dyrud of Baraboo, Wisconsin, the sum of twenty-one dollars and forty-two cents, the said amount being due him on tax certificates numbered 25, 26 and 27 for the year 1911. Sauk county, which said certificates were issued on certain lands now a part of Devils Lake state park and owned by the state. Said payment shall be made upon the filing with the secretary of state of a certificate of the county treasurer of Sauk county, Wisconsin, that said original tax certificates have been duly surrendered and cancelled. SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 447

AN ACT to repeal subsection (2) of section 20.22, and subsection (4) of section 20.37 of the statutes; to amend subsection (1) of section 20.37, and sections 20.38 and 401m of the statutes; and to create two new subsections of section 20.38 of the statutes; relating to the state board of education, and making appropriations.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (2) of section 20.22, and subsection (4) of section 20.37 of the statutes, are repealed.

SECTION 2. Section 20.38 of the statutes is amended to read: 20.38. There is appropriated from the normal school fund income to the state board of education:

(1) For the board of normal regents, on July 1, 1917, nineteen thousand dollars, and annually, beginning July 1, * * * 1918, twenty-four thousand dollars, for the execution of the functions of said board. Of this there is allotted:

(a) To each member of said board such compensation as may be fixed by the board for rendering any specific service under the direction of the board; but they shall receive no compensation for time spent in going to, attending, or returning from the meetings of the board.
