Further resolved, That a copy of these resolutions, signed by the President of the Senate and the Speaker of the Assembly, be transmitted to the President of the United States.

## [No. 80, S.] JOINT RESOLUTION NO. 35.

Relative to the Wisconsin National Guard.

WHEREAS, The Wisconsin National Guard having responded to the call of the President of the United States for duty on the Mexican border, and

WHEREAS, The Wisconsin legislature by joint resolution did publicly thank the soldiers of the Wisconsin National Guard for the manner in which this duty was performed, therefore, be it

Resolved by the Senate, the Assembly concurring, That the Adjutant General be required and directed to procure suitable badges, of such design to be in commemoration of the service, in harmony with like badges heretofore issued for like purposes; to be issued to all the officers and enlisted men who were mustered into the service of the United States for this service, and who were not discharged at the State mobilization camp on account of physical disqualifications, or who were not dishonorably discharged while at the border by sentence of a general court-martial; the badges to be part of the uniform of the Wisconsin National Guard and to be worn like similar badges provided by the United States War Department and under the same general regulations, and be it

Further Resolved, That this resolution be entered in the journals of the two houses and that a copy thereof, suitably engrossed and duly signed by the Governor of the State and by the presiding officers of the two houses and duly attested by the chief clerks thereof, be duly forwarded to the Adjutant General as his direction to act.

## [No. 98, S.] JOINT RESOLUTION NO. 36.

Accepting the resignation of the board of managers of the Wisconsin industrial school for girls, and extending to the members of said board the thanks of the people of the state of Wisconsin.

Withheas. The industrial school for girls located in the city of Milwaukee has for the past forty years been in charge of a band of women serving gratuitously and known as the board of managers of the Wisconsin industrial school for girls; and Withheas. This board has tendered its resignation to the gov-

ernor, and through the governor to the people of the state of Wisconsin, after these many years of service and of unselfish devotion to the interests of the girls who have been committed to that institution; now therefore, be it

Resolved by the Senate, the Assembly concurring, That this legislature, for and on behalf of the people of the state of Wisconsin, accepts the resignation tendered by the board of managers of the Wisconsin industrial school for girls, and, for and on behalf of the people of the state, tender a vote of thanks and convey expressions of appreciation and gratitude to that board and to each of the members thereof for the benefits conferred and the noble ends accomplished. Be it further

Resolved, That a copy of these resolutions appropriately engrossed and attested by the presiding officers of the two houses of this legislature be transmitted to the appropriate officer of the board of managers for the industrial school for girls.

## [No. 9, A.] RESOLUTION NO. 1.

Whereas, On the 25th day of September, 1916, the Great Master, in His infinite wisdom, saw fit to summon to eternal rest Honorable Charles Rudolph Zorn, who died at his home in the town of Schleswig on that day, having been born August 4, 1844, in Pommern, Germany, from whence he came with his parents to the town of Schleswig in 1854.

"Life is a narrow vale between the cold and barren peaks of two eternities. We strive in vain to look beyond the heights. We cry aloud and the only answer is the echo of our wailing cry. From the voiceless lips of the unreplying dead there comes no word, but in the night of death, hope sees a star and listening love can hear the rustle of a wing."

Whereas, Mr. Zorn was for many years prominent in the public life of Manitowoc county and this state, having been a member of the county board of supervisors of Manitowoc county for seventeen years, representing the town of Schleswig, a member of the Wisconsin state legislature as assemblyman from the second district of Manitowoc county during the years 1873, 1874 and 1876, and having held various other positions of public and private trust during a long and useful life, and

WHEREAS, He discharged the many duties of the various offices held by him during his lifetime with ability, fearlessness, faithfulness and integrity, proving himself, both as a private citizen and a public servant, worthy of the enduring remembrance of his fellowmen, and a man of sterling character and
