

have been used to enforce support and none has been obtained, or such mother must be divorced from her husband and must show that she has used all provisions of law to compel her former husband to support her and has not been able to do so. Such deserted or divorced woman need not show that she has used all provisions of law to enforce support, if the court shall be of the opinion that such procedure on her part would be of no avail; the mother or grandparents or person having the care and custody of such children must be a fit and proper person to have the custody and care of the dependent children and the period of aid must be likely to continue longer than one year. The ownership by a mother of a homestead shall not prevent the granting of aid under the provisions of this section if the rental thereof would not exceed the rental which a family of the same size as the family of such parent, receiving aid, would be obliged to pay for living quarters.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 252.

AN ACT to repeal paragraphs (c) of subsection (5), (d) of subsection (6), subsection (14), paragraph (c) of subsection (15), paragraph (b) of subsection (17), and subsections (c), (d), (h), and (i) of subsection (18) of section 20.17 of the statutes; to amend paragraphs (a) and (b) of subsection (2), paragraphs (a), (b) and (c) of subsection (3), paragraphs (a), (b), (c), and (d) of subsection (4), paragraphs (a), (b), and (d) of subsection (5), paragraphs (a), (b) and (f) of subsection (6), paragraph (c) of subsection (7), paragraphs (a), (b), and (c) of subsection (8), paragraphs (a), (b) and (c) of subsection (9), paragraphs (a), (b) and (c) of subsection (10), paragraph (a) of subsection (11), paragraphs (a), (b) and (d) of subsection (12), paragraphs (a), (b), (d) and (e) of subsection (15), paragraphs (a), (b), (c) and (d) of subsection (16), paragraph (a) of subsection (17), paragraphs (a), (b), (e) and (f) of subsection (18), subsections (23), (24) and (27) of section 20.17 of the statutes; and to renumber section 20.18 of the statutes; and to create paragraph (bf) of subsection (2), paragraph (bf) of subsection (3), paragraph (c) of subsection (5), paragraph (bf) of subsection (6), paragraphs (bc) and (bf) of subsection

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (c) of subsection (5), paragraph (d) of subsection (6), subsection (14), paragraph (c) of subsection (15), paragraph (b) of subsection (17), paragraphs (c), (d), (h) and (i) of subsection (18) of section 20.17 of the statutes are repealed.

SECTION 2. On July 1, 1919, the unexpended balance in the appropriation heretofore made by paragraph (a) of subsection (17) of section 20.17 of the statutes, shall revert to the general fund.

seven thousand dollars, and on July 1, 1920, seven thousand dollars, for property repairs and maintenance.

(3). (a) * * * *Annually, an amount sufficient to cover the cost of insurance, and annually, beginning July 1, * * * 1919, one hundred * * * sixty-two thousand * * * dollars, for operation; of which appropriation in each year, eighteen thousand dollars is allotted for the purchase of coal, and forty-five thousand dollars for the purchase of provisions.*

(b) On July 1, * * * 1919, * * * twelve thousand * * * dollars, and on July 1, * * * 1920, * * * twelve thousand * * * dollars, for property repairs and maintenance.

(b) On July 1, * * * 1919, one thousand * * * two hundred * * * dollars, and on July 1, * * * 1920, one thousand * * * two hundred * * * dollars, for property repairs and maintenance.

(c) On July 1, 1915, twenty-three thousand eight hundred fifty dollars, and on July 1, 1916, one thousand three hundred dollars, * * * and on July 1, 1918, three thousand six hundred dollars, for permanent property and improvements.

(5) *Annually, an amount sufficient to cover the cost of insurance, and annually, beginning July 1, * * * 1919, * * * seventy-one thousand * * * eight hundred ninety-five dollars, for operation; of which appropriation in each year, seven thousand dollars is allotted for the purchase of coal, and twelve thousand dollars for the purchase of provisions.*

(b) On July 1, * * * 1919, * * * six thousand * * * dollars, and on July 1, * * * 1920, * * * six thousand * * * dollars, for property repairs and maintenance.

(d) * * * On July 1, 1918, one thousand one hundred fifty dollars, for permanent property and improvements.

(6) (a) *Annually, an amount sufficient to cover the cost of insurance, and annually, beginning July 1, * * * 1919,*

* * * *sixty-four thousand * * * two hundred * * * seventy-five* dollars, for operation; of which appropriation in each year, seven thousand dollars allotted for the purchase of coal, and nine thousand five hundred dollars, for the purchase of provisions.

(b) On July 1, * * * 1919, seven thousand five hundred dollars, and on July 1, * * * 1920, * * * seven thousand * * * dollars, for property repairs and maintenance.

(f) On * * * July 1, 1918, two thousand dollars, for the construction of a root cellar.

(7) (c) On July 1, * * * 1919, * * * five thousand dollars together with any materials then in stock, pursuant to the provisions of this subsection, * * * to be invested in materials, * * * payment of artisans, and for expenses incident to manufacture and sale of * * * *basketry and willow ware*; and whenever any such materials, or the articles manufactured therefrom, are sold, the proceeds thereof shall be paid into the general fund within one week of receipt, and credited back to this appropriation. On July 1, * * * 1919, the superintendent may withdraw from this appropriation not to exceed five hundred dollars, for his contingent expenses.

The superintendent may withdraw from this appropriation not to exceed three hundred dollars for his contingent expenses.

(b) On July 1, * * * 1919, * * * twelve thousand * * * five hundred * * * dollars, and on July 1, * * * 1920, * * * twelve thousand * * * five hundred * * * dollars, for property repairs and maintenance.

(c) On * * * July 1, 1916, one thousand seven hundred dollars, * * * on July 1, 1919, one thousand two hundred fifty dollars, and on July 1, 1920, one thousand two hundred fifty dollars, for permanent property and improvements.

(11) (a) Annually, an amount sufficient to cover the cost of insurance, and annually, beginning July 1, * * * 1919, * * * forty thousand dollars, for operation. The superintendent may withdraw from this appropriation not to exceed five hundred dollars, for his contingent expenses.

(12) (a) * * * Annually, an amount sufficient to cover the cost of insurance, and annually, beginning July 1, * * * 1919, * * * sixty-six thousand * * * five hundred * * * fifteen dollars, for operation; of which appropriation in each year, eight thousand five hundred dollars is allotted for the purchase of coal, and nine thousand dollars, for the purchase of provisions. Provided that the care and treatment of indigent children who have resided within the state not less than one year, and who are crippled, deformed or suffering from

disease through which they are likely to become crippled or deformed, shall be a charge against this appropriation.

(b) On July 1, * * * 1919, * * * *three thousand five hundred dollars*, and on July 1, * * * 1920, * * * *three thousand five hundred dollars*, for property repairs and maintenance.

(d) On July 1, * * * 1919, * * * nine hundred * * * dollars, and on July 1, * * * 1920 * * * eight hundred * * * dollars, for permanent property and improvements.

(17) (a) * * * *Annually, beginning July 1, * * * 1919, * * * twenty-two thousand five hundred dollars, for operation. The superintendent may withdraw from this appropriation not to exceed five hundred dollars, for his contingent expenses.*

(18) (a) *Annually, an amount sufficient to cover the cost of insurance, and annually, beginning July 1, * * * 1919, * * * two hundred * * * fourteen thousand * * * five hundred * * * twenty dollars, for operation; of which appropriation in each year thirty-seven thousand dollars is allotted for the purchase of coal, and thirty-seven thousand sixty dollars, for the purchase of provisions.*

(b) On July 1, * * * 1919, * * * fifteen thousand * * * dollars, and on July 1, * * * 1920, * * * fifteen thousand * * * dollars, for property repairs and maintenance.

(e) On July 1, 1917, twenty-nine thousand seven hundred dollars, and on July 1, 1918, fifteen thousand one hundred dollars, for permanent property and improvements. Of the amount appropriated on July 1, 1917: * * * four thousand dollars shall be available only for yard lighting; four hundred dollars shall be available only for a greenhouse; and twenty thousand one hundred dollars shall be available only for machinery, equipment and permanent improvements for the power plant; and of the amount appropriated on July 1, 1918, thirteen thousand dollars shall be available only for machinery, equipment and permanent improvements for the power plant.
