CHAPTER 618.

AN ACT to create subsection (6) of section 59.08 of the statutes, relating to powers of county boards to grant additional compensation to judges of juvenile courts.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new subsection is added to the statutes to read: (59.08) (6) The county board may appropriate annually for the benefit of, and pay over to any judge of a juvenile court, appointed or designated in pursuance of the provisions of subsection (1) of section 48.01, a sum of money as compensation for the additional services rendered by such juvenile judge.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 619.

AN ACT to amend subsection (2) of section 42.12 and to create subsection (5) of section 42.11 and subsection (6) of section 42.12 of the statutes, relating to the teacher's insurance and retirement fund.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (2) of section 42.12 of the statutes is amended to read: (42.12) (2) The board of trustees may ratably reduce the annuities provided in this chapter whenever, in the judgment of the board, the condition of the fund shall require such reduction; *provided, however, that beginning with the quarterly payment due September 30, 1919, said board shall reduce the payments to annuitants fifteen per cent, to and including the quarterly payment due June 30, 1921.*

SECTION 2. A new subsection is added to section 42.11 and a new subsection is added to section 42.12 of the statutes to read:

(42.11) (5) Until the first day of July, 1921, the operation of section 42.11 is suspended, and during said period no teacher shall be entitled to the rights, benefits and privileges therein conferred; provided, however, that said section shall not be deemed suspended as to any teacher who may have made application in accordance with the provisions of subsection (4) thereof on or before July 1, 1919, or any teacher who may have previously entered upon the annuity and who has returned to teaching, or any teacher who may retire under the provisions of subsection (2) of this section.

(42.12) (6) If any teacher employed in said public schools, and who has not received any benefit or annuity from the fund, shall die, the legal representative of such teacher shall be entitled to receive the entire amount of assessments, without interest, paid into the fund by such teacher, or withheld from the salary of such teacher for the fund, upon application in writing to the board of trustees by said representative.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 620.

AN ACT to amend subsection (3) of section 41.035 of the statutes, relating to special classes for exceptional pupils and making an appropriation therefor.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 3 of section 41.035 of the statutes is amended to read: (41.035) (3) The state superintendent of public instruction shall appoint in his department a person of suitable training and experience who shall have general supervision of such classes and who shall give special attention to examining, testing and classifying the pupils applying for admission to such special classes and perform such other duties as the state superintendent may direct. Such supervisor shall be exempt from the provisions of sections 16.01 to 16.29, inclusive, of the statutes
