JOINT RESOLUTION NO. 64.

Ratifying an amendment to the constitution of the United States, relating to woman's suffrage.

WHEREAS, Both houses of the Sixty-sixth congress of the United States of America at its first session by constitutional majority of two-thirds thereof, made the following proposition to amend the constitution of the United States of America in the following words, to wit: "Joint resolution (H. J. Res. 1) proposing an amendment to the constitution extending the right of suffrage to women.
