For recording any mark or brand, twelve cents.

For giving a certificate thereof, the same.

For making copies of any records or papers, when required, seven cents for each folio and twelve cents for a certificate.

122.10 The filing officer shall mark upon the contract or copy filed with him the day and hour of filing and shall file the contract or copy in his office for public inspection. He shall keep a separate book in which he shall enter the names of the seller and buyer, the date of the contract, the day and hour of filing, a brief description of the goods, the price named in the contract and the date of cancellation thereof; except that in entering the contracts mentioned in section 122.08 the secretary of state shall record either the sum remaining to be paid upon the contract or the price of the goods. Such books shall be indexed under the names of both seller and buyer. For filing and entering such contract or copy the filing officer shall be entitled to a fee of twenty-five cents, except that in cities of the first class the filing officer shall be entitled to a fee of thirty-five cents and except that for filing and entering a contract described in section 122.08 the secretary of state shall be entitled to a fee of one dollar.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 116.

AN ACT to create paragraph (g) of subsection (10) of section 352.03 (4601-4a) of the statutes, relating to custard (New York) ice cream.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact os follows:

SECTION 1. A new paragraph is added to subsection (10) of section 352.03 (4601-4a) of the statutes to read: (352.03) (4601-4a) (10) (g) Custard ice cream (New York ice cream) is a frozen product made from cream, or milk and cream, sugar, eggs or egg powder or egg yolk; and may contain added milk

solids, added milk fat, a natural flavoring, edible gelatin or harmless gum, harmless color, and shall contain not less than twelve per cent of milk fat and five egg yolks or their equivalent in egg powder or egg yolk powder in each gallon, nor more than one-half of one per cent of said gelatin or gum, or a mixture of said gelatin or gum. The volume of custard ice cream (New York ice cream) after being melted shall be not less than one-half the volume of the custard ice cream (New York ice cream).

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 117.

AN ACT to amend section 130.01 of the statutes, relating to auctions.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 130.01 of the statutes is amended to read : There shall be paid by the auctioneer to the town treas-130.01 urer, for the use of the town, upon all sales by auction made in any town and outside of a city or village of goods, wares and merchandise, except household furniture which has been used as such, twenty per centum out of the gross receipts accruing from such sales, except when sale is made by virtue of a chattel mortgage, or of a rule, order or judgment of a court, or of some law of the state or the United States respecting the collection of some tax or duty; or in consequence of a general assignment of property or effects for the benefit of creditors; or when made of property belonging to the state or of the United States; or when made by or on behalf of any executor or administrator; or when made of his farm property by or on behalf of a resident farmer who has paid the taxes lawfully levied on his property; or when made for the purpose of closing up his business by or on behalf of any merchant who shall reside and trade in any town, city or village and who shall have paid the taxes lawfully levied on his stock in provided, that in the trade: * last case ŧ such sale shall be made in the town, city or village in
