AN ACT to amend subsection (3) of section 45.07 of the statutes, relating to maintenance of war veterans at Wisconsin veterans' home.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection (3) of section 45.07 of the statutes is amended to read: (45.07) (3) Applications for entrance into and maintenance at the Wisconsin veterans' home shall be considered and passed upon in the following order: Civil war veterans; the mothers, wives and widows of civil war veterans; civil war nurses, veterans of the Spanish-American war, Philippine insurrection and China relief expedition; and the mothers, wives and widows of veterans of the Spanish-American war, Philippine insurrection and China relief expedition.

CHAPTER 38.

AN ACT to amend subsection (1) of section 20.73 and section 16.09; and to create a new subsection of section 16.10 of the statutes, relating to the civil service.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection (1) of section 20.73 and section 16.09 of the statutes are amended to read: (20.73) (1) Except as expressly provided by law, the governor, secretary of state, state treasurer, attorney-general, state superintendent, commissioner of insurance, state fire marshal, superintendent of public property, railroad commission, dairy and food commissioner, superintendent of weights and measures, industrial commission, adjutant general, state board of control, grain and warehouse commission, civil service commission, tax commission, commissioners

of public lands, state conservation commission, supervisor of inspectors of illuminating oils, state treasury agent, commissioner of banking, printing board, free library commission, state chief engineer, commissioner of agriculture, board of public affairs, geological and natural history survey, state board of health, state highway commission, state board of medical examiners, state board of dental examiners, state board of pharmacy, Wisconsin real estate brokers board, state board of vocational education and state athletic commission are each authorized to * * such deputies, assistants, experts, clerks, appoint stenographers, or other employes as shall be necessary for the execution of their functions and to designate the titles, prescribe the duties, and fix the compensation of such subordinates, but these powers shall be exercised subject to the state civil service law unless the position filled by any such subordinate has been expressly exempted from the operation of chapter 16 and subject, also, to the approval of such other officer or body as may be prescribed by law.

16.09 The classifications prepared pursuant to law by the superintendents or heads of the several state reformatory, charitable and penal institutions, approved by the state board of control, and adopted by the commission are the classifications in such respective institutions, and adequate eligible lists shall be made up, and so far as possible shall be at all times kept by the commission from which appointments shall be made in such institutions. But the provisions of sections 16.01 to 16.30, inclusive. with reference to removals, suspensions, discharges, reductions in pay or position, transfers and reinstatements shall not be applicable in such cases, except that they shall be made for just cause, which shall be neither religious nor political, and the reasons therefor shall be reported in writing to the civil service commission. In such institutions emergency appointments and appointments when no suitable person is on an eligible list may be made otherwise than from such list. And such persons, when so appointed, shall have the same rights as though taken from an eligible list, except that they may be subjected to such test as to merit and fitness as is prescribed by the commission.

Section 2. A new subsection is added to section 16.10 of the statutes to read: (16.10) (3) The commission shall establish and maintain standard salary ranges for all positions and em-

ployments in the state service to which this chapter applies. The salary of no person holding any such position or employment shall be certified by the commission, unless such salary conforms to and is within the salary range established under the provisions of this subsection.

SECTION 3. This act shall take effect upon passage and publication.
