**CHAPTER 396.**

AN ACT to repeal and recreate subsection (3) of section 180.11 of the statutes, relating to corporations.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subsection (3) of section 180.11 of the statutes is repealed.

SECTION 2. A new subsection is added to section 180.11 of the statutes to be numbered and to read: (180.11) (3) If authorized by its articles of organization any corporation organized under chapter 180 of the statutes may subscribe for, take or hold stock in any other corporation.

SECTION 3. This act shall take effect upon passage and publication.

**CHAPTER 397.**

AN ACT to repeal subsection (24) of section 20.17 of the statutes; to amend subsection (1), subsection (1a), paragraphs (a), (b), and (c) of subsection (2), paragraphs (a), (b), (c), and (d) of subsection (3), paragraphs (a), (b), and (c) of subsection (4), paragraphs (a), (b), and (c) of subsection (5), paragraphs (a), (b), (c), and (e) of subsection (6), paragraphs (a) and (c) of subsection (7), paragraphs (a), (b), and (c) of subsection (8), paragraphs (a), (b), and (c) of subsection (9), subsection (9b), paragraphs (a), (b), and (c), of subsection (10), paragraphs (a), (b), and (c) of subsection (11), paragraphs (a), (b), (c), and (h) of subsection (12), paragraphs (a), (b), and (c) of subsection (14), paragraphs (a), (b), and (d) of subsection (15), paragraphs (a), (b), and (c) of subsection (16), paragraphs (a), (b), and (c) of subsection (17), paragraphs (a), (b), and (d) of subsection (18), and subsection (27), all of section 20.17 of the statutes; and to create subsection (1c), paragraph (i) of subsection (2), paragraph (i)

of subsection (5), subsections (24), (24a) and (33) of section 20.17 of the statutes; subsection (12) of section 20.40 of the statutes; subsection (12) of section 20.41 of the statutes, and section 36.227 of the statutes, relating to appropriations to the state board of control and the charitable and penal institutions, and the university of Wisconsin, and transferring the control and operation of the Wisconsin psychiatric institute to the board of regents of the university of Wisconsin.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subsection (24) of section 20.17 of the statutes is repealed.

SECTION 2. Subsection (1), subsection (1a), paragraphs (a), (b), and (c) of subsection (2), paragraphs (a), (b), (c), and (d) of subsection (3), paragraphs (a), (b), and (c) of subsection (4), paragraphs (a), (b), and (c) of subsection (5), paragraphs (a), (b), (c), and (e) of subsection (6), paragraphs (a) and (c) of subsection (7), paragraphs (a), (b), and (c) of subsection (8), paragraphs (a), (b), and (c) of subsection (9), subsection (9b), paragraphs (a), (b), and (c) of subsection (10), paragraphs (a), (b), and (c) of subsection (11), paragraphs (a), (b), (c), and (h) of subsection (12), paragraphs (a), (b), and (c) of subsection (14), paragraphs (a), (b), and (d) of subsection (15), paragraphs (a), (b), and (c) of subsection (16), paragraphs (a), (b), and (c) of subsection (17), paragraphs (a), (b), and (d) of subsection (18), and subsection (27), all of section 20.17 of the statutes are amended to read: (20.17) (1) Annually, beginning July 1, \* \* \* 1925, \* \* \* *ninety-four* thousand \* \* \* *one hundred fifty* dollars, for general expenditures incurred in the execution of the functions of said board. Of this there is allotted:

(a) To each member of the board, an annual salary of five thousand dollars.

(1a) On July 1, \* \* \* 1925, \* \* \* *ten* thousand \* \* \* *two hundred forty* dollars, and on July 1, \* \* \* 1926, \* \* \* *ten* thousand \* \* \* *two hundred forty* dollars for carrying out the provisions of subsection (4) of section 46.04.

(2) (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to sub-

section (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, \* \* \* 1925, \* \* \* two hundred \* \* \* *twenty-eight* thousand five hundred *seventy* dollars, for operation. *Of the amount appropriated July 1, 1925, two hundred fifty dollars may be used to pay bills heretofore incurred.*

(2) (b) On July 1, \* \* \* 1925, *twenty-seven* thousand *six hundred seventy* dollars, and on July 1, \* \* \* 1926, *twenty-seven* thousand *six hundred seventy* dollars for property repairs and maintenance.

(2) (c) On July 1, \* \* \* 1925, \* \* \* *four* thousand \* \* \* *four* hundred \* \* \* dollars, and on July 1, \* \* \* 1926, \* \* \* *four* thousand \* \* \* *four* hundred \* \* \* dollars for permanent property and improvements.

(3) (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02 and freight charges thereon, and annually, beginning July 1, \* \* \* 1925, one hundred \* \* \* *eighty-eight* thousand *four hundred eighty-four* dollars, for operation.

(3) (b) On July 1, \* \* \* 1925, \* \* \* *thirty-two* thousand *two hundred twenty* dollars, and on July 1, \* \* \* 1926, \* \* \* *thirty-two* thousand *two hundred twenty* dollars for property repairs and maintenance.

(3) (c) On July 1, \* \* \* 1925, \* \* \* *five* thousand *seven hundred* \* \* \* *fifty* dollars, and on July 1, \* \* \* 1926, \* \* \* *five* thousand *seven hundred* \* \* \* *fifty* dollars for permanent property and improvements.

(3) (d) On July 1, 1923, one thousand five hundred dollars for sewage disposal; one thousand five hundred dollars for furniture for the superintendent's residence; and one thousand dollars for apparatus for the hospital. On July 1, 1924, two thousand nine hundred dollars for tiling; one hundred twenty-five thousand dollars for the construction, \* \* \* equipment, *and furniture and furnishings* of \* \* \* inmate buildings; and two thousand dollars for furniture for the west farm house.

(4) (a) Annually, an amount sufficient to cover the cost of insurance, and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon,

\* \* \* and annually, beginning July 1, \* \* \* 1925, \* \* \* *sixty-six thousand three hundred sixty* dollars, for operation.

(4) (b) On July 1, \* \* \* 1925, \* \* \* *six thousand nine hundred fifty* dollars, and on July 1, \* \* \* 1926, \* \* \* *six thousand nine hundred fifty* dollars for property repairs and maintenance.

(4) (c) On July 1, \* \* \* 1925, one thousand \* \* \* *nine hundred fifty* dollars, and on July 1, \* \* \* 1926, one thousand \* \* \* *nine hundred fifty* dollars for permanent property and improvements.

(5) (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, \* \* \* 1925, \* \* \* *ninety-seven thousand eight hundred four* dollars, for operation.

(5) (b) On July 1, \* \* \* 1925, \* \* \* *twelve thousand seven hundred fifty* dollars, and on July 1, \* \* \* 1926, \* \* \* *twelve thousand seven hundred fifty* dollars for property repairs and maintenance.

(5) (c) On July 1, \* \* \* 1925, \* \* \* *five thousand five hundred fifty* dollars, and on July 1, \* \* \* 1926, \* \* \* *five thousand five hundred fifty* dollars for permanent property and improvements.

(6) (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, \* \* \* 1925, \* \* \* *ninety-one thousand two hundred thirty* dollars, for operation.

(6) (b) On July 1, \* \* \* 1925, \* \* \* *seventeen thousand six hundred fifty* dollars, and on July 1, \* \* \* 1926, \* \* \* *seventeen thousand six hundred fifty* dollars for property repairs and maintenance.

(6) (c) On July 1, 1921, five hundred dollars for engine room floor; on July 1, \* \* \* 1925, \* \* \* *eight thousand seven hundred* dollars, and on July 1, \* \* \* 1926, \* \* \* *eight thousand seven hundred* dollars for permanent property and improvements.

(6) (e) \* \* \* *Annually, beginning July 1, \* \* \* 1925, three thousand five hundred dollars, \* \* \* for maintaining the summer school in connection with the school for the blind.*

(7) (a) On July 1, \* \* \* 1925, fourteen thousand five hundred dollars, and on July 1, \* \* \* 1926, fourteen thousand five hundred dollars, for operation. On July 1, 1923, one thousand dollars for the institution contingent fund.

(7) (c) On \* \* \* July 1, \* \* \* 1925, \* \* \* *ten thousand dollars, together with any materials then in stock, pursuant to the provisions of this subsection, to be invested in materials, payment of artisans, and for expenses incident to manufacture and sale of basketry and willow ware; and whenever any such materials, or the articles manufactured therefrom, are sold, the proceeds thereof shall be paid into the general fund within one week of receipt, and credited back to this appropriation.*

(8) (a) *Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, \* \* \* 1925, one hundred \* \* \* thirty-six thousand five hundred forty-six dollars, for operation.*

(9) (a) *Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, \* \* \* and \* \* \* annually, beginning July 1, \* \* \* 1925, \* \* \* twenty-six thousand three hundred dollars, for operation. \* \* \* Of the amount appropriated July 1, 1925, seventeen dollars and thirty cents may be used to pay bills heretofore incurred.*

(9) (b) On July 1, \* \* \* 1925, two thousand \* \* \* *three hundred fifty dollars, and on July 1, \* \* \* 1926, two thousand \* \* \* three hundred fifty dollars, for property repairs and maintenance.*

(9) (c) On July 1, 1919, seven thousand four hundred fifty dollars, of which seven thousand dollars shall be used for no other purpose than the purchase of furniture and furnishings for the new buildings, on July 1, \* \* \* 1925, \* \* \* *two thousand \* \* \* eight hundred \* \* \** dollars, and on July 1, \* \* \* 1926, \* \* \* *two thousand \* \* \* eight hundred \* \* \** dollars, for permanent property and improvements.

(9b) For state aid and maintenance of inmates in county tuberculosis sanatoriums, annually, beginning July 1, \* \* \* 1925, two hundred \* \* \* *fifty thousand* dollars. Such aid shall be apportioned among the various county institutions in proportion to the number of patients cared for at public expense in each institution during the year ending on the thirtieth day of June; but no more shall be allowed than seven dollars per week per patient for the number of weeks such patient was a resident of such institution, *and if more be demanded the appropriation made by this subsection shall be pro-rated.*

(11) (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually beginning July 1, \* \* \* 1925, *one hundred \* \* \* fifteen thousand \* \* \* seven hundred eighty* dollars, for operation.

(11) (b) On July 1, \* \* \* 1925, \* \* \* *seventeen thousand \* \* \* ten* dollars, and on July 1, \* \* \* 1926,

\* \* \* *seventeen* thousand \* \* \* *ten* dollars, for property repairs and maintenance.

(11) (c) On July 1, \* \* \* *1925*, two thousand \* \* \* *nine* hundred dollars, and on July 1, \* \* \* *1926*, two thousand \* \* \* *nine* hundred dollars, for permanent property and improvements.

(12) (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, \* \* \* *1925*, one hundred \* \* \* *thirty-nine* thousand \* \* \* *nine* hundred *five* dollars, for operation.

(14) (i) Annually, an amount sufficient to cover the cost of insurance, and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, \* \* \* *1925*, \* \* \* *seventy-one* thousand *five* hundred *fifteen* dollars, for operation. \* \* \*

(14) (l) On July 1, \* \* \* *1925*, ten thousand \* \* \* *one* hundred *fifty* dollars, and on July 1, \* \* \* *1926*, ten thousand \* \* \* *one* hundred *fifty* dollars, for property repairs and maintenance.

(14) (c) On July 1, \* \* \* *1925*, one thousand \* \* \* *four* hundred dollars, and on July 1, \* \* \* *1926*, one thousand \* \* \* *four* hundred dollars, for permanent property and improvements.

SECTION 3. Subsection (1c), paragraph (i) of subsection (2), paragraph (i) of subsection (5), subsections (24), (24a) and (33) of section 20.17 of the statutes; subsection (12) of section 20.40 of the statutes; subsection (12) of section 20.41 of the statutes, and section 36.227 of the statutes are created to read: (20.17) (1c) Annually, beginning July 1, 1925, twelve thousand five hundred dollars, for operation of psychiatric and medical field service.

(20.17) (2) (i) On July 1, 1925, forty thousand dollars for the purchase of land to be used for farming purposes and for making improvements thereon.

(20.17) (5) (i) On July 1, 1925, eight thousand dollars for the purchase of land to be used for farming purposes and for making improvements thereon.

(24) On July 1, 1925, one thousand dollars and the balances made available by paragraph (k) of this subsection, and on July 1, 1926, two hundred eleven thousand one hundred dollars and the balances made available by paragraph (k) of this subsection for the construction, remodeling, and equipment of buildings, for the purchase of furniture and furnishings, and for permanent property and improvements to be allotted as follows:

(24) (g) Eight thousand dollars for a water softening plant at the state reformatory.

(24) (h) Fifteen thousand dollars for guard fencing; and eight thousand dollars for refrigeration at the Wisconsin industrial home for women.

(24) (i) One thousand five hundred dollars for water supply; one thousand two hundred dollars for dental equipment; and six thousand dollars for live stock at the industrial school for boys.

(24) (j) Twenty thousand dollars for boys' cottage; sixty thousand dollars for a school house; seventeen thousand five hundred dollars for a school building addition; six thousand dollars for remodeling cottage D at the state public school.

capas, runways, machine shed, hospital, corn crib, and an oil house in paragraph (c), for a cold storage compartment, a new barn and silo, a tunnel to barn, a root cellar, old barn equipment, tunnel equipment, slaughter house, and a piggery in paragraph (e), and for land in paragraph (f) of subsection (15); for remodeling officers' quarters, a barn and silo on the Oneida farm, and furniture in paragraph (f) and for horse barn, and property repairs in paragraph (h) of subsection (16); for yard lighting, fences, an automobile, a tractor, and live stock in paragraph (d) and for painting in paragraph (f) of subsection (17); for water supply, farm superintendent's office, a hog house, a slaughter house, in paragraph (c) and poultry houses in paragraphs (c) and (f), for a new hospital, remodeling old hospital, a Ford roadster, a Ford chassis, and resetting boilers in paragraph (e), for a calf barn, a stock hospital, barn extensions, a hog house, a sheep barn, officers' quarters, a tractor and plow, barn equipment, and a truck chassis in paragraph (f), and for a new boiler in paragraph (g) of subsection (18); and for convict labor on highways in subsection (21), all of section 20.17 of the statutes are added to and made a part of the appropriation made by the introductory paragraph of this subsection.

Any balances remaining June 30, 1926, in the appropriations for land in subsection (9a) and for sprinkler systems in subsection (25) of section 20.17 of the statutes, and for land in section (5), chapter 599, of the laws of 1915 are added to and made a part of the appropriation made by the introductory paragraph of this subsection.

(20.17) (24a) On July 1, 1925, thirty-three thousand one hundred fifty dollars for the construction, remodeling, and equipment of buildings, and for permanent property and improvements to be allotted as follows:

(24a) (a) One thousand six hundred dollars for remodeling young stock shed and one thousand five hundred dollars for the construction and equipment of a poultry house at the state hospital for the insane.

(24a) (b) One thousand dollars for a motor cultivator, six hundred twenty-five dollars for a Fordson truck, and seven hundred dollars for a threshing outfit at the northern hospital.

(24a) (c) One thousand two hundred dollars for a hog house at the central state hospital.

(24a) (d) One thousand seven hundred twenty-five dollars for a poultry house and one thousand dollars for drainage at the school for the deaf.

(24a) (e) Four hundred dollars for a Ford truck for the tuberculosis sanatorium.

(24a) (f) Three thousand dollars for live stock at the state tuberculosis camp.

(24a) (g) One thousand five hundred dollars for fencing and land clearing, seven hundred dollars for a silo, and seven hundred dollars for a threshing outfit for the northern colony and training school.

(24a) (h) One thousand five hundred dollars for completing hog house, three thousand two hundred dollars for farm drainage and fencing, one thousand five hundred dollars for a slaughter house, one thousand dollars for live stock, and seven hundred dollars for a threshing outfit for the southern colony and training school.

(24a) (i) One thousand two hundred dollars for a poultry house at the industrial school for boys.

(24a) (j) Two thousand dollars for clearing land and developing Oneida farm, and seven hundred dollars for a threshing outfit at the state reformatory.

(24a) (k) Two thousand five hundred dollars for drainage and fencing, one thousand two hundred dollars for a poultry house, and one thousand dollars for live stock at the industrial home for women.

(24a) (l) One thousand dollars for live stock at the state prison.

(33) Except as provided in paragraph (k) of subsection (24) of section 20.17 of the statutes, any amounts appropriated for construction, land, equipment or permanent property and improvements at an institution under section 20.17 of the statutes, not needed for the original purpose, may, with the consent of the governor, be added to any one or more of the other specific capital appropriations at the same institution, provided that the provisions of this subsection shall only be applicable to appropriations made for specific capital purposes.

(20.40) (12) Annually, beginning July 1, 1925, thirty-six thousand six hundred dollars to meet the appropriation made by subsection (12) of section 20.41.

(20.41) (12) Annually, beginning July 1, 1925, thirty-six thousand six hundred dollars for the operation, maintenance, and permanent property and improvements for the psychiatric institute.

(36.227) (1) On July 1, 1925, the Wisconsin psychiatric institute, heretofore established under section 51.235 of the statutes, excepting therefrom the Wisconsin memorial hospital, shall be transferred to and thereafter shall be maintained as a department of the university of Wisconsin.

(2) On July 1, 1925, or as soon thereafter as it is possible to house the Wisconsin psychiatric institute, all of the equipment, apparatus, instruments, appliances, chemicals, books, periodicals, pamphlets, records, supplies and other property, except real property and buildings used by said psychiatric institute, and except such supplies and equipment the property of the Wisconsin memorial hospital, used by said Wisconsin psychiatric institute, shall be transferred to the university of Wisconsin. The state board of control shall transfer and deliver to the board of university regents all such property and said board of regents shall hold all such property as the property of, and for the use of, the Wisconsin psychiatric institute. The expense of making such transfer shall be borne by the Wisconsin psychiatric institute.

(3) The board of regents of the state university is authorized and directed to house, equip and maintain as part of the university, the Wisconsin psychiatric institute, the duties of which institute shall be:

(3) (a) To investigate medical and social conditions which directly or indirectly result in state care; to develop and promote measures to relieve and prevent the need of state care; to undertake special education and training, and generally seek by research and investigation to prevent conditions which result in state care.

(3) (b) To render a specialized service to the state institutions under the jurisdiction of the state board of control, such service to be available at all times, to the state board of control, and to the institutions under its jurisdiction. Such state institutions shall at all times be open to the Wisconsin psychiatric institute for the prosecution of research investigation.

(3) (c) To make the Wasserman tests and other chemical examinations provided for under section 46.13 and section 143.07 of the statutes.

(3) (d) To exercise the powers granted under section 51.235 of the statutes, provided that the transfer of any insane person from the psychiatric institute to any hospital or asylum for the insane, or from any other state or county institution under the jurisdiction of the board of control to the psychiatric institute shall be made only by approval of the state board of control.

(4) All amounts heretofore appropriated or hereafter appropriated for the operation of the Wisconsin psychiatric institute shall, on and after July 1, 1925, be administered by the board of university regents, such funds to be administered and accounted for separately from other appropriations made to the university of Wisconsin and thereafter the board of university regents shall state separately from other items of the biennial budget, of the university, the biennial requests for appropriations to meet the requirements for operation, capital, and repairs and maintenance of the Wisconsin psychiatric institute.

(5) The board of regents of the university of Wisconsin shall appoint the director of the Wisconsin psychiatric institute and such assistants to do the work as are necessary to accomplish the purposes of the institution, and shall fix the compensation of such director and assistants.

(6) There is hereby created an advisory council to govern the relations of the psychiatric institute to the institutions under the jurisdiction of the state board of control and of these institutions to the psychiatric institute. Such council shall be made up of the president of the university of Wisconsin, the dean of the medical school of the state university, the director of the psychiatric institute, and three members of the state board of control. Such council, by majority vote, shall prescribe rules and regulations whenever, in its judgment, these are necessary to govern the relations of these institutions. Such council shall not have power to prescribe any rule or regulation the effect of which would be to restrict the services of said psychiatric institute to the state institutions as provided for in this section.

SECTION 4. This act shall take effect July 1, 1925.
