## CHAPTER 62.

AN ACT to detach certain territory from the Hayward free high school district, Sawyer county, and to provide for the apportionment of the credits, liabilities and property values of said high school district.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. All the territory consisting of town forty north, range five west, known as the town of Fishtrap, now a part of the Hayward free high school district joint of the city of Hayward and the towns of Hayward, Lenroot, Round Lake, Spider Lake, Bass Lake, Hunter and Fishtrap, Sawyer county, Wisconsin, is hereby detached from said joint high school district.

SECTION 2. The town boards of the towns of Hayward, Lenroot, Round Lake, Spider Lake, Bass Lake, Hunter and Fishtrap, and the city council of the city of Hayward, shall meet with the school board of the Hayward free high school district, at the high school building in the city of Hayward, on the twentyseventh day of June, 1925, at two o'clock in the afternoon to adjust the credits and liabilities of said district on account of the detachment of territory as herein provided.

SECTION 3. The clerk of the Hayward free high school district shall give written notice to each member of the various boards of the meeting to adjust the credits and liabilities by registered mail at least ten days before the meeting.

SECTION 4. This act shall take effect upon passage and publication.

AN ACT to amend paragraph (a) of subsection (18) of section 29.18 of the statutes, relating to close season for Hungarian partridges in Waukesha and Jefferson counties.

## CHAPTER 64.

AN ACT to amend section 252.14 of the statutes, relating to court commissioners.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 252.14 of the statutes is amended to read : 252.14 In each county constituting a part only of a judicial circuit, the circuit judge shall appoint such number of court commissioners, not exceeding six, as the proper transaction of business requires, except in counties having a population exceeding sixty-five thousand, according to the last census, where the number may be increased to ten. In each county constituting an entire judicial circuit with two or more branches each circuit judge shall appoint one, and if the proper conduct of business requires it, two court commissioners. Each court commissioner shall hold office during the term of office of the judge who appointed him, and until his successor is appointed and qualified, and, before entering upon the duties of his office, shall take and subscribe the constitutional oath of office and file the same duly certified, together with his appointment, in the office of the clerk of the circuit court of the county in which he resides.
