## CHAPTER 76.

AN ACT to amend section 21, chapter 244 of the laws of 1921, relating to the municipal court in the county of Fond du Lac, except the city and town of Ripon.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 21 of chapter 244 of the laws of 1921 is amended to read: (Chapter 244, laws of 1921) Section 21. A change of venue in any civil action or proceeding pending before any justice of the peace of the county of Fond du Lac, except the city of Ripon and the town of Ripon and the city of Waupun, may be taken to the municipal court, provided either party to the action shall, on or before the return day, by himself or attorney, in writing demand that such action be removed to the municipal court, in which case the justice shall forthwith transmit the papers to the municipal court, whereupon the plaintiff shall pay to said municipal court the court costs prescribed in section 25 of this act, and a failure to pay said court costs shall be cause for a dismissal of said action with costs and disbursements thus far incurred to be taxed against said plaintiff, and on the payment of said court costs or by order of the court the action shall proceed in like manner as if originally commenced in the municipal court.

Section 2. This act shall take effect upon passage and publication.
