ceive for his services for and during a regular session the sum of

\* \* one thousand dollars, and ten cents for every mile he
shall travel in going to and returning from the place of meeting
of the legislature on the most usual route. In case of an extra
session of the legislature, no additional compensation shall be
allowed to any member thereof, either directly or indirectly,
except for mileage, to be computed at the same rate as for a regular session. No stationery, newspapers, postage or other perquisites, except the salary and mileage above provided, shall be
received from the state by any member of the legislature for his
services or in any other manner as such member.

## JOINT RESOLUTION

Relating to the appointment of an interim committee to investigate the pollution of boundary waters between Minnesota and Wisconsin.

Whereas, Joint resolution No. 18, S., adopted by the senate and assembly, directed the appointment of a joint committee consisting of one senator and two assemblymen to meet with a similar committee of the Minnesota legislature to investigate the problem of the pollution of the boundary waters between the states of Minnesota and Wisconsin, and

WHEREAS, In compliance with said resolution a committee was appointed consisting of Senator W. H. Hunt, and Assemblymen Charles B. Perry and Theodore Swanson, and

WHEREAS, Said committee met in joint session with a committee of the Minnesota legislature on Friday, April 17, and found a large amount of work which should be done in the interest of the conservation of the health of the people and of the wild life of the upper Mississippi river. Therefore, be it

Resolved by the Assembly, the Senate concurring, That this committee or a similar committee be continued as an interim committee vested with the authority to make further investigation and take such procedure as will eventually bring about the desired results. Be it further

Resolved, That said interim committee shall be vested with all powers granted in joint resolution 18, S., and that provision be made for the actual and necessary expenses of said committee.

## JOINT RESOLUTION

## JOINT RESOLUTION

Providing for a revision and codification of the school laws.

WHEREAS, It is agreed that the school laws of this state are in great need of prompt revision and codification, and

Whereas, It would be impossible for this legislature or any committee thereof to properly do the work connected with such a revision and codification within the time that the legislature will be in session, and

WHEREAS, Because of the several kinds of school districts and the technical nature of the subject it is believed that such revision and codification should be made by persons familiar with the subject of school laws and the drawing of statutes, therefore, be it
