## CHAPTER 101.

AN ACT to amend subsection (4) of section 35.84 of the statutes, relating to Wisconsin session laws.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection (4) of section 35.84 of the statutes is amended to read: (35.84) (4) Of Wisconsin session laws, one copy to each member and officer of the legislature enacting them; four copies to each chief clerk of the next succeeding legislature; one copy each to the governor, secretary of state, attorney-general, the district attorney of each county, justices of the supreme court, supreme court reporter, revisor, each judge and clerk of every other court of record, each judge and district attorney of the United States in this state, the secretary of state of the United States, the library of congress, the Milwaukee law library association and the Oshkosh law library; to the state library, the library of the legislative reference department, the state historical society, the law library of Marquette University, and the university law library, ten copies each.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 102.

AN ACT to create section 61.68 of the statutes, relating to the laying out of highways in villages.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 61.68 All of the provisions of chapter 80 of the statutes with reference to the laying out, altering and discontinuing of highways are hereby made applicable to villages. The application for the laying out of highways shall be made to the village board of trustees, and in any instance where the words "town board" or the word "supervisors" are used in said chapter 80 of the

statutes, such words shall be construed to mean "village board" or "village board of trustees," to the end that streets and highways may be laid out in villages in the same manner, with the same procedure, and with like effect as such highways are laid out in towns.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 103.

AN ACT to convey to the city of Marinette certain lands for public park purposes.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. All of the right, title, and interest of the state of Wisconsin in and to the following described land is hereby ceded, granted, quit claimed, and conveyed for public park purposes to the city of Marinette in fee, to wit:

- (a) The south half of the north half of the north east quarter of the north east quarter of section number twelve in township number thirty north of range number twenty-three east, Marinette county, Wisconsin;
- (b) Commencing at the south east corner of the north east quarter of the north east quarter of section twelve in township thirty north of range twenty-three east and running north on the east line of said lot five chains and forty-six links to the south east corner of lands sold as per deed recorded in volume 25, page 166, Oconto county records; thence west on the south line of said land twenty chains to the west boundary thereof, thence south on the west line of said lot five chains and forty-six links to the south west corner of said lot; thence east on the south line of said lot twenty chains to place of beginning, containing ten and ninety-two hundredths acres, more or less, Marinette county, Wisconsin;
- (c) Commencing at the south east corner of the north half of the north east quarter of the north east quarter of section twelve in township number thirty north of range number twentythree east, thence west twenty chains to the western boundary line
