CHAPTER 385.

AN ACT to revert to the general fund on June 30, 1927, any balance remaining in the appropriation made by the introductory paragraph to subsection (1) of section 20.03 of the statutes; and to amend the introductory paragraph to subsection (1) of section 20.03 of the statutes, relating to the appropriation to the Wisconsin national guard.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Any balance remaining in the appropriation made by the introductory paragraph to subsection (1) of section 20.03 of the statutes on June 30, 1927, shall revert to the general fund.

SECTION 2. The introductory paragraph to subsection (1) of section 20.03 of the statutes is amended to read: (20.03) (1) (Introductory paragraph) To the Wisconsin national guard, annually, beginning July 1, * * * 1927, two hundred * * * thirty thousand dollars. Of this there is allotted:

SECTION 3. This act shall take effect July 1, 1927.

CHAPTER 386.

AN ACT to amend the introductory paragraph to subsection (1), and subsection (2) of section 20.21 of the statutes, relating to the appropriations for the superintendent of public instruction.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The introductory paragraph to subsection (1), and subsection (2) of section 20.21 of the statutes are amended to read: (20.21) (1) (Introductory paragraph) Annually, beginning July 1, * * * 1927, one hundred * * * ten thousand dollars, for the execution of his functions. Of this there is allotted:

(2) Annually, beginning July 1 * * * 1927, not to exceed * * * four thousand * * * two hundred dollars,

for institutes for the instruction of teachers pursuant to section 37.14, and for conducting a state teachers' and a state young people's reading circle organized by the Wisconsin teachers' association. Not to exceed *two thousand * * ** dollars of this appropriation is allotted, annually, for such reading circles.

SECTION 2. This act shall take effect July 1, 1927.

CHAPTER 387.

AN ACT to amend the introductory paragraph and paragraph (b) of subsection (1) of section 20.08 of the statutes, relating to appropriations for the attorney-general.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The introductory paragraph and paragraph (b) of subsection (1) of section 20.08 of the statutes are amended to read: (20.08) (1) (Introductory paragraph) Annually, beginning July 1, * * * 1927, * * * *sixty-five* thousand * * * dollars, for the execution of his functions. Of this there is allotted:

(b) To the deputy attorney-general an annual salary of four thousand * * * *eight* hundred dollars.
