AN ACT to amend subsection (1) of section 53.12 of the statutes, relating to convict labor outside prison.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection (1) of section 53.12 of the statutes is amended to read: (53.12) (1) Every convict employed on construction or other work outside of the prison walls on the honor system who shall conduct himself in a peaceful and obedient manner and shall faithfully perform all the duties required of him shall be entitled to a diminution of time on the ratio of five days for each month of thirty days or fraction thereof, while he is so employed, in addition to the credit for good conduct prescribed by section 53.11.

Section 2. This act shall take effect upon passage and publication.

CHAPTER 41.

AN ACT to renumber subsection (2) of section 50.07 to be paragraph (a) of said subsection, and to create paragraph (b) of said subsection (2) of section 50.07 of the statutes, relating to admission of patients to sanatoriums.

SECTION 1. Subsection (2) of section 50.07 of the statutes is renumbered to be paragraph (a) of said subsection.

Section 2. A new paragraph is added to subsection (2) of section 50.07 of the statutes to read: (50.07) (2) (b) Any such person who is unable to pay the actual cost of his maintenance may be admitted upon the payment of an amount ordered by the judge approving the application, if after investigation it is found that the patient truly represented his circumstances and was unable to pay more than the amount so ordered. All payments

so made by, or on the behalf of the patients are to be made to the superintendent in charge of the institution in which the patient is being cared for.

The average annual earnings for employes shall be taken at not less than five hundred twenty-five dollars nor more than one thousand * * * five hundred dollars per annum. Between said limits such average annual earnings shall be determined as follows:
