CHAPTER 480.

AN ACT to appropriate a sum of money named herein to the Wisconsin deep waterways commission, created by chapter 377, laws of 1919.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to the Wisconsin deep waterways commission, created by chapter 377, laws of 1919, for the fiscal year ending June 30, 1928, six thousand two hundred fifty dollars; and for the fiscal year ending June 30, 1929, six thousand two hundred fifty dollars for the execution of its functions, provided that no part of this appropriation shall be available except upon the approval of the governor, and provided further, that the members of said commission shall receive their actual expenses but no compensation.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 481.

AN ACT to amend subsection (3) of section 26.08 of the statutes, relating to leases by the conservation commission.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (3) of section 26.08 of the statutes is amended to read: (26.08) (3) No lease shall hereafter be issued or any existing lease extended or renewed by the commission on any unsurveyed and unattached islands in inland lakes north of the township line between townships thirty-three and thirty-four north, and granted to the state by an act of congress, approved August 22, 1912, entitled "An act granting unsurveyed and unattached islands to the state of Wisconsin for forestry purposes," *except that the commission may extend or renew any*

such leases in existence June 25, 1925, to public, charitable, religious, educational or other associations not organized for profit.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 482.

AN ACT to amend subsection (2) of section 102.03 of the statutes, relating to compensation for injured firemen.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (2) of section 102.03 of the statutes is amended to read: (102.03) (2) Where, at the time of the accident, the employe is performing service growing out of and incidental to his employment.

Every employe going to and from his employment in the ordinary and usual way, while on the premises of his employer, shall be deemed to be performing service growing out of and incidental to his employment:

(a) *When any fireman is responding to a call for assistance outside the limits of the city or village by which the fireman is employed, unless such calls are made in violation of an ordinance, resolution or order of such city or village.*

SECTION 2. This act shall take effect upon passage and publication.

AN ACT to create section 226.045 of the statutes, relating to deposits in banking institutions in this state by nonresidents and foreign corporations.
