JOINT RESOLUTION

Relating to the duty on cheese of the cheddar type.

WHEREAS, The importation from Canada and other foreign countries of cheese of the cheddar type has increased very greatly in recent years and now constitutes a great menace to the producers of American cheese in this country; and

WHEREAS, The present duty of five cents per pound on cheese of the cheddar type is inadequate, as shown by the fact that foreign cheese is frequently sold in American markets at a price, with the duty added, at which such cheese can not be produced in this country; now, therefore, be it

Resolved, by the Senate, the Assembly concurring, That the President of the United States be and is hereby respectfully requested to exercise the powers conferred upon him under the flexible tariff act to increase the duty on the importation of cheese of the cheddar type from five to seven and one-half cents per pound.

JOINT RESOLUTION

Relating to the appointment of a special joint committee upon the repeal of obsolete laws.

WHEREAS, There are now in the statutes of Wisconsin many obsolete laws which should be repealed; and

WHEREAS, The task of systematically going through the statutes to rid them of such obsolete laws is too great for any individual member or for any of the regular committees to undertake; therefore, be it

Resolved by the Assembly, the Senate concurring, That a special joint committee consisting of two members of the senate and three members of the assembly, be appointed by the presiding officers of the respective houses, to investigate and ascertain what obsolete laws there are now in our statutes. Be it further

Resolved, That said committee shall from time to time during the present session of the legislature report bills for the repeal of obsolete laws now a part of the statutes of Wisconsin.

JOINT RESOLUTION

Relating to appointment of a legislative committee to represent the state in matters relating to permanent flood control of the Mississippi River.

WHEREAS, The present flood conditions of the Mississippi Valley make it evident that something must be done to permanently control future floods in that region, and

WHEREAS, On or about June 1, 1927, in the city of Chicago, a conference of mayors, governors, congressmen and army engineers will be held to consult and make recommendations to congress relative to future flood control, and

WHEREAS, There will doubtless be other conferences of similar nature held during the recess of this legislature, and

WHEREAS, It is proper that the State of Wisconsin be represented at these conferences, therefore be it

Resolved by the Senate, the Assembly concurring, That a legislative committee, consisting of two senators and three assemblymen to be appointed by the presiding officers of the respective houses, be created to represent Wisconsin at the conference at Chicago and at such other conferences as may be held relating to the permanent control of floods in the Mississippi Valley.
