## CHAPTER 120.

AN ACT to create section 29.395 of the statutes, relating to possession during open season of animals killed in close season.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new section is added to the statutes to be numbered and to read: 29.395 It shall be unlawful to have in possession or under control during the open season the carcass or part of the carcass or skin of any protected wild animal showing that the same has been taken during the close season for such animal.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 121.

AN ACT to amend subsection (1) of section 56.01 of the statutes, relating to prison industries.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subsection (1) of section 56.01 of the statutes is amended to read: (56.01) (1) The state board of control may establish and conduct various industries, and purchase machinery and raw materials, for the employment of prisoners in the state reformatory and state prison, in the manufacture of articles for the state and its municipalities, including motor vehicle license plates and highway signs and markers, and for sale, by contract or otherwise, to other states or political subdivisions thereof or to the United States government or in the open market; and shall fix the price of all articles produced as near the market price as possible; *provided that no monumental article shall be manufactured and sold in the open market.* In fixing the price of motor vehicle license plates and highway signs and markers to the state of Wisconsin or any subdivision thereof the value of labor of each prisoner employed at such work shall be calculated

at the rate of one dollar and seventy-five cents per day, of which twenty-five cents may be allowed as pay to the prisoner so employed or as a benefit to his dependents.

SECTION 2. This act shall take effect January 1, 1930.

### CHAPTER 122.

AN ACT to renumber section 192.42 to be subsection (1) of said section and to create subsection (2) of section 192.42 of the statutes, relating to operation of locomotives.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 192.42 of the statutes is renumbered to be subsection (1) of said section.

SECTION 2. A new subsection is added to section 192.42 of the statutes to be numbered to read: (192.42) (2) It shall be unlawful for any railroad company in the state of Wisconsin to move over its main line outside of yard limits an engine with no cars attached with less than a full crew consisting of one engineer, one fireman and one pilot; said pilot to have had not less than three years experience in train or engine service and who shall have passed standard examination on book of rules and has qualified as a conductor or an engineer; except that such pilot need not be used if one is not available when it is necessary to run engine to the relief of an injured person or to raise a blockade of traffic.

SECTION 3. This act shall take effect upon passage and publication.
