CHAPTER 190.

AN ACT to amend paragraph (a) of subsection (8) of section 27.01 of the statutes, relating to the acquisition of Copper Falls Park.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (a) of subsection (8) of section 27.01 of the statutes is amended to read: (27.01) (8) (a) The conservation commission is hereby authorized to enter into negotiations for the acquisition by purchase, donation or otherwise of suitable areas for park and recreational purposes in sections seventeen and twenty in township forty-five, range two west, Ashland county, commonly known as "Copper Falls." * * *

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 191.

AN ACT to provide for the publication of a new and complete edition of Wisconsin Annotations to the Wisconsin constitution and statutes, and to amend sections 20.64 and 35.23 of the statutes, relative thereto and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The revisor of statutes shall prepare and deliver to the printing board as soon as practicable after the end of the regular legislative session of 1929, printer's copy for a volume to be designated "Wisconsin Annotations" and to contain the Wisconsin constitution, notes of the legislative history of the several sections of the statutes, and annotations of court decisions interpreting the Wisconsin constitution and statutes, and such other matter as he may deem important to be included. The printing board shall order printed, and the state printer shall print and deliver, within ninety days after the receipt of the last of said copy, an edition of five thousand copies.

SECTION 2. Section 35.23 of the statutes is amended to read: 35.23 WISCONSIN ANNOTATIONS. It is the duty of the revisor to prepare from time to time such annotations as will keep the annotations contained in the volume known as "Wisconsin Annotations," * * * down to date, and to print such continuations in the appendix of each biennial issue of Wisconsin Statutes.

SECTION 3. Subsection (2) of section 20.64 of the statutes is amended to read: (20.64) (2) Annually, * * * such sums as may be necessary, for printing and distributing the Wisconsin Statutes and Wisconsin Town Laws and *Wisconsin Annotations*, as prescribed by law.

SECTION 4. The superintendent of public property is authorized to sell all copies of "Wisconsin Annotations" issued in May, 1914, now in stock, at such price as he may deem advisable.

SECTION 5. This act shall take effect upon passage and publication.

CHAPTER 192.

AN ACT to create subsection (9) of section 66.05 of the statutes, relating to the disposition of unclaimed property by cities and villages.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new subsection is added to section 66.05 of the statutes to read: (66.05) (9) Cities and villages may, at a public auction to be held once a year, dispose of any personal property which shall have been abandoned, or shall have remained unclaimed for a period of thirty days after the taking of possession of the same by the city or village officers. All receipts from such sales, after deducting the necessary expenses of keeping such property and conducting such auction, shall be paid into the city or village treasury.

SECTION 2. This act shall take effect upon passage and publication.
