CHAPTER 232.

AN ACT to amend subsection (2) of section 220.08 of the statutes, relating to delinquent banks.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (2) of section 220.08 of the statutes is amended to read: (220.08) (2) On taking possession of the property and business of any such bank or banking corporation, the commissioners shall forthwith give notice of such fact to any and all banks or banking corporations holding or in possession of any assets of such bank or banking corporation. No bank or banking corporation knowing of such taking possession by the commissioner, or notified as aforesaid, shall have a lien or charge for any payment, or advance, thereafter made, or liability thereafter incurred, against any of the assets of the bank or banking corporation of whose property and business the commissioner shall have taken possession as aforesaid, except that all drafts issued and delivered against existing balances on deposit in any drawee banks or banking corporations shall be paid on presentation, if they correspond by number and amount to a list to be certified to them by the commissioner of banking, * * * his deputies or representatives, and if there be sufficient funds in deposit such drafts shall be preferred claims. Such bank or banking corporation may, with the consent of the commissioner, resume business upon such conditions as may be approved by him.

SECTION 2. This act shall take effect upon passage and publication.

SECTION 1. Clause (4) of subsection (12) of section 204.31 of

the statutes is amended to read: (204.31) (12) (4) The provisions of this act contained in clause (5) of subsection (2) and clauses (2), (3), (8) and (12) of subsection (3) may be omitted from railroad ticket policies sold only at railroad stations or at railroad ticket offices by railroad employes and from airplane ticket policies sold only at airports or at airplane ticket offices by the duly authorized employes for passage on duly licensed and authorized air lines permitted to carry passengers, and motor bus ticket policies sold only at motor bus stations or ticket offices by the duly authorized employes for passage on duly licensed bus ticket policies sold only at motor bus stations or ticket offices by the duly authorized employes for passage on duly licensed bus lines permitted to carry passengers.

CHAPTER 234.

AN ACT to appropriate a sum of money named therein to P. Walter Peterson, a member of the state highway commission, to reimburse him for expenses in a suit brought by George Staudenmeyer.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to P. Walter Peterson, a member of the state highway commission, the sum of three hundred and thirty-seven dollars and fifty cents to reimburse said P. Walter Peterson for attorney's fees and expenses incurred by him in defending a suit brought by George Staudenmeyer, which was decided in favor of the said P. Walter Peterson and involved his right to serve as a member of the highway commission.

SECTION 2. This act shall take effect upon passage and publication.
