CHAPTER 349.

AN ACT to amend section 20.17, section 45.278, subsection (10) of section 46.03, subsection (2) of section 46.05, subsection (9) of section 47.08, subsection (10) of section 48.33, and subsection (3) of section 49.37 of the statutes, relating to the board of control and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 20.17, section 45.278, subsection (10) of section 46.03, subsection (2) of section 46.05, subsection (9) of section 47.08, subsection (10) of section 48.33, and subsection (3) of section 49.37 of the statutes are amended to read: 20.17 BOARD OF CONTROL. There is appropriated from the general fund to the state board of control:

- (1) GENERAL ADMINISTRATION. For the board of control:
- (a) Annually, beginning July 1, * * 1929, * * * one hundred forty-three thousand * * eight hundred * * twenty-one dollars for general expenditures incurred in the execution of the functions of said board. Of this there is allotted: to each member of the board an annual salary of five thousand dollars.
- (b) * * * Annually, beginning July 1, * * * 1929
 * * nineteen thousand two hundred * * * dollars for carrying out the provisions of subsection (4) of section 46.04.
- (c) Annually, beginning July 1, * * 1929, * * fifteen thousand * * six hundred dollars for operation of psychiatric and medical field service.
- (d) On July 1, 1929, two hundred thirty-five thousand dollars, and annually, beginning July 1, 1930, for a term of nine years, four hundred thousand dollars for the construction and equipment of new buildings and other permanent property and improvements. No part of this appropriation shall be effective and available for any project until approval in writing signed by the governor and at least one other member of the emergency board has been filed in the office of the secretary of state.
- * * (e) All moneys in the hands of the board of control, or coming into its possession, belonging to absconding

probationers as provided in section 57.075 of the statutes, as a revolving fund to be used for the purposes of such section; and all moneys received by said board pursuant to the provisions of said section shall be paid, within one week after receipt, into the general fund, and are appropriated therefrom, and added to this appropriation.

- • (f) For mental and physical examination of inmates, and prevention of procreation, as provided in section 46.12 of the statutes, annually, beginning July 1, 1919, not to exceed two thousand dollars.
- (g) On July 1, 1929, ten thousand dollars as a revolving appropriation for colonization. All moneys received by each and every person on behalf of colonization projects shall be paid within one week into the general fund and are reappropriated therefrom to the board of control for colonization purposes.
- (2) WISCONSIN STATE HOSPITAL FOR THE INSANE. For the Wisconsin state hospital for the insane:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, two hundred * * forty-five thousand * * one hundred * * fourteen dollars for operation. *
- (b) On July 1, * * 1929, * * twenty-nine thousand * * one hundred * * seventy-three dollars, and on July 1, * * 1930, * twenty-nine thousand * * one hundred * * seventy-three dollars for property repairs and maintenance.
- (c) On July 1, * * 1929, * * nine thousand * * eight hundred seventy-eight dollars, and on July 1, * * 1930, * * nine thousand * * eight hundred seventy-eight dollars for permanent property and improvements.
- (h) * * On July 1, 1922, twenty thousand dollars for the construction and equipment of additions to the continuous bathrooms.
- (3) NORTHERN HOSPITAL FOR THE INSANE. For the Northern hospital for the insane:
 - (a) Annually, an amount sufficient to cover the cost of insur-

ance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, * * * two hundred * * * thirty-four thousand * * nine hundred * * forty-one dollars for operation.

- (b) On July 1, * * 1929, thirty-two thousand * * seven hundred * * eighty dollars, and on July 1, * * 1930, thirty-two thousand * * seven hundred * eighty dollars for property repairs and maintenance.
- (c) On July 1, * * 1929, * * seven thousand * * three hundred * * seventy-six dollars, and on July 1, * * 1930, * * seven thousand * * three hundred * * seventy-six dollars for permanent property and improvements.
- (d) On July 1, 1923, * * one thousand dollars for apparatus for the hospital. On July 1, 1924, two thousand nine hundred dollars for tiling. * *. *
- (e) • On July 1, 1922, fifteen hundred dollars for the construction and equipment of an operating room • •.
- (4) CENTRAL STATE HOSPITAL FOR INSANE. For the central state hospital for insane:
- (a) Annually, an amount sufficient to cover the cost of insurance, and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually beginning July 1, * * 1929, * * ninety-four thousand * * six hundred * * eighty-one dollars for operation.
- (b) On July 1, * * 1929, * * * eight thousand nine hundred * * twenty-four dollars, and on July 1, * * 1930, * * eight thousand nine hundred * * twenty-four dollars for property repairs and maintenance.
- (c) On July 1, * * 1929, * * four thousand * * eighty-four dollars, and on July 1, * * 1930, * * four thousand * * eighty-four dollars for permanent property and improvements.
- (f) On July 1, 1920, * * * five hundred dollars for the construction of a telephone system.
- (5) FEDERAL AID; MEMORIAL HOSPITAL * * *.
- (a) All moneys received by the state from the United States as

federal aid for the treatment of the mental diseases of persons who served in the armed forces of the United States during the war against Germany and her allies, shall be paid within one week after receipt into the general fund of the state treasury and are appropriated therefrom to the state board of control to be allotted to such institutions in the state as said board shall deem proper, in conformity with the agreement under which such money is received.

- (b) All moneys received by each and every person for the board and treatment of persons who served in the armed forces of the United States during the war against Germany and her allies, and who are suffering with mental diseases, and who have been admitted as patients at the Wisconsin memorial hospital, or from the sale of supplies and merchandise on account of such persons, shall be paid within one week after receipt into the general fund of the state treasury, and appropriated therefrom to the state board of control, for the operation of the Wisconsin memorial hospital.
- (c) All moneys transferred from the soldiers' rehabilitation fund to the board of control pursuant to section 45.278 are appropriated to the board of control to be used for augmenting the facilities for the care of patients at the Wisconsin memorial hospital.
- * * (6) NORTHERN WISCONSIN COLONY AND TRAINING SCHOOL. For the Northern Wisconsin colony and training school:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, two hundred * * seventy thousand * * one hundred * * thirteen dollars for operation.
- (b) On July 1, * * 1929, * * twenty-five thousand * eight hundred * one dollars, and on July 1, * 1930, * * twenty-five thousand * eight hundred * one dollars for property repairs and maintenance.
- (c) On July 1, * 1929, * nine thousand three hundred ninety-eight dollars, and on July 1, * 1930, * nine thousand

three hundred * * * ninety-eight dollars for permanent property and improvements.

- (d) On July 1, 1923, • four thousand one hundred dollars for fire escapes; • two thousand dollars for the construction and equipment of an addition to the laundry building; one thousand dollars for poultry house. •
- (7) SOUTHERN WISCONSIN COLONY AND TRAINING SCHOOL. For the Southern Wisconsin colony and training school:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, one hundred * * forty-eight thousand * * three hundred * nine-ty-three dollars for operation.
- (b) On July 1, * * 1929, * * eighteen thousand * * sixty dollars, and on July 1, * * 1930, * * eighteen thousand * * sixty dollars for property repairs and maintenance.
- (c) On July 1, * * 1929, * * six thousand * * two hundred thirty-three dollars, and on July 1, 1930, * * six thousand * * two hundred thirty-three dollars for permanent property and improvements.
- (d) On May 15, 1929, seventy-five thousand dollars for furniture and furnishings for the three new inmate buildings.
- (e) On July 1, 1921, • seven thousand dollars for the construction of a house to be occupied by the steward.
- (8) WISCONSIN STATE SANATORIUM. For the Wisconsin state sanatorium:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, one hundred * * eighty-four thousand * * eight hundred * ninety-two dollars for operation.
- (b) On July 1, * * 1929, * * eighteen thousand * * nine hundred * * sixty-six dollars, and on July 1, * * 1930, * * eighteen thousand * * nine hundred * * sixty-six dollars for property repairs and maintenance.

- (c) On July 1, * * 1929, * * three thousand * * three hundred * * four dollars, and on July 1, * * 1930, * * three thousand * * three hundred * * four dollars for permanent property and improvements.
- (e) On July 1, 1917, eight thousand dollars for the construction of a laundry.
- (9) LAKE TOMAHAWK STATE * * * CAMP. For the Lake Tomahawk * * * state camp:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * * 1929, * * * thirtynine thousand * * * one hundred dollars for operation.
- (b) On July 1, * * * 1929, * * five thousand three hundred * * thirty-six dollars, and on July 1, * * 1930, * * five thousand three hundred * * thirty-six dollars for property repairs and maintenance.
- (c) On * * July 1, * * 1929, * * three thousand * * six hundred dollars, and on July 1, * * 1930, * * three thousand * * six hundred dollars for permanent property and improvements.
- (d) On July 1, 1917, * * * two thousand five hundred dollars, for a workshop and storehouse, and on July 1, 1922, thirty-five hundred dollars for the completion of the workshop and storehouse.

(10) STATE PRISON. For the state prison:

- (a) Annually, an amount sufficient to cover the cost of insurance, and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, two hundred * * fifty-one thousand seven hundred seventy-five dollars for operation.
- (b) On July 1, * * * 1929, * * * twenty-five thousand * * * two hundred * * * forty dollars, and on July 1, * * 1930, * * * twenty-five thousand

- * * * two hundred * * * forty dollars for property repairs and maintenance.
- thousand * * fifty dollars, and on July 1, * * 1930, * * ten thousand * * fifty dollars for permanent property and improvements.
- * * (d) On * * July 1, 1920, one thousand dollars for tiling and fencing * * *.
- (e) On July 1, 1923, * * three thousand nine hundred dollars for silo and poultry house on Chester farm and poultry house on Warber farm * * *.
- (j) On July 1, 1927, ten thousand dollars and on July 1, 1928, ten thousand dollars for the construction and equipment of buildings on the north farm.
- * * (10ab) BINDER TWINE PLANT. For the binder twine plant at the state prison, from time to time, sums equal in amount to the moneys derived from the sale of the manufactured products of said plant and paid into the general fund, to be used as a revolving appropriation for operation, purchase of raw materials, carrying, handling and marketing the products of said plant; but whenever said revolving appropriation exceeds six hundred thousand dollars such excess shall revert to the general fund. The sum of two hundred eight thousand seven hundred sixteen dollars seventy-eight cents, heretofore reverted to the general fund, is reappropriated therefrom, and added to this appropriation.
- * * (10ac) PRISON INDUSTRIES. For prison industries as provided in section 56.01 of the statutes:
- (a) On July 1, 1919, fifteen thousand dollars, and from time to time, sums equal in amount to the moneys derived from the sale of products of the industries of the state prison other than the binder twine plant, • and paid into the general fund, to be used as a revolving appropriation to carry on such industries at the state prison.
- (b) On July 1, 1917, two-fifths of the unexpended balance of the appropriation heretofore made by subsection • (10ac) of section 20.17 of the statutes, and, from time to time, sums equal in amount to the moneys derived from the sale of the products of the industries at the state reformatory, and paid into the general fund, to be used as a revolving appropriation to carry on such industries at the state reformatory.

. . .

- (11) STATE REFORMATORY. For the state reformatory:
- (a) Annually, an amount sufficient to cover the cost of insurance, and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, one hundred * * ninety-three thousand * * two hundred * * sixteen dollars for operation.
- (b) On July 1, * * 1929, * * twenty-eight thousand * * five hundred * * eighty-nine dollars, and on July 1, * * 1930, * * twenty-eight thousand * * five hundred * * eighty-nine dollars for property repairs and maintenance.
- (c) On July 1, * * 1929, * * eight thousand * * four hundred four dollars, and on July 1, * * 1930, * * eight thousand * * four hundred four dollars for permanent property and improvements.
- (h) On July 1, 1921, fifteen hundred dollars for tiling and landscaping; • and eighty-seven hundred dollars for yard lighting and the renewal of the lighting system.
- (12) INDUSTRIAL HOME FOR WOMEN. For the Wisconsin industrial home for women:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, forty- * seven thousand * * seventeen dollars for operation.
- (b) On July 1, * * 1929, * * eight thousand * * ninety-six dollars, and on July 1, * * 1930, * eight thousand * * ninety-six dollars for property repairs and maintenance.
- (c) On * * July 1, * * 1929, four thousand * * four hundred * * forty-eight dollars, and on July 1, * * 1930, four thousand * * four hundred * * forty-eight dollars for permanent property and improvements.
- (d) On July 1, 1923, * * one thousand dollars for roads and walks; * * and four thousand dollars for a farmhouse.

- (13) INDUSTRIAL SCHOOL FOR BOYS. For the industrial school for boys:
- (a) Annually, an amount sufficient to cover the cost of insurance, and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, one hundred * * forty-eight thousand * * five hundred * * forty-six dollars for operation.
- (b) On July 1, * * * 1929, * * twenty-one thousand four hundred fifty-four dollars, and on July 1, * * * 1930, * * * twenty-one thousand four hundred fifty-four dollars for property repairs and maintenance.
- (c) On July 1, * * 1929, * * four thousand * * nine hundred * * eighty-eight dollars, and on July 1, * * 1930, * * four thousand * * nine hundred * * eighty-eight dollars for permanent property and improvements.
- (e) On July 1, 1921, ten thousand eight hundred dollars for the purchase and installation of a water softening plant;

 and on July 1, 1922,

 fifty-five hundred dollars for remodeling the old laundry building; and twelve thousand dollars for the construction of a new laundry building.
- (14) WISCONSIN INDUSTRIAL SCHOOL FOR GIRLS. For the Wisconsin industrial school for girls:
- (a) Annually, an amount sufficient to cover the cost of insurance, and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, * * ninety-eight thousand five hundred * * twenty-nine dollars for operation.
- (b) On July 1, * * 1929, * * six thousand one hundred * * thirty-six dollars, and on July 1, * * 1930, * * six thousand one hundred * * thirty-six dollars for property repairs and maintenance.
- (c) On July 1, * * * 1929, * * * six thousand four hundred thirteen dollars, and on July 1, * * * 1930, six thousand four hundred thirteen dollars for permanent property and improvements.

(e) The benevolent fund, amounting to the principal sum of thirteen thousand five hundred dollars, transferred to the state by chapter 636 laws of 1917, constitutes a separate trust fund and shall be conserved and applied as follows:

First: The principal of said trust fund shall be held by the state treasurer, and be invested and reinvested as provided in chapter 25 of the statutes.

Second: The income of said trust fund shall be used and expended exclusively for the benefit of girls committed to the Wisconsin industrial school for girls, or such other institutions as the state may hereafter establish and maintain for the care, custody and education of girls of the classes now or hereafter authorized by law to be committed to said institution, in providing healthful and instructive recreation and amusements, furnishing advance educational facilities for such of them as show special fitness therefor, providing needed medical or surgical care in exceptional cases, and other similar purposes; but no part of said income shall be used for defraying any of the ordinary expenses of any such institution.

Third: Said income shall be disbursed from the state treasury only upon warrants issued on certifications by the state board of control upon the recommendation of the superintendent or other managing officer of such industrial school or other institution.

- . . .
- (h) On February 1, 1928, two hundred thousand dollars and on July 1, 1928, two hundred thousand dollars to purchase a site for and to construct and equip the necessary buildings for the Wisconsin industrial school for girls at a new location to be selected by the state board of control, subject to the approval of the governor.
- (i) On March 1, 1929, ten thousand dollars to be used as a revolving appropriation for operation, maintenance, and permanent property and improvements of the farm on the site purchased for the new industrial school for girls.
- (15) STATE PUBLIC SCHOOL. For the state public school:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and

. .

- annually, beginning July 1, * * 1929, one hundred * * eighty-five thousand * * six hundred * * seventy-one dollars, for operation.
- (b) On July 1, * * 1929, * * eleven thousand * * seven hundred * * ninety-nine dollars, and on July 1, * * 1930, * * eleven thousand * * seven hundred * * ninety-nine dollars, for property repairs and maintenance.
- (c) On July 1, * * 1929, * * five thousand * * nine hundred * * forty-four dollars, and on July 1, * * 1930, * * five thousand * * nine hundred * * forty-four dollars for permanent property and improvements.
- (d) * * Annually, beginning July 1, * * 1929, twenty- * * four thousand * * four hundred dollars * * for hospital care, medical appliances, and the operation of cottages for crippled children. * *
- (e) On May 15, 1929, ninety thousand dollars for the construction and equipment of a heating and power plant.
- * * (16) SCHOOL FOR THE DEAF. For the school for deaf:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, * * one hundred ten thousand * * six dollars for operation.
- (b) On July 1, * * 1929, * * eighteen thousand * * two hundred * * ninety dollars, and on July 1, * * 1930, * * eighteen thousand * * two hundred * * ninety dollars for property repairs and maintenance.
- (c) On July 1, * * 1929, * * two thousand * * three hundred * * seventy dollars, and on July 1, * * 1930, * * two thousand * * three hundred * * seventy dollars for permanent property and improvements.
- (17) SCHOOL FOR THE BLIND. For the school for the blind:
 - (a) Annually, an amount sufficient to cover the cost of insur-

ance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning July 1, * * 1929, ninety- * * seven thousand two hundred * * seventy-seven dollars for operation.

- (b) On July 1, * * 1929, * * fourteen thousand * * three hundred * * eighty dollars, and on July 1, * * 1930, * * fourteen thousand * * three hundred * * eighty dollars for property repairs and maintenance.
- (c) On * * July 1, * * 1929, * * seven thousand * * one hundred twenty-five dollars, and on July 1, * * 1930, * * seven thousand * * one hundred twenty-five dollars for permanent property and improvements.
- (d) Annually, beginning July 1, * * 1929, * * five thousand * * * dollars, for maintaining the summer school in connection with the school for the blind.
- (e) Annually, beginning July 1, 1923, three thousand dollars, or so much thereof as may be necessary, to carry out the provisions of section 47.07.
- * * (f) Annually, beginning July 1, * * 1929, * * twenty thousand dollars to carry out the provisions of section 47.12 of the statutes.
- * * * (18) INSTITUTE FOR BLIND ARTISANS. For the Institute for blind artisans:
- (a) Annually, an amount sufficient to cover the cost of insurance and coal and other solid fuel purchased pursuant to subsection (14) of section 34.02, and freight charges thereon, and annually, beginning * * July 1, * * 1929, * * eighteen thousand * * nine hundred dollars * * for operation. * *
- (b) On July 1, * * * 1929, * * * two thousand * * twenty-five dollars, and on July 1, * * * 1930, * * * two thousand * * twenty-five dollars for permanent property and improvements, except the purchase of land.
- (c) On July 1, 1925, ten thousand dollars, together with any materials then in stock, pursuant to the provisions of this subsection, to be invested in materials, payment of artisans, and for

expenses incident to manufacture of different articles; and whenever any such materials, or the articles manufactured therefrom, are sold, the proceeds thereof shall be paid into the general fund within one week of receipt, and credited back to this appropriation.

- • (21) LIVE STOCK. All moneys received by the board of control from the sale of live stock and farm products shall be paid within one week of receipt into the general fund and are appropriated to the board of control to be used as a revolving appropriation for operation, maintenance, and permanent property and improvements of the institutional farm from which the receipts were received.
- * * (22) OCCUPATIONAL THERAPY. On July 1, 1919, five thousand dollars to carry out the provisions of subsection (10) of section 46.03. Of this there is allotted:
- (a) Not to exceed two thousand five hundred dollars for salary and expenses of an instructor.
- (b) Two thousand five hundred dollars to be used as a revolving appropriation for the purchase of the necessary materials and supplies.
- • (23) NEW BUILDINGS. All appropriations made by law to the board of control for the construction of new buildings, shall be expended in accordance with the following conditions:
- (a) Construction shall, unless otherwise directed by law, be in order of the greatest need therefor as determined by the board of control.
- (b) No plan or plans shall be finally adopted, and no contract or contracts shall be entered into by the board of control for the construction of any building until such plans and contracts, with complete estimates of the total cost thereof, shall have been submitted to, and in writing approved by the governor, who shall withhold such approval until he shall satisfy himself by a personal examination or by such other means as he may in his discretion adopt, that such building is required for the purpose proposed, and that it can and will be erected and fully completed according to such plans or contracts for the sum proposed for the same by the board of control out of the appropriation made for such purposes.
- (24) PERMANENT PROPERTY AND IMPROVE-MENTS. On * * * July 1, 1926, two hundred eleven

thousand one hundred dollars * * for the construction, remodeling and equipment of buildings, for the purchase of furniture and furnishings, and for permanent property and improvements to be allotted as follows:

- (c) * * * Forty thousand dollars for farm colony buildings * * * at the northern Wisconsin colony and training school.
- (d) Three hundred thousand dollars for inmate buildings; ten thousand dollars for land improvements; • and two thousand five hundred dollars for a telephone system at the southern Wisconsin colony and training school.
- (h) Fifteen thousand dollars for guard fencing • at the Wisconsin industrial home for women.
- (24a) BUILDINGS AND EQUIPMENT. On July 1, 1925, thirty-three thousand one hundred fifty dollars for the construction, remodeling, and equipment of buildings, and for permanent property and improvements to be allotted as follows:
- (g) One thousand five hundred dollars for fencing and land clearing * * for the northern colony and training school.
- (h) * * Three thousand two hundred dollars for farm drainage and fencing * * for the southern colony and training school.
- (j) Two thousand dollars for clearing land and developing Oneida farm * * at the state reformatory.
 - (1) One thousand dollars for live stock at the state prison.
- (25) DEPENDENT CHILDREN. Annually, on January first, not to exceed thirty thousand dollars for state aid according to the provisions of sections 48.33 and 48.331 of the statutes.
- (26) COUNTY INSTITUTIONS. For state aid and maintenance of inmates in county institutions:
- (a) From time to time such sums as may be necessary, to be credited and charged on taxes, as provided in sections 46.10, 50.07, 51.08, 51.12, 51.26, 51.27, and 51.28 of the statutes.
- (b) Annually, beginning July 1, 1913, such sums as may be necessary, for any compensation to the trustees of any hospital

for mental diseases in any county having a population of two hundred fifty thousand chargeable against the state as provided in subsection (2) of section 51.23 and section 51.24 of the statutes.

. . .

- (28) BLIND AND DEAF AID. For state aid to the blind and to the blind and deaf, annually, beginning July 1, 1923, not to exceed fifty thousand dollars, according to the provisions of section 47.08 of the statutes.
- * (29) OLD-AGE PENSIONS, STATE AID. For state aid for old-age pensions, * on January 1, 1930, not to exceed • thirty-five thousand dollars, and annually, beginning January 1, 1931, forty-five thousand dollars, according to the provisions of section 49.37.

. . .

- (30) COMPENSATION FOR IMPRISONMENT OF INNO-CENT PERSONS. For compensation to prisoners who have served terms of imprisonment upon conviction for an offense or crime against the state of which they are innocent, as provided in section 285.05, such sums as may be necessary to pay the awards of the board created by said section, when certified to the secretary of the state by said board.
- * * (31) WITNESS FEES OF PRISONERS. All moneys received in reimbursement of expenses incurred in taking inmates of state institutions into court pursuant to section 292.45 shall be paid within one week after receipt into the general fund and are appropriated therefrom to the institution incurring such expense and are added to the appropriation for operation of such institution.
- (33) USE OF SURPLUS APPROPRIATIONS. * * Any amounts appropriated for construction, land, equipment or permanent property and improvements at an institution under section 20.17 of the statutes, not needed for the original purpose, may, with the consent of the governor, be added to any one or more of the other specific capital appropriations at the same institution, provided that the provisions of this subsection shall only be applicable to appropriations made for specific capital purposes.

45.278 REHABILITATION FUNDS TO BOARD OF CONTROL. Any moneys in the soldiers' rehabilitation fund which, in the opinion of the board in charge of this fund, will not be

needed for carrying out the provision of sections 45.27, 45.271, 45.275 and 45.276 may be transferred to the state board of control for the purpose of augmenting the facilities for the care of patients at the Wisconsin memorial hospital. Whenever such moneys are transferred to the state board of control, the same shall be credited to the appropriation made by paragraph (c) of subsection (5) of section 20.17.

(46.03) (10) The state board of control may give such instruction in occupational therapy or vocational training at such institutions under its control as it shall deem wise; such instruction shall consist of vocational advice and technical training necessary for the proper qualifications of the inmates of such institutions for present and future usefulness.

(46.05) (2) The salaries of the officers of said institutions, if not otherwise fixed by law, shall be fixed by the board of control * * *. The steward of each institution shall execute and file an official bond in such sum and with such sureties as said board may prescribe. Said board shall also require any other officer or other person having the possession or custody of any money or property belonging to the state or any institution under its control or supervision to give an official bond, and from time to time to renew the same.

(47.08) (9) On the first day of January, in each year, the county treasurer of each county shall certify under oath, in duplicate, to the secretary of state and to the state board of control, the amount paid out by each county under the provisions of this section, and if the board of control shall approve the same and shall cause its approval to be endorsed by the president and secretary of said board on the certificate received by the secretary of state, the secretary of state shall credit such county with one-third of the amount so certified on the state taxes next due therefrom, and the state treasurer shall credit such county with said one-third of such amount in his annual settlement with said county for taxes due the state. If the total amount due all counties shall exceed the sum appropriated by . . . (28) of section 20.17, the same shall be prorated among the various counties.

(48.33) (10) On the first day of January of each year the county treasurer shall certify under oath, in duplicate, to the secretary of state and the state board of control the amount paid out by such county during the preceding year for aid

under this section and section 48.331, and if the board of control shall approve the same and shall cause its approval to be indorsed by the president and secretary of said board on the certificate received by the secretary of state, the secretary of state shall credit one-third of the amount so certified to be due such county on the state taxes next due therefrom, and the state treasurer shall credit such county with said one-third of such amount in his annual setttlement with said county for taxes due the state; provided, that the amount paid by the state to any county in any one year shall not exceed a sum equal to one dollar for each thirty inhabitants thereof; provided, further, that if the total amount paid by all the counties under this section and section 48.331 as certified by the county treasurers shall exceed the sum appropriated by subsection • • • of section 20.17, the secretary of state and the state treasurer shall prorate the said sum among the various counties according to the amount paid out.

(49.37) (3) On the first day of January of each year the county treasurer shall certify under oath, in duplicate, to the secretary of state and the state board of control, the amount paid out by such county during the preceding year for old-age pensions, and if the board of control shall approve the same and shall cause its approval to be indorsed by the president and secretary of said board on the certificate received by the secretary of state, the secretary of state shall credit one-third of the amount so certified to be due such county on the state taxes next due therefrom, and the state treasurer shall credit such county with said one-third of such amount in his annual settlement with said county for taxes due the state; provided, that if the total amount payable to all the counties under this section, as certified by the county treasurers, shall exceed the sum appropriated by subsection • • • (29) of section 20.17. the secretary of state and the state treasurer shall prorate the said sum among the various counties according to the amount paid out.

SECTION 2. This act shall take effect upon passage and publication.
